Lockdown may be over, but virus still around: PM Modi

Prime Minister Narendra Modi on Tuesday warned the people against letting their guard down in the fight against Covid-19 in the festive season, saying the lockdown might have ended but the virus was still around. Addressing the nation, PM Modi also said the government was preparing to make Covid-19 vaccines accessible to all Indians as soon as it was available.

"In this festive season, markets are bright again but we must keep in mind that lockdown may have ended but the virus is still there. With the efforts of every Indian over the last 7-8 months, India is in a stable situation we must not let it deteriorate. Of late we have seen videos that show many people have stopped taking precautions; this is not right," PM Modi said.

In his nearly 13-minute



speech, PM Modi also touched upon the Covid-19 situation in the country, saying the fatality rate of India was much lower than countries like the US, Brazil, Spain, and Britain. "The fatality rate in India is 83 out of every 10 Lakh population in India, whereas it is more than 600 in countries like the US, Brazil, Spain, Britain," he said

He also said the recovery

rate in the country was good while stressing that this was not the time to be careless or to believe that Covid-19 had ended.

"5,500 people out of every 10 lakh population in India are infected, whereas in countries like the US and Brazil this figure is around 25,000. We will soon cross the 10-crore test mark. Increased testing has been a big strength in our fight against Covid-19," the

prime minister said.

The number of new coronavirus infections in India dropped below 50,000 for the first time in nearly three months, taking the Covid-19 caseload to 75,97,063. A total of 46,790 fresh infections were reported, while the death toll climbed to 1,15,197 with 587 fatalities. The number of people who have recuperated from the disease has crossed 67

lakh, pushing the national recovery rate to 88.63 percent, the Union Health Ministry said.

On the vaccine front, PM Modi said, "All countries are working on a warfooting for making Covid-19 vaccine. The government is making all efforts to ensure that vaccine, whenever it is launched, reaches every Indian."

According the three government. vaccines are in advanced stages of development in India, of which two are in Phase II and one is in Phase III. The government had previously estimated that it is likely to receive and utilize 400-500 million doses of Covid vaccine and that as many as 25 crore individuals could be vaccinated by July 2021.

Last week, PM Modi said to ensure speedy access

to the Covid-19 vaccine, the delivery system could learn from the successful conduct of elections and disaster management. Chairing a meeting to review the Covid-19 pandemic and preparedness of vaccine delivery, PM Modi is also learned to underlined the use of a strong IT backbone for vaccine administration. "The Prime Minister stressed that every step in the logistics, delivery, administration should be put in place rigorously. It must include advanced planning of cold storage chains, distribution network, monitoring mechanism, advance assessment, preparation of ancillary equipment required,

such as vials, syringes,"

Education nobody's baby

Collapsing private educationmay cost Rs 1.75 lakh crore a year

India's private school education is collapsing. Thousands of schools have closed down, many others are gasping and it may cost the nation over Rs 1.75 lakh crore a year. The lockdown has harmed the education sector immensely. Private education conjures up an image of spunky public schools with their high fee structure. These also are in crisis. Worse are the virtual budget schools, charging a fee of Rs 1,000 or less penetrating the rural, small-town, or lowincome areas of metros, according to the State of the Sector Report on Private Schools by Central Square Foundation (CSF).

There are about 15 lakh schools, with 26 crore students, according to World Education News

the recently released Household Consumption Education in India Report, the aggregate household expenses are on private schools, about Rs 1.75 lakh crore, almost equal to the e-commerce

Though almost all are under stress due to lockdown the worst sufferers are virtual informal schools with government recognition or not but serving the hinterlands of the country. It has improved enrolment school especially in rural areas, where the number of students attending private schools has increased from 4 percent in 1993 to 26.6 percent in 2017-18.

The CSF report says the struggle is intense for the survival of private education. In normal and Reviews (WENR). In circumstances, it is not easy for private schools to attract students and during covid19 times it has worsened as parents refuse to pay fees. Weak and digital footprint has online unaffordable.

So most such schools have either closed down or facing closure as they are neither able to pay their teachers nor afford infrastructure costs. Some had planned expansion in early March and taken loans. Many have gone into severe debt and even after closures are in distress. Most of these are entrepreneurial ventures innovative individuals. In Fatehpur. UP, a shopkeeper's son started a school at Re 1a-day pay concept. Since the students are not coming to school, entrepreneurs like him have little option but to down operations.

The impact on society is severe. These employ mostly jobless youth at low salaries or payment on a daily wage basis or as in Chennai on an hourly-payment system. But each school sustains at least 100 persons on average. The youth prefer to opt for such jobs for sustenance as well as the prestige they enjoy in neighborhood.

In villages or semi-urban areas such schools have become the choice for parents, as they are perceived to be better government than schools, may not be in pedagogy but overall care that a child is given. Teachers trained or not, since from neighborhood, considered de[emdable. This is making education more mass-based as the official system has many limitations and despite some recent efforts suffers from delivery problems. Recruitment of teachers itself is flawed as the disclosures from VYAPAM in Madhya Pradesh or recent disclosures by the UP government has shown. The UP government also found that the district officials interfere in Basic Shiksha schools and issued orders for severing these from the district administration. The orders stated that no district official should intervene in any such schools.

But online education has come up largely as cropper in all such schools. The pandemic has given a sudden rise to the need of having a digital infrastructure and due to their low budgets, the unaided private schools claim that they are neither able to match up with elite schools nor with the state-run schools for which the content is aired through televisions, radio, and other government-run platforms.

Parents do not consider it to be an education. They do not pay the schools because their wards are not going there. Apart they find online - mostly mobile phones - teaching expensive for the high internet costs. Another problem they face is that

each child should have a smartphone, which they cannot afford.

Many children too do not find online interesting as it interrupts too often teachers themselves limited for lack of eye contact. Students mostly put off video because of the poor network across the country as also to reduce unaffordable data use. Digital, which the telecom companies are trying to promote for a revenue model, is collapsing the education system. At kindergarten and primary level, it is burdening the parents, mostly mothers, as they have to remain present continuously during online classes that in many cases have become the norm in metro cities. The parents complain that children do not consider "laptop teaching" like education and pester them to allow them to go to schools. Another aspect that has not been taken into

account that home education has become cumbersome, expensive. uninteresting as in many families a child at home is a resource for family work or business. The pandemic panic is mostly being taken as a holiday and the society is complaining of apathy of the schools.

The students and their parents find being physically at school more affordable and at least fruitful because apart from the books they learn etiquette, interaction with peer groups, use of the library, and social behavior, even if they quarrel or fight there.

So the society despite the low incomes does not mind paying education and that is heavy. As per the MoSPI report, Indians are paying 12 times the money for pre-primary education at a private school. The number decreases to about three times at the higher secondary level. The majority, 70.8 percent of students pay less than Rs 1000 monthly fee, while 45.5 percent pay less than Rs 500. The monthly median fee in an elementary unaided school is Rs 958 in urban areas and Rs 500 in rural India. Schools complain that at least one-third of the parents default in paying that also.

The New Education Policy has also ignored the basic aspect of survival of private education, elementary to higher. The idea that greedy capitalists use it to shore up their bottom line is impractical. They have to survive on low fees and also pamper the policemen, government officials, panchayat pradhans, and sundry others. Many in the business even in the national capital are keen on exiting.

The shutdown of private schools can adversely impact 'education for all' multiply unemployment. With apathy, low government allocation highhandedness education is becoming nobody's baby. 💬

Built with indigenous knowhow these coolers do not require any power source to function and can keep around 100 kg of vegetables fresh for 7 days.

Sabji Cooler is a metal chamber developed by Mumbai-based Rukart Technologies which uses over 1,600 plastic balls to enable cooling. 'DeshPremi', a local producers group takes care of the installation and maintenance. The farmer only needs to construct a brick and cement chamber to house the cooler. This small chamber acts as cold storage. The project is funded by the District Periphery Development Fund.

Collector accentuates strict adherence of model code and conducts during the by-poll



JAGATSINGHPUR, Oct 18:The by-poll for the Tirtol assembly constituency scheduled to be held on 3 November, model code and conduct have been enforced with immediate effect, consequently, contesting candidates, political parties, media, election stakeholders, and polling parties have been instructed to follow the ECI guidelines with letter and spirit, said district collector cum election officer Saroj Kumar Mishra.

Collector Mishra reveals

that filing of nominations, scrutiny, and withdrawal of candidature process has been completed. 9 candidates from several political parties and independents remained in the fraythe polls scheduled to be held on November 3 and results would be declared on November 10. Under model code of conduct, while political parties can only criticize the other candidates based on policies and programs and their work records, they are not allowed to use caste,

religion, and communal remarks to lure voters, carrying or burning effigies the opponent candidates are disallowed. Political leaders cannot bribe or intimidate voters and most importantly they cannot criticize them based on unverified reports, the collector said.

On polling day all party supporters who are working for their parties in the polling booth must wear a badge with party name and symbol as well as obey mandated Covid 19 rules wearing a mask and maintaining social distancing strictly, collector revealed.

It is mandatory for the contesting candidates and political parties to inform the local police about their rallies and public meetings, to be organized under Covid 19 guidelines comprising 100 attendances administration selected venues in different blocks. 16 meeting grounds have been selected in different locations in poll-bound Tirtol areas where the public meeting would be

organized.

Informing Covid safe election collector Mishra informed that all contesting candidates and political parties have been given Covid 19 guidelines for adherence, polling parties would be given gloves, face mask and shield as well as Personal Protective [PP] kits during pre and post-poll arrangements, all polling booths would be properly sanitized before go to polling, Covid 19 affected voters would cast votes later on before onehour ending of polling.

About 15253 people have been identified as special categories voters in Tirtol assembly segment included as PWD 9796, a person with age above 80 years old 5117 and Covid positive 340, from the 3681 persons have opted using postal ballot for the poll. Apart from voters only those, government officials, individuals with permission from the ECI will be allowed to enter polling booths, political parties must not campaign for votes within a distance of 100 meters of the polling booth on the day of the election. No MP, MLA, and minister should combine their official visit with election campaigning and party works, collector warned while briefing model code and conduct.

Apart from elaborate arrangements have been made for electrification and supply of drinking water in each polling booths have given priority, collector assured.

Though she was waiting to get a house either by Biju PuccaGhar Yojana or Pradhan MantriAwasYojana nothing could availedfor long due to apathy of Ward Member, Sarpanch, and local administration. She said for 15 years of her marriage, her husband used to meet Ward Member, Sarpanch, and Block Development Officer pleading for a house.But, until now all she got was only assurances. "I spent Rs.2000 to Rs.3000 every year before the rainy season to repair the roof of

the house. Due to the pandemic this year, I cannot repair the house. The house may collapse any movement as the recent flood has wrecked the house. Basanti complains that the houses under the scheme are given to such people who have politically involved and support the BJD ruling government.

Bleakness Ranjan Bodhei (40) also a flood victim of the same village said he has not built a concrete house and is spending his family for years in a riskyto-live house. Despite all his efforts, he is still waiting for a house under the scheme. Kumar Jena has been assuring to sent his application for a house to BDO for the last two years, but his application is yet to reach block office. village in 1997 and educated them about the significant role of mangrove vegetation in coastal pockets during the catastrophe and provided mangrove saplings to make the area greenery with mangrove cover. SamalMajumdar, the village Head Kandarapatia village.



Civil society must play a role in governance

A successful democracy does not necessarily involve successful governance. The fight against poverty is far from over. We must rediscover the virtue of self-scrutiny, and we need to prevent wastage of our precious resources. In light of these observations, we need to scrutinize whether the Indian democratic experiment of the last seven decades has been ideal and successful.

Ours is an electoral democracy like others across the globe. Some are successful, others are a failure. We need to evolve electoral democracy into a participatory democracy where the voice of civil society, including the media, is heard and respected.

State power according to the constitutional and legal scheme is shared at present

institutions and the unelected such as the bureaucracy, police, judiciary, AttorneyGeneral, Comptroller and Auditor General, Election commission, etc. There is no place for civil society in the decision-making process of elected and unelected institutions.

Participatory Democracy envisages legal recognition for civil society in the law-making process. It does not mean civil society members are conferred with voting rights. It only means that their voice is heard and respected in shaping the bill. It applies, particularly, to important legislations such as Lokpal and LokAyukta laws that are meant to fight corruption.

It would be equally true in respect to the stillborn Accountability law and the

defective Right to Information Act of 2005. If labor laws are to be passed or amended, workers, labor unions and management need to be involved in debates and discussions in committees making recommendations for law-making.

Civil society's representation is the need of the hour in the committees. commissions, and Boards and Tribunals (public authorities) that take decisions while implementing laws. This would include bodies that make recommendations for grant of a license or commutation of prison sentences, etc. Civil society needs to be represented in the annual assessment of public officers. Similarly, it should be represented in the Cabinet's appointments committee which approves postings of officers above the rank of Joint Secretary and public sector undertakings, and in the NitiAayog which is responsible for huge discretionary grants to states, to reduce discrimination.

Civil society must also be part of the decision-making process in appointments to the higher Judiciary. Inclusiveness in the decisionmaking process is important. In judicial administration, troubled in recent times by allegations of lack of democracy in managing the roster in the Apex Court and in the matter of granting stay orders indefinitely by High Courts, there is a need for civil society oversight. Civil society also needs to be involved in the social audit of public works under execution both for the time limit and standard of work.

We also need to eliminate certain negative features of democratic politics to make the exercise successful.

Party fund collection needs to be limited to members of the party. If 10 percent of the population is affiliated with a party, a small donation from each member will ensure the sufficiency of funds. Donations from capitalists, crony capitalists, and mafia dons must stop. Party functionaries need to be defined as public servants falling under section 21 of the Indian Penal Code for accountability in managing the fund. "Election" to party positions needs to be the norm and not an exception. Chief Ministers of States

positions needs to be the norm and not an exception. Chief Ministers of States should not be appointed using the sealed cover method devised by party high commands.Dynastic politics must end.Crime-tainted individuals should not be sent to Parliament and State Assemblies.Bribing voters, rigging polls, and defections must stop.Only pre-poll alliances must be allowed. Post-poll alliances should never be allowed as it cuckolds the voters.

To make governance more meaningful, we need a law on Accountability. It exists in neighboring Pakistan. Accountability would cover wrongful omissions, commissions, and crimes of public officials and Ministers. It is at the heart of good governance. Any government that checks

professional and organized crime, Maoists, terrorists, tax-evaders, and corruption can be considered good. The experience of the common man when he approaches a police or revenue official or a Court of Law is the benchmark for good governance.

Political parties that shelter goons to intimidate, threaten, or cause physical harm to independent thinkers, authors, journalists, and civil society activists are a threat to a functional democracy. Many a time, police will be a silent spectator or active participant in this nefarious game. Police possess the "soft power" of filing FIR or ignoring to file one, of pursuing investigations or going slow. The police also possess the "hard power" of using force including firearms that snuff out the lives and liberties of citizens. Unelected institutions like the Police, Bureaucracy, Judiciary, and Army have a large role to playin ensuring the rights and liberties of citizens. The elected polity is not the sole repository of State power.

Editors Guild expresses concern and dismay on actions against OTV

Bhubaneswar, October 17: The Editors Guild of India on Friday expressed dismay and concern over the action taken by the Odisha government against the Odisha Television Limited (OTV) and its senior journalist Ramesh Rath.

Conveying displeasure over the vindictive manner in which the government and its agencies have acted against the media, the nonpartisan association of editorial leaders in India said, "Such acts undermine the independent functioning of media organizations."

In a letter, the EGI said, "... On the same day in the

Keonjhar district of Odisha, the state police picked up a senior journalist, Ramesh Rath, employed with a regional news channel, OTV. on charges of having circulated an obscene video last year. OTV has stated that the journalist has been targeted for having done a series of reports exposing the Biju Janata Dal government in Odisha, although the state police have denied the allegations, saying that no arrest has yet been made."

"The Guild believes that such actions threaten as well as undermine the independent functioning of the media organizations. These should be withdrawn forthwith," the letter read.

Notably, Rath was picked by police on October 15 near his residence, a day after OTV telecast an expose on Chief Minister Naveen Patnaik's claims of an aerial survey of the flood-hit areas of the State, which was based on RTI revelations. Rath was entangled with an old viral video case of 2019 reported from Keonjhar

Rath was entangled with an old viral video case of 2019 reported from Keonjhar and forcibly picked up from near his residence. His two mobile phones were also seized.

Despite full cooperation from OTV and Rath into



the investigation of the case, the scribe was lifted and later released at 10

pm on the same day after writing an undertaking. Rath has been asked to appear before the Keonjhar police of October 21.

5 Cars That Failed Miserably In India In The Last 5 Years



Even while most of the carmakers now have a full understanding of what the Indian buyer wants, new products always have a probability of being a hit or a miss. However, there are also some instances of manufacturers entering a well-established space, and yet still failing to make a statement because of an incompetent product. We have compiled a list of five such cars that failed miserably in the Indian market in the last 5 years, take look -

1. Renault Captur: The Renault Captur was launched in the Indian market in 2017, at a time when the compact SUV segment was scarce and was solely dominated by the Hyundai Creta. At a time when the shift towards SUVs was on the rise, buyers wanted a bold and muscular looking SUV that did not burn a hole in their pocket. The Captur had everything to take on the Hyundai Creta, but it certainly lacked the muscular SUV looks that the latter offered. The edgy crossover design certainly did not please

2. Tata Tiago/Tigor JTP: Tata Motors entered into 50:50 JV with JayemAutomotivesPvt Ltd in March 2017 to develop special performance vehicles based on the existing Tata cars, and later, launched the hot hatch Tiago JTP and its sedan sibling, the Tigor JTP. As compared to the regular Tiago and Tigor's 1.2-litre NA petrol engine (86 PS/113 Nm), the Tigor JTP and Tiago JTP were plonked with BS4 Nexon's 1.2-litre turbocharged petrol engine that was tuned to put out 114 PS of maximum power, along with 150 Nm of peak torque. With a premium of just around Rs 1 lakh over their regular counterparts, the Tiago JTP and Tigor JTP were expected to rock the market. However, both of the cars failed to attract buvers, who were attracted to bigger yet similarly priced premium hatchbacks. Earlier this year, Tata Motors ended JV JayemAutomotives by buying the latter's stake in JT Special Vehicles (JTSV) and discontinuing the two performance-oriented

3. Maruti Suzuki Baleno RS: The Maruti Suzuki Baleno RS could not be given a miss when we're talking about affordable performance-oriented cars. Given the Baleno's

popularity, Maruti Suzuki thought that it was the perfect time to launch the Polo GT and Tata Tiago JTP rivaling Baleno RS - a performance-oriented version of the premium hatch. Over the regular Baleno, the RS version featured aesthetic changes to make it look sportier including a redesigned front and rear bumpers smokedheadlamps, and blacked alloy wheels. It got a 1.0liter Boosterjet turbo

petrol engine producing 102 PS power and 150 Nm torque, mated to a 5-speed MT. However, owing to limited success, the Baleno RS was let go in January this year.

4. Volkswagen Ameo: Volkswagen introduced the Ameo to bridge the gap between the Polo and the Vento in its portfolio, and the car served as the German automaker's most affordable sedan in the country. However, the Ameo was never able to

keep it up with its competitors like the Maruti Suzuki Dzire, Honda Amaze, Tata Tigor, and Hyundai Aura/Xcent, and the low sales volumes resulted in Volkswagen taking the sedan off the shelves.

5. Honda BR-V: Honda decided of introducing a unique, affordable 7-seat car with a different approach altogether, and ended up launching the BR-V in India in 2016. The BR-V was a 7-seater but

featured crossover styling - something that, at that time, no other manufacturer was offering at the price point of under Rs 15 lakh. The crossover MPV came equipped with the same 1.5-liter diesel and petrol powertrains as the Honda City, however, the car did not perform well in the Indian market. Hence, Honda ended up discontinuing the BR-V from the country once the BS6 emission norms came into effect.

Nagarjuna Besha: Sculptors Begin Preparations For Rare Incarnation

Puri: With just a month before the once-in-ageneration occasion of the NagarjunaBesha of Lord Jagannath, sculptors and artisans have initiated preparations for the rare rituals. NagarjunaBesha of the Lords was last held in 1994. As per tradition, it is celebrated when the Panchuka (last five days of Kartika month) is observed as six days. This year, due to an extra month after Ashwin (Adhik Maas), the special besha of the Holy Trinity will be held on November 27, the extra day (sixth day of Panchuka).

The deities will be dressed like warriors with golden attire of several weapons including arrows, bows, Hala (plough), Chakra (wheel), and Musala (mace).

Beshasilpis, the artisans in charge of designing the special costumes of the Lords will begin crafting the attire from Monday. Various types of raw materials like SantaraPatta, thermocol have already been procured for the designing exercise.

The artisan community is quite excited to see this extraordinary occasion unfold before their eyes. Many of them who will take part in the process for the first time in their life have expressed their delight.

"I am really happy to be witnessing this rarest of the rare besha of Mahaprabhu. I don't know much work because I had never taken part in this ritual before so I will fully cooperate with the senior artisans and sculptors who



have the experience," said a carpenter Basant Rana. per mythology, historians say the besha is celebrated commemorate killing Sahashrarjuna Parsuram, the warrior incarnation of Lord Vishnu. With the winter season about to make its onset and pandemic Covid restrictions still in place, devotees and culture experts are wary that the occasion will be a low key

affair without any expected congregation of lakhs of devotees from all around the world.

However, many are hopeful that the government will make necessary arrangements so that people across the globe will not miss the rare besha of the Lords.

MadhavPujapanda, member of the Shree Jagannath Temple Managing Committee said "If Covid-19 restrictions

continue to remain in place, the administration will go ahead with its plan to organize the besha without any devotees. As people may not be allowed to enter shrine, Patitapabana, representative deity of the Lord Jagannath situated in the SinghaDwara will be adorned with the special attire so that devotees can witness the outside."

Jagannath culture expert Naresh Chandra Das said that if the government can adopt alternative measures like allowing less number of devotees into the temple at a time to ensure Covid guidelines remain intact, I think people will not have to miss this chance of their lifetime. Meanwhile, with the Kartika Brata set to begin from Monday, the PuriJagannath Temple administration has finalized all ritual timings of the shrine. Due to the pandemic protocols, the pilgrim town is exhibiting a deserted look this year as there is a ban on the congregation of devotees and also entry into the temple.

Habishyalis who throng the temple in lakhs every year to mark this holy period of abstinence from worldly affairs are a dejected lot due to the restrictions over the virus infection scare.

"I would suggest government relaxes some norms to allow habishyalis place to observe their rituals around the temple if not their entry into the shrine," said MadhavMohapatra.

"Ravan is worshiped as an embodiment of 'Shakti' (power) and 'Gyan' (knowledge). Ravan was a staunch devotee of Lord Shiva and is known for his knowledge and power. "The temple here is a part of a Shiva temple complex and Ravan is worshipped as a guard of Lord Shiva. People believe that Ravan was also born on Dussherathe day he was slain," says Pandit K.K. Tiwari,

the temple priest.

Devotees at the temple claim that when Ravan was dying, Lord Ram had asked his younger brother Laxman to take blessings from the king because his knowledge was unparalleled.

Ambani succession is a chance to divide and rule



Mukesh Ambani can divide the \$200-billion Reliance Industries conglomerate and still rule if he wants to. India's and Asia's richest man has promised Silicon Valley investors that he will spin off tele communicationsto-technology unit Jio Platforms and Reliance's retailing business from his oil-to-chemicals operations. That will leave three listed entities, and the 63-year-old Ambani has three children. But keeping family interests aligned is important, too. Ambani has made no public statements about succession, but his adult children are stepping up. Akash has been announcing developments at Jio, backed by Facebook and Alphabet-owned Google, and valued at up

to \$70 billion. Twin Isha is visible at Reliance Retail, valued at \$57 billion by investors including Silver Lake and Mubadala. The youngest, Anant, has joined the management team of the industrial division that Saudi Aramco has valued at about \$75 billion.

It points to the easy separation of fiefdoms with valuations in the same ballpark. That might avoid a repeat of Ambani's Bollywood-worthy sibling feud after the death of his father, the founder of Reliance, at the age of 69 in 2002

Family management

Even if the empire is divided, there is value in family unity. Reliance is 50.4 percent owned by Ambani, his mother, wife, three kids, and related

entities. Larger business groups in emerging markets find it easier and cheaper to access credit and have more influence with regulators and lawmakers. Keeping things in the family has paid off for Reliance: the Indian company has delivered total shareholder returns three times better than the Nifty 50 over the past 15 years, Refinitiv data shows.

Reliance dismissed as speculative an August report in Mint newspaper of Ambani forming a family council, but it would be a step towards something rare: a family-owned business group that lasts multiple generations. The Agnellis, the Italian clan behind Fiat Chrysler and the Juventus football team, manage the interests of

100-plus family members through a council, though they have largely yielded management to **professionals.**

At Merck, another potential example, the founding family controls the centuries-old \$19billion German pharmaceutical and chemicals company through a board of partners that supervises the executive management. Something comparable at Reliance would be a contrast to Hong Kong's Li Ka-Shing, who in 2012 announced he would hand his companies to his eldest son and cash to the other. Ambani's ambition in business suggests he wouldn't shy away from seeking a legacy to rival the Mercks or Agnellis.

Asia's Richest Banker Explores Takeover of IndusInd Bank

Kotak Mahindra Bank Ltd., backed by Asia's richest banker, is exploring a takeover of smaller Indian rival IndusInd Bank Ltd., people with knowledge of the matter said, a move that would create the nation's eighth-largest financial firm by assets.

Mumbai: Uday Kotak, founder, and chief executive officer of Kotak Mahindra, is looking at the possibility of an all-stock acquisition, one of the people said, asking not to be identified as the discussions are private. Uday Kotak and the Hinduja family have held initial talks over the proposal in which the founders of IndusInd Bank could retain a stake in the lender after a deal, another person said.

A deal would cement Kotak Mahindra's position as one of India's leading private banks, boosting its assets by about 83%. It would also throw a lifeline to IndusInd, which has seen its market value drop 60% to \$6 billion this year after being hit by concerns over worsening



asset quality and an erosion of low-cost deposits. Kotak in 2014 acquired the local unit of ING Group NV for 150 billion rupees (\$2 billion) in the largest takeover of a lender in India.

Deliberations are at an early stage and talks could fall through, the people said.

Kotak Mahindra's spokesman declined to comment. IndusInd "completely denies the said rumor and considers it malicious, untrue and baseless," the bank's external spokesman said in an email, adding the founders "reiterate their full support to IndusInd Bank, now and always."

The U.K.-based Hinduja family began discussions for selling control of the Mumbai-based lender following a dispute between the four brothers over the future of the family's \$11.2 billion fortune, one of the people said.

India's central bank earlier this year pushed back on the Hinduja brothers' plan to raise a stake in IndusInd, people with knowledge of the matter said in June.

Shares of Kotak Mahindra have fallen about 18% this year. Its 2.7 trillion rupee market capitalization makes it India's third-largest lender by value.

IndusInd's shares have fallen 64% in the past year as investors fretted over the founders borrowing money against its shares, worsening asset quality, and erosion of low-cost deposits. The brothers have since repaid the loan backed by shares of the bank.

UP registers FIR in TRP case and hands it to CBI

New Delhi: The Central Bureau of Investigation (CBI) on Tuesday took over the alleged manipulation of Television Rating Points (TRP) after registering an FIR. The central agency took over the probe from Lucknow police on the recommendation of the Uttar Pradesh government.

A case was registered in Lucknow's Hazratganj police station on the complaint of a person named Kamal Sharma, which was transferred to the CBI.

The FIR?has been registered against unidentified people. The charges include manipulating the TRPs using forged means.

The alleged scam was brought to light by Mumbai police earlier this month which



registered a case. Republic TV is one of the four channels being investigated.

Six people have so far been arrested by the police in connection with the scam, which allegedly involves inducing homes which form the sample set whose TV viewing is monitored to ensure that certain channels get higher ratings.

The ratings are a key influencer of advertiser preferences while placing commercials.

ARG Outlier Media Pvt Ltd, which owns Republic TV, and its Editor-in-Chief Arnab Goswami moved the Bombay high court last week seeking to quash the FIR lodged by the Mumbai police against the channel in the case. The channel filed the petition in the high court on October 16, a day after the Supreme Court refused to hear a plea of one of its senior officials challenging the summons issued by the Mumbai police.

The Mumbai Crime Branch had earlier registered an FIR under various sections of the Indian Penal Code for cheating, criminal breach of trust, and criminal conspiracy against Republic TV and its senior officials, and also against two other local regional channels.

MP Courts Controversy By Suggesting People Drink 'Handia'

Dhenkanal: BJD MP from Dhenkanal, Mahesh Sahu has courted controversy after a video of him suggesting people to make handia (an indigenous alcoholic-fermented beverage) outof putrid rice went viral on social media. Sahu has reportedly made remarks while distributing rice and other materials residents at Pendarabasa village in the Palalhada area of Angul district on October 23.

According to sources, the parliamentarian distributed rice, chuda, sugar, gur, turmeric powder, and salt to the residents. About 244 elderly persons from Nijigarh, Dimiria, and Balipasi panchayats had gathered at Pendarabasa to receive the items. It was alleged that the food distribution was carried out violating Covid-19



guidelines.

Addressing the people after the distribution of the items, Sahu reportedly told the people that the rice packets were three months old stock. He further suggested the locals make the rice beer.

Reacting to the viral video, the MP admitted to having made the statement and said 'why I would hesitate to tell the truth.'

"I told the people to serve the rice to gomaata (cow) if they cannot use them or make handia out of it and drink. I advised them to drink the handia before sunrise. Because the beverage becomes alcoholic after being exposed to sun," Sahu said

The MP also admitted that the people gathered there to receive the food items had violated the social distancing norms. "They were sitting slightly close to each other and had not maintained social—distancing. But I had followed the norms," he added.

New cooks on the menu toParliament canteens

After 52 years of feeding India's lawmakers, the Indian Railways is set to exit the canteens and kitchens of Parliament complex by next month to make way for a new agency to feed Parliamentarians.

Northern Railway, which provides the catering arrangement in all food-serving facilities in Parliament House Estate-the canteens, annex, library building, various pantries - has received a communication from the Lok Sabha Secretariat, asking it to vacate the premises and hand over all equipment, such as computers, printers, furniture and the like, and recall all its staff by November 15.

Officials in Parliament and Railways confirmed the



development and said that as per the latest proposal, the Indian Tourism Development Corporation (ITDC), which runs the Ashoka Hotel, is set to take over the catering job. Food served in Parliament has been highly subsidized to keep the tariff low for the MPs, House staff, and visitors.

House staff, and visitors.
Usually, a committee of MPs oversees the catering arrangements in Parliament.
However, the committee for the current Lok Sabha has not yet been constituted. Officials said the decision has been

finalized at the level of the Secretariat administration. More than 100 Northern

Railway staff-cooks, servers, kitchen staff, and others - are posted in Parliament. During House sessions, around 75 additional personnel from Indian Railway Catering and Tourism Corporation (IRCTC) are deployed as reinforcement. The Railways had a sanctioned strength of 417 catering staff for deployment in Parliament. Usually, the committee of MPs, along with the

Parliament administration, decides the rates and items of food served in Parliament canteens of various categories. However, Northern Railway is paid whatever cost it incurs from the Ministry of Finance through Parliament. Officials said the annual revenue from Parliament catering is to the tune of Rs 15 to Rs 18 crore.

Officials maintained that the move to get an alternative to Railways for catering for MPs had been contemplated even during the UPA tenure when Meira Kumar was the Speaker. "There have often been quality issues with the railway food," a Parliament official said.

Dalai Lama and Tibet card hold key in future India-China border escalation

Special Frontier Force soldier Nyima Tenzin's funeral ceremony was the first acknowledgment of the role played by Tibetans in India's elite SFF border units

New Delhi: The myth of India's Tibet card is finally shattered with the rare recognition of a secretive Indian military unit with Tibetan soldiers called Special Frontier Force (SFF). The public display of solidarity during the Tibetan soldier's funeral ceremony, killed on the front lines of deadly clashes with China on 29 August, has virtually 'revealed' the secretive force raised by India through a lot of visibility to the event. Nyima Tenzin, a Tibetan soldier from the SSF was given a funeral with full military honors, wrapped in the Tibetan flag and the Tricolour, in Ladakh.

The ceremony was telecast across India and conveyed a solemn acknowledgment of the role ethnic Tibetans, descendants of those who sought refuge in India after China invaded and occupied Tibet in 1950, have played in India's elite SFF border units.

The event was more significant was the suggestion that India questioned China's sovereignty over Tibet, a red line for China. There was no response from the government if the publicity for the funeral was a policy shift or a signal to China that their current border standoffs at eastern Ladakh could be extended across the Himalayas, a strategic ace up the sleeve some analysts refer to as India's Tibet card.

India has been reticent about the nation's secretive SFF forces and their ethnic make-up. But the SFF is part of the RAW, India's external intelligence agency. But when it is deployed with the army, it is under the military's operational control. However, the army prefers to keep the relationship under wraps. Akin to the US Special Forces, every member is trained as a paracommando and operates undercover in conjunction with the Indian military. The US Central Intelligence Agency (CIA) helped India train Tibetan refugees to become part of a special force, the forerunner to today's SFF, after the 1962 war.

The SFF and its Tibetan fighters have a valiant fighting record for India. The SFF played a crucial role during the Bangladesh Liberation Movement that helped defeat Pakistan in 1971 and create Bangladesh. SFF fighters also contributed to the 1999 war that dislodged Pakistani forces who had occupied heights in western Ladakh's Kargil



Even though the Indian government hasn't formally acknowledged the Tibetan forces, the open support for the unit has aroused emotional appeal among the Tibetan-in-exile community who aspire to see Tibet as an independent nation.

According GonpoDhundup, President of the Tibetan Youth Congress, a body that has more than 30,000 members and is fighting for the region's freedom acknowledged "I strongly feel that the younger generation will join the SFF in larger numbers as the event has sent out a message that our contribution will be recognized."

Over 100,000 Tibetans live freely in different parts of India. Tibetans in China's Tibet Autonomous Region, however, face a high degree of state control over their lives and livelihoods, increasingly akin to the situation faced by ethnic Uighurs held in vocational camps in China's western Xinjiang province. Over the decades, Indian leaders have avoided being seen as supporting or aligning with the cause of Tibet, despite hosting the exiled Tibetan spiritual leader the Dalai Lama for over 60 years. China considers the Dalai Lama, a darling of the West and Nobel Peace Prize recipient for his nonviolent resistance to China's annexation of Tibet, as an enemy of the state. But some wonder if Tibet's peaceful resistance could begin to take a harder tack, particularly as Western powers including the US articulate new

support for Tibet's cause

in the context of a wider


new Cold War against China.

Analysts suggest that peaceful struggle could shift after the next Dalai Lama is selected, particularly as China is expected to attempt to prop up a successor chosen by it. The Dalai Lama, who has been based for decades in Dharamsala. has said any candidate handpicked by Beijing would be illegitimate. Geographically strategically, India could be key in funneling support to any new Tibetan resistance.

Tibetan disaffection has grown coincident with Chinese repression and forced Sinicization of Tibetan-Buddhism culture, according to

LobsangSangay, President of Central Tibetan Administration (CTA), who spoke recently during a webinar held on September 28. Chinese President Xi Jinping has said the stability of China depends on the stability of Tibet. As recent as 2008, China's Central Military Commission ranked Tibet as its most critical sovereign challenge, ahead of even Xinjiang and the self-governing island Taiwan, said Sangay.

It's not clear if or how India may opt to play its Tibet card, but taboos on mentioning Tibet are breaking down. Analysts suggest New Delhi could start to lend its voice to calls for Tibetan autonomy and democracy, echoing Western critics, after remaining reticent for _ years to avoid irking Beijing. Indeed, India is now signaling to China for the first time in years that playing its long-held Tibet card is at least a strategic possibility. Perhaps, the time has come for a major foreign policy change in India's position on Tibet.


France to Close Paris Mosque in Clampdown Over Teacher's Beheading

French authorities said Tuesday they would close a Paris mosque in a clampdown on radical Islam that has yielded over a dozen arrests following the beheading of a teacher who had shown his pupils cartoons of the Prophet Mohammed.

The mosque in a denselypopulated suburb northeast of Paris had published a video on its Facebook page days before Friday's gruesome murder, railing against teacher Samuel Paty's choice of Michel Blanquer said Tuesday that Paty would be posthumously bestowed France's highest order of merit, the Legion of Honour, for having been "martyred" because of his profession.

The murder was preceded by a fierce online campaign against Paty and the school, led by the father of a schoolgirl who accused the teacher of disseminating "pornography" for showing a cartoon of the prophet naked.

The school said Paty had given



material for a class discussion on freedom of expression, said a source close to the investigation.

The interior ministry said the mosque in Pantin, which has some 1,500 worshippers, would be shut on Wednesday night for six months.

Interior Minister Gerald Darmanin has vowed there would be "not a minute's respite for enemies of the Republic".

The order came after police on Monday launched a series of raids targeting Islamist networks, mainly in the Paris region. Paty, 47, was attacked on his way home from the junior high school where he taught in Conflans-Sainte-Honorine, 40 kilometers (25 miles) northwest of the capital. A photo of the teacher and a message confessing to his murder was found on the mobile phone of his killer, 18year-old Chechen AbdullakhAnzorov, who also posted images of the decapitated body on Twitter. Azarov was shot dead by

Education Minister Jean-

Muslim pupils the choice to leave the classroom.

The father who posted the video shared by the Pantin mosque is among 15 people arrested after the killing, along with a known Islamist radical and four members of Anzorov's family.

Darmanin accused the father and the radical of having issued a "fatwa" against the teacher.

On Tuesday, the head of the Pantin mosque, Mohammed Henniche, said he had shared the video not to "validate" the complaint about the cartoons, but out of fear that Muslim children were singled out in class.

Four pupils suspected of accepting payment for pointing Paty out to his killer were also taken into custody Monday.

Junior interior minister Marlene Schiappa was to meet the French bosses of social media networks Tuesday to discuss bolstering the "fight against cyber-Islamism".

Paty's killing has drawn parallels with the 2015

massacre at French satirical magazine Charlie Hebdo, where 12 people, including cartoonists, were gunned down for publishing cartoons of Mohammed.

Tens of thousands of people took part in rallies countrywide on Sunday to honor Paty and defend freedom of expression, while Muslim leaders gathered at his school Monday to offer condolences and distance their religion from the atrocity.

French President Emmanuel Macron threatened that "fear is about to change sides" in the new anti-Islamist campaign.

Paty's beheading was the second knife attack since a trial started last month over the Charlie Hebdo killings.

In the September attack, two people were wounded outside the publication's former offices.

A silent march is planned for Conflans-Sainte-Honorine on Tuesday evening in homage to Paty, while parliament will observe a minute of silence in the afternoon.

Macron will attend an official homage with Paty's family Wednesday at the Sorbonne university.

Blanquer added that schools countrywide will observe a minute's silence for Paty when pupils return after the autumn break, and a special lesson on the recent events will be taught in all classes.

Justice Minister Eric Dupond-Moretti on Tuesday denied there had been any failure on the part of intelligence services.

"This is an insidious war," he told France Inter. "There is organized terrorism that is monitored by our services, and then there is a young man of 18 who was not on the radar of the intelligence services and who committed this abominable act in the name of misguided religion."

Meanwhile, Paris prosecutors said they had opened an investigation into a French neo-Nazi website hosted abroad that republished the photo of Paty's decapitated corpse posted to Twitter by the killer.

The number of cannabis consumers was second only to those for alcohol - 15.40 crore across the two age brackets - and much higher than those who consumed other categories of drugs and substances classified under the survey, such as opioids, sedatives, inhalants, cocaine, amphetamine-type stimulants (ATS) and hallucinogens.

On June 14, one of these 3.10 crores alleged cannabis users died by suicide at his Mumbai apartment. Sushant Singh Rajput was a rising star in the Hindi film industry who was reportedly struggling with mental disorders. Rajput's sudden death triggered a political and media frenzy that began as a quest to determine why he took the extreme step. Three months later, this ostensibly noble pursuit of justice for Rajput is now an ugly charade that has painted the late actor as an incorrigible 'drug addict' who was allegedly pushed in the throes of cannabis abuse by his companion, actor Rhea Chakraborty.

The Narcotics Control Bureau (NCB), whose mandate is to investigate inter-state or international drug trafficking networks, invoked various sections of the Narcotic Drugs and Psychotropic Substances (NDPS) Act to arrest Chakraborty on September 8. As per the NCB, Chakraborty is an "active member of a drugs syndicate" and had been procuring illegal drugs (marijuana to be specific) for the late actor. So far, the NCB's case against Chakraborty seems to hinge on the discovery of "59 grams of curated marijuana" from two men, Abbas Ramzan Ali Lakhani and Karan Arora.

The brouhaha over the Rajput-Chakraborty case has brought cannabis, and the larger issue of criminalization of its production, distribution or consumption, under the NDPS Act back into focus. As the national survey of substance abuse suggests, cannabis and its derivates are the most widely consumed 'drugs' in India. Cannabis, marijuana, hemp, pot, bud, ganja, bhang - call it what you wish, but there's no denying that the venerable, yet reviled, plant is endemic to the Indian subcontinent. The use of its derivatives as medicine or recreational drugs is common among spiritual and ordinary folk alike. Chakraborty is in police custody for allegedly procuring cannabis for her former beau and for purportedly knowing two men who had 59 grams of the banned substance. A walk down the ghats or alleys of Varanasi, the Lok Sabha constituency of Prime Minister Narendra Modi, may invariably lead to an encounter with holy men who possibly smoke twice this quantity within an hour - and for several hours of the day - without the fear of being apprehended by NCB sleuths or dubbed as criminals.

For over three decades now, the five-bladed leaf has been a banned substance under the NDPS Act of 1985; clubbed in the same category as indisputably more addictive and harmful substances like opioids, amphetamine-based drugs, psychedelic, and psychotropic substances. This, even as the past decade has witnessed a reappraisal of cannabis globally with several countries legalizing its recreational use and researchers studying its potential medicinal use.

The NDPS Act criminalizes cannabis use under the classifications of charas (the separated resin of cannabis), hashish oil, ganja (the flowering or fruiting tops of the cannabis plant), or any mixture, with or without any neutral material, of these derivatives. The Act also bans the cultivation of cannabis and "manufactured drugs" made from "medicinal cannabis" (any extract or tincture of hemp).

However, the Act allows the exploitation of cannabis as bhang by excluding the categorization of cannabis leaves and seeds as narcotic substances. Bhang is typically made by grinding cannabis leaves and seeds and mixing it with milk (though the clandestine use of the plant's flowering tops - a banned substance - in making this mixture is not uncommon). It is consumed in copious quantities by revelers, particularly during Holi and Mahashivratri celebrations, and is the accepted offering for Lord Shiva. This apparent loophole in the Act has led to a paradox - the cultivation of cannabis is illegal, but consuming bhang made from it isn't. Most Indian states have government-run or sanctioned shops for the sale of bhang. Further, hemp is also used widely in Himachal Pradesh and Uttarakhand as a vegetable that is typically cooked on all special occasions, including weddings.

As insensitive as this may sound, the investigations into Rajput's death and Chakraborty's arrest have afforded India a chance to relook at its legal framework on cannabis. Gender stereotypes are as old as the hills. While men are preordained to excel at something, women stepping into that territory continue to ruffle a few feathers. It's not uncommon for women to face blatant, casual, or concealed sexism, no matter how accomplished. Female athletes are asked who their favorite male athlete is. Are women smart enough to analyze science fiction films or sports? If this is what we face today, Lucknow girl GunjanSaxena shattered the glass ceiling in the 90s when she became an IAF pilot. She did it at a time when feminism wasn't in vogue. It was only in 2016, that India saw its first-ever women fighter pilots commissioned into the Indian Air Force. Women were not inducted in the fighter stream before. Flight Lieutenants GunjanSaxena and SrividyaRajan paved

the way for others to follow. In 1999, Gunjan, the former helicopter pilot at 24, became India's first woman combat aviator to fly Cheetah helicopters in the Kargil war zone. She was tasked with medical evacuations, supply drops, and mapping enemy position duties.

Hailing from an army family, raised by a remarkable father (Pankaj Tripathi at his best), what makes Gunjan's journey unique and a film on her much deserving was, her mental conditioning. Her dreams were never defined by gender because it wasn't imbibed in her as a child. She wasn't told what she can or cannot have because she is a woman. She desired to fly a plane since her childhood and that is what she did. She never set out to make a statement or inspire people. She merely followed her dream.
