Among other leaders, Union Home Minister Amit Shah, Defence Minister Rajnath Singh, Union Minister Ravi Shankar Prasad, foreign Envoys, and Lok Sabha Speaker Om Birla also attended the ceremony.

Prime Minister Narendra Modi unveiled a plaque to mark the foundation stone laying ceremony of the new Parliament building. At 2:15 pm, Prime Minister Narendra Modi addresses the gathering on this occasion.

According to a release by the Prime Minister's Office (PMO), the new building is an intrinsic part of the vision of 'Aatmanirbhar Bharat' and will be a landmark opportunity to build peoples' Parliament for the first time after independence, one which will match the needs and aspirations of 'New India' in the 75th anniversary of independence in 2022.

"The new Parliament building will be modern, state-of-the-art and energy-efficient, with highly non-obtrusive security facilities to be built as a triangular-shaped building, adjacent to the present Parliament. Lok Sabha will be three times of the existing size and Rajya Sabha will be substantially bigger," the re-

lease said.

The interiors of the new building will showcase a rich blend of Indian culture and the diversity of our regional arts, crafts, textiles, and architecture, it said. As per the PMO, the design plan includes space for a magnificent Central Constitutional Gallery, which will be accessible to the public. It said the construction process will use resource-efficient green technology, promote environmentfriendly practices, generate employment opportunities, and contribute towards economic revitalization.



Soon cars will have flexible engines have the option to choose fuel: Nitin Gadkari



Union Transport Minister Nitin Gadkari has said that in the coming days, the vehicle owners will have the option to decide whether they would prefer their vehicles to run on petrol or ethanol. According to Nitin Gadkari, his ministry is working on the flexible engine, where customers will get the option to choose fuel.

According to Nitin Gadkari, customers will have the option of choosing 100 percent petrol or ethanol for their vehicle engines. More emphasis is needed on making ethanol from food grains. At the moment, many options are being considered.

Sugarcane juice also shows a lot of potential in ethanol. However, against the requirement of 1600 crore liters, only 450 crore liter of ethanol exists. As a result, there is a short supply of ethanol for oil companies. Now second-generation ethanol companies are setting up plants through biomass.

Benefits of ethanol

- Ethanol will be available at 50 to 55 rupees per liter. Although it will give lower mileage than petrol, still there will be considerable savings.
- Ethanol is made from sugarcane and can be made anywhere in India.

India will not have to depend on any other countries for ethanol.

- Ethanol will benefit the farmers of India the most. Ethanol is made from sugarcane and it is cultivated in many places in the country.
- While big oil companies benefit from petrol, the use of ethanol will benefit the farmers of India the most.
- The use of ethanol will save India's money and farmers will also benefit. The money coming from petrol sales goes to the accounts of big companies and Gulf countries.
- Ethanol is also friendly to the environment. Due to this, pollution in the car running is less than that of petrol.
- Ethanol is much less hot than petrol.
- Alcohol in ethanol flies quickly, due to which the engine does not heat up quickly.

Villagers build a dam by shramdan

Bolangir(Sudhir Mishra) : It is a common sight to find villagers seeking irrigation facility,to their field to produce more, even though the village is located near asource of water. The villagers of Kuhimunda,in Degeaon block, have set an example by constructing a small and makeshift check dam, by giving Shramadan. Utilizing the stored water, villagers enjoythe benefits of taking up vegetable cultivation and Ravi paddy cultivation.

Earlier, the villagers used to hire a JCB machine to dig a water resolverthat isLocally called CHHALA using sand. And water from that CHAHLA, would be lifted and supplied to vegetable cultivations. But, that would cater the need barely for one hour which is too inadequate to meet our water requirements says a villager.

On 3rd December, the villagers assembled a meeting facilitated by members of Reliance Foundation Bolangir, after a short



deliberation, villagers decided to construct the makeshift check dam through Shramadan. The next morning, all the villagers, SHG members went to KeutiJore, a dry rivulet, and packed bags with sand and put them in to makea dam in two places of the river, says Maithili Sahu, a village lady.

A big water resolver was ready to cater to the needs of the villagers. Now we can pump out the water for seven hours and we are cultivating smoothly with the availability of water s a y s , K s h i r o d r a Pradhan. This check dam would provide water to vegetable and paddy cultivation

till March.Nearby village farmers are also getting the benefit. The availability of water would further boost cultivation in around 30acreas area in the village says SambhuSahu,another villager.

The height of the check dam has been kept low as it is impossible to store the flow of water with only sandbags.

The villagers urged the district administration to take necessary steps to construct a permanent check dam here so that the 30 households of the villages would produce a huge quantity of vegetables, and rice in the season.

Reopening Of Schools remains uncertain: CM Naveen

Bhubaneswar: Hours after the School and Mass Education and the State Higher Education department in Odisha announced there is much likelihood on the reopening of schools and colleges in the State after New Year, Chief Minister Naveen Patnaik expressing displeasure raps the department for issuing speculated statements, and rapped the concerned authorities over showing lack of coordination.

Patnaik said the State government will only take appropriate decisions at the right time after reviewing the COVID situation in the state.

Earlier on Thursday, Secretary, Higher Education Department Saswat Mishra had said that the Department is hopeful that colleges across Odisha would reopen in January 2021. Similarly, School and Mass Education Minister Sameer Ranjan Dash on Thursday had said



that there is also the likelihood of reopening of schools in the State after New Year. Dash had also said that the priority will be given to classes 10 and 12 and if possible, classes might also be continued on holidays and weekends.

Meanwhile, CM Naveen also reviewed Odisha's preparedness for the Covid-19 vaccination drive and expressed pleasure that the danger of a second wave gripping the state has been avoided.

Patnaik highlighted that everyone should be cautious yet optimistic that the winter should pass in an uneventful manner as well

"The database and logistics for a swift vaccination drive are already in place. Odisha has been amongst the best states in India for COVID management. Even the NitiAyog has praised us for the same," said Naveen.

Addressing the meeting, Additional Chief Secretary of Health Department PK Mohapatra said Sero Survey will be carried out in Ganjam, Nayagarh, and Koraput by December 31 while the exercise will be completed in Cuttack and Bhubaneswar in January 2021.

Do farmers have reasons to be unhappy?

Yes, they have; Farm yields return fall, FPI, corp ingress rise and law review is a must

Farmers get low returns but as farm laws start shaping up foreign portfolio investments (FPI) zoom and so does investments in silos.

It's a queer connection. Over the years, between 2013-14 and 2017-18, as farmers' return on their produce starts reducing, the FPI starts booming, and funding for silo construction increases. Since 1967, when the APMC Act was enforced, never have farmers been in such distress.

Normally, despite not being able to sell at MSPs, they were not unhappy at the returns. The MSP decided on a floor price and provided the bargaining strength to them against the market forces. In 2013-14, the paddy price was 58 percent higher than average input and labor

costs. This margin shrank to 41 percent in 2018. The difference in maize reduced from 43 percent to 25.6 percent. Other crops like wheat, moong, jowar, bajra, arhar, groundnut, gram, rapeseed. mustard. barley, cotton soybean also were noticed to be less profitable. The returns are either falling or stagnating. Despite the rise in MSP, in the past five years, the farmer's actual income has not seen significant increase.

The farmers have reasons to be unhappy. Their yields are low asthe world average for rice per kg per hectare in 2018 is 4679, maize 5924, all pulses 964, arhar 852, soybean 2791, groundnut 1611, wheat 3425, barley 2951 and gram 965. The Indian average is rice 2638, maize 3070, all

pulses 757, arhar 757, soybean 1192, groundnut 1422, wheat 3371, barley 2693, and gram 956. The prices they get are less and as the cost is high approaching international markets is not easy.

In this backdrop, if it is linked to FPI, the trend is surprising. In June 2020, the FPI was Rs 11,736 crore. It doubles to Rs 22,866 crore in July. The three farm laws were introduced as ordinances on June 5. In August as the farm bills were introduced for passing by Parliament, the investments jump to Rs 1,30,576 crore. About half the investments surprisingly came from two tiny countries, Mauritius and Singapore. Another large investor was not Netherland.

These three countries have been at the top of foreign investors. These are destinations for round-tripping - that is the funds are routed through these countries by various investors and supposedly include domestic ones (Indians) too. The investments are reportedly made in farms, toll roads, rail corridors, airports, ports, smart cities, film cities, and similar ventures. Such investments have heavy baggage. The falling rupee-dollar parity and high Sensex are linked to these maneuverings.

The foreign funding flow has reportedly gone to two western provinces, Maharashtra and Gujarat. It is estimated that 55 percent of the funding has gone to these states and one percent to Uttar Pradesh.

The International Monetary Fund and Copenhagen University report says that 40 percent of the total foreign capital comes from unofficial sources and could have a darker side. But international money flows like that despite many recent revelations. It is just not for tax saving but there are many other reasons. Many investors prefer to keep their footprints in shrouds to avoid competition and other strategic reasons.

The recent developments about the farm bills and construction of silos, giant steel structures for storing grains for a longer duration, are also being linked. It is being said that silos in Panipat and Katihar were built by some industrialists during the past few years. The modern silos have been built in Madhya Pradesh, Tamilnadu, and Andhra Pradesh and are likely to come up in other states as well. Earlier, these warehouses were being built by Central Warehousing Corporation and Food Corporation of India (FCI) largely. As the need for storage is increasing the private sector has joined the efforts.

The change was started being noticed in 2007. A Gujarat house has been building the silos for FCI. It has built such silos at Naultha and Jondhan Kalan, and Kaithal in Haryana and Punjab's Moga. Some farmers alleged that now the farm produce would straightway purchased by the business group as they could store as much as they wanted and the FCI would have to purchase it from it for releasing requirements for the public distribution system.

The Adani group on December 9 has clarified in its Twitter handle, "The company has no role in deciding the volume of storages as well as the pricing of grain as it is only a service or infrastructure provider for the FCI".

The National Agriculture Policy since envisages that private sector participation will be promoted through contract farming and land leasing arrangements to allow accelerated technology transfer, capital inflow, and assured market for crop production, especially of oilseeds, cotton, and horticultural crops.

The farmers' apprehension corporate ingress may not be incorrect. Many large companies have entered the area. It is also estimated that since most farms are small, there is large attrition from the area as well. It is estimated that 330 farmers leave their land every week. This void is likely to be filled up by the corporate.

It is also the largest producer, consumer, and

exporter of spices and spice products. Many companies are dealing with or cultivating various corps. Many are listed on the stock exchanges. As of March 2019, 7374 companies are registered in the farm sector. There are about 2000 farmer producer organizations registered NABARD. On July 5, 2019, the Centre announced a plan to promote 10,000 new farmer producer companies over the next five years.

The government by the three new laws has sought to create a new situation. There could be convolutions. More so as the laws were passed without a detailed discussion, a relook is needed. The farmers' moves are not against reforms. The movement is apparently for the nation to chart out an informed course lest India becomes a Venezuela facing manmade disaster with currency distortions and government takeover of food distribution.

Since it is a critical issue, a detailed discussion and policy formulation is needed. For a reassuring national environment, the three laws having larger ramifications need a review with farmers, political parties, and finance and market experts. Let the nation not shy away from understanding the problem an apt solution. 💬

Advanced Sanitation Programme Launched In Sundargarh

The work carried out manually by sanitation workers will be done by using machines, delivering quality services to citizens."The program will also ensure safety and dignity to the sanitation workers. machines More and manpower will be provided to enhance the quality of service," he said.

RSP Record Highest Torpedo ladle life in India

SAIL, Rourkela Steel Plant (RSP) has registered a new national record in Torpedo ladle life. The plant scripted this record by clocking Torpedo ladle Life of 2407 heats in a single campaign surpassing the earlier best Torpedo Ladle Life of 2338 heats achieved in July 2020. Recorded in the Torpedo ladle #8, this is not only highest in SAIL but also the best life achieved anywhere in India. The Torpedo ladle#8 started its campaign on 26thDecember 2017 and after handling 7,35,406tonnes of hot metal, it was ultimately putdown for unbricking on 25th November 2020. The significant achievement was made possible because of the dedicated and coordinated efforts of Refractory Engineering (Services) and Blast Furnace#5 (Operation). The endeavor ensured both tangible as well as intangible benefits in terms of enhanced Torpedo Ladle availability, better logistics, and reduced refractory consumption. The effort is one amongst many such initiatives being undertaken by the enterprising RSP collective to reduce the cost of production and further improve the techno-economic of the plant.

AAI Officials Visit RKL Air strip

Rourkela: The steel city passengers are still agog to witness the D-day of launching of air traffic from Rourkela airport. Since Rourkela was included under Regional Connectivity Scheme-UdeDeshKaAamNagarik (RCS-UDAN) scheme in September 2017 the wait for air service here has turned into a mirage. Since that joyous announcement, many official delegations have visited Rourkela to implement the announcement but it is yet to see the light. In the latest developmenton 20th November ioint inspection of the Rourkela Steel Plant (RSP)-owned airport was conducted by officials from the Airports Authority of India (AAI), Odisha Government, Alliance representatives, and officials of Steel Authority of India Ltd (SAIL), RSP and Rourkela Airport. They inspected to assess the early implementation of

RCS-UDAN

The nine-member AAI team led by S. Sreekumar, Executive Director (engineering), Officers of RCS-UDAN, planning, air traffic, engineering as well as electronics and communication were part of the team. The Air Alliance team led by Captain Naveen Garg and officers of operations, flight safety and security were also part of the inspection team.

Former Union Minister and Sundargarh MP JualOram, Sundargarh Collector Nikhil PawanKalyan, Rourkela Municipal Corporation (RMC) Commissioner DibyajyotiParida, and senior officials of RSP were also present during the inspection.

The team moved around the airstrip to see the infrastructure, runway, departure and arrival lounge, parking area, air control system, 72-seater aircraft handling, passenger handling facilities, etc. The

team would submit the final finding of their assessment and then their final findings to higher authorities.

SKumar later said that inspection aimed to assess the possibility of running 72-seat aircraft. A review meeting was also held with Sundargarh Collector Nikhil Pawan Kalyan and RSP executive director (personnel and administration) Rajvir Singh.

Talking to media, Sundargarh MP JualOram informed, "An assessment was made by the officials of Airports Authority of India, DG of Civil Aviation, flight operator Alliance Air in presence of officials of District administration, SAIL to see the feasibility of operating 72-seater aircraft from Rourkela airport or not. The finding will be technically submitted to the Centre."

Responding to a query on the possibility of regular passenger flights, the MP said, "Lots of points are to be raised by the inspection team. Hence, it all depends on the time for all the things to be in place. Hence, it would be improper to tell the timeline. I assume it to be finalized soon."

It may be mentioned that the Directorate General of Civil Aviation (DGCA) on 7th January 2019, had replaced the private airport license of Steel Authority of India Ltd with a commercial license. The AAI signed an MoU with SAIL for operation and management of the airport. It was scheduled to begin the commercial flight service at Rourkela in March 2020. But it didn't happen. The Principal Secretary of Commerce and Transport department, Madhusudan Padhi on October 15 chaired a meeting on upgradation of the airport from ARC 2B to ARC-2C to allow operation of 72-seat aircraft.

A specific date of operation has not yet been confirmed.

Bike Ambulance Service Launched In Odisha's Sundargarh

Sundargarh: To extend health care facilities to the people of remote areas, the district administration launched a bike ambulance called 'SwasthyaRakshyak' on 24th November.

District collector Nikhil PavanKalyan flagged off a fleet of nine bike ambulances. Three bike ambulances were provided to Koira, Gurundia, and Rajgangpur blocks in the first phase. The facility has been launched with the funds of Odisha Mineral Bearing Areas Development Corporation (OMBADC).

On this occasion, Kalyan said," bike ambulance is a modern facility to reach remote areas which will help bring patients to the hospital in time and save their lives. The service will be extended to



other blocks in a phased manner".

The ambulance service will help increase the ratio of institutional child delivery while people living in inaccessible areas will also get timely treatment in Government hospitals. The quick response ambulance will also reduce infant and

maternal mortality rate in the district, the Collector added.

CDMO Saroj Kumar Mishra said, "Bike ambulances will play an important role in the ambulance service. We will allocate a dedicated number soon for the which will be communicated to the people through ASHA and Anganwadi workers soon.'

Sundargarh CDMO DrSaroj Kumar Mishra, A D M O DrPurnachandraSahu, SLO Dr Shakti Prasad Padhi, and DPM Deepak Kumar Mohanty were present at the inaugural program when the services were launched.

Paradip- Hyderabad pipeline project; administration resolves villager's demand



JAGATSINGHPUR: The district administration held a meeting with Dhinkia villagers over the Paradip-Hyderabad pipeline project on Saturday. District collector Saroj Kumar Mishra chaired the meeting accompanying IOCL pipeline division officials and affected villagers from Dhinkia villager under Erasama block.

Although lands have been acquired from private holders for the project trouble began occupying government and pasture land of the locality, the villagers had opposed and declined to allow go ahead of the project. Responding to the local people's resentment civil administration decided to holda talk with the unhappy villagers and resolve the crisis and invited the meeting on Saturday.

According to official sources informed that the meeting endorsed a conscious decision among the attending stakeholders

that the pipeline project would be processed as well as pipe would be stretched leaving the 200-meter length and 18-meter width in pasture land, the pipe would be stretched 6 feet deep

The farmers will provide suitable compensation affecting cultivation during project works, moreover, developmental works would be undertaken by IOCL from CSR funds in affected villages as Dhinkia, Govindapur, and

Trilochanpur under the consent of district administration, the meeting decided.

Speaking at the meeting IOCL pipeline project chief general manager BS Rao revealed that the pipeline would be of a total length of 1212 km, covering 330 km in Odisha, till date 320 km pipe stretching works have been completed, pending 10 km works are incomplete due to resistance from residents of Dhinkia Panchayat.

Vigilance raids lady section officer houses in J'spur

JAGATSINGHPUR: Basing on allegation against Sanjukta Das a lady section officer working in district Panchayat office here acquiring disproportionate property. Sleuths from the vigilance Cuttack division raided four places and found the lady officer possessing property worth Rs 1.50 Crore. According to the vigilance department, a press release informed that the woman officer was found in

possession of one triple stored building in native village Satpura, one double storied building in Panisalia village, one 3 BHK flat in Mahanadi Vihar in Cuttack, and six plots in different locations. Moreover, the woman officer has one four-wheeler, two two-wheelers, and deposit in different banks and post office, gold ornaments, cash, and household articles.

Corona warrior ASI succumbs to Covid 19

JAGATSINGHPUR: Assistant Sub Inspector of police [ASI] Sanatan Mallick hailing from Biswanathpur village under Raghunathpur block succumbed due to coronavirus infection in a private hospital in Bhubaneswar. The deceased cop was cremated in the village crematorium after paying state honor adhering to Covid 19 guidelines on Tuesday. The report said that the deceased ASI Mallick was working in Begunia police station under Nayagarh district and returned village recently, he suffered illness and admitted in district headquarters hospital for treatment four days ago where he was reported Covid 19 positive and shifted to a private hospital in Bhubaneswar for treatment but died there on Tuesday.

Six miscreantswere arrested for abducting the teacher

JAGATSINGHPUR: Acting on a tip-off Tirtol police have arrested six persons involved in teacher Rabinarayan Mishra kidnapping incident and recovered a sum of Rs 50,000, 4 mobile phones, and a TATA magic light motor vehicle under their possession. The report said that teacher Rabinarayan Mishra a resident of Eradanga under Tirtol block on 2 December was kidnapped by few miscreants while he was returning to the village at Nalibara. The alleged kidnappers have demanded a ransom of Rs 5 Lakhs from the Rabinarayan family for releasing him from their custody. Responding to kidnappers' telephonic calls victim's teacher family had paidRs 4 Lakh to kidnappers andRabinarayan was set free and reached the village safely. Soon after Rabinarayan freed the family members lodged an FIR in Tirtol police station, the police acted promptly, formed two teams conducting the probe finally picked up the alleged kidnapper's from Tirtol area. The alleged kidnappers were identified as Tapan Kumar Das, Biswajit Patra, Pratap Mohanty, and SuryakantaMohapatra, all inhabitants of Tirtol police limits. During custodial interrogation, they have confessed the crime and reported three other nameswho participated in this kidnapping bid later police arrested another two.

Miscreants set ablaze makeshift shops in Somanath Hat



JAGATSINGHPUR Unidentified miscreants set ablaze 150 makeshift shops in Somanath Hat. The report said that all the temporary sheds being made by sellers and smalltime traders at Hat have been reduced ashes. The fire brigade and local people doused the fire after six hours of struggle.Police have started an investigation. Sources informed that Somanath Hat is the oldest private market of Jagatsinghpur district

owned by a local family, the Hat runs twice a week. Usually, local farmers from Jagatsinghpur district and few adjoining villagers from Cuttack district come to this Hat to sell their agricultural produces. Meanwhile, sources said, after the Hat gets closed it becomes a hub for the antisocials, used the place consuming intoxicants. Victim traders suspect antisocials to have set fire the Hat and demanded compensation from the civil administration.

Solar power projects under AMRUT scheme fails in Baripada town



Baripada: Atal Mission for Rejuvenation and Urban Transformation (AMRUT) one of the ambitious scheme to carter drinking water crisis in urban areas and reduce power consumption sofar proves meaningless for residents in Baripada municipality of Mayurbhanj district as the Solar power units are not working properly due to alleged poor maintenance by the Public Health Engineering Department (PHED). As many as 12

solar power projects were installed in the municipality area during 2017-18 under the AMRUT scheme and the cost of the total projects was Rs.90 lakh.

The department had installed the power projects nearest to pump houses

and sumps in 12 places in the town. While two solar powers are installed in the district headquarters hospital and Madhuban, Station Bazar, Murgabadi, Daraghadehi, Lal Bazar Club, Golapbag, KC Circle, BijayRamchandrapur, and Debendrapur areas in the municipality. Most of them are not working due to the obstacles of trees.

One instance is Madhuban, where the two solar power projects are not functioning as many trees are creating shade on solar panels as a result they are producing poor energy. Most of the projects are facing similar problems as the authority

concerned does not pay any attention, consequently, the operators are forced to run submersible motors by electric energy.

The residents alleged that many of the solar power projects which are used to generate energy for the functional of submersible motors for the supply of water are not functioning. Even the water supply through the pipeline is never used for drinking purposes due to the production of dust. An operator of a pump house anonymity said his name said the sumps and tanks have not been clean for a year. No precautionary measures are taken by the department concerned. The swamp of caterpillars continued to make their nest around the water tank in Golaphag that create health hazards for the people to use water from this tank. When contacted, SitaramSethy the sub-divisional officer (SDO) Baripada PHED said despite the operational of one solar power project in Station Bazar rest eleven power projects are running in the town and the department is taking care

of sumps and tanks.

Demand to install Dialysis Machines in PRM MCH for HIV, Hepatitis and Covid-19 infected

Baripada: Former Rajya Sabha MP SarojiniHembram demanded separate Dialysis machines in Pandit Raghunath Murmu Government Medical College and Hospital (PRM MCH) for especially intensive care service to the HIV, Covid-19, and Hepatitis positive patients. She brought the attention of the Principal Secretary to Government, Department of Health and Family Welfare urged for the installation of Dialysis machines in PRM MCH as the positive infected are depriving of this facility. He also gave a letter to the Secretary on this issue on Tuesday. The patients here have been forced to go to private nursing homes and private clinics to get the service by paying money beyond their capacity as the separate Dialysis machines are not availed in PRM MCH or any other government-run hospital. At least two Dialysis machines were demanded by people to provide the intensive care facility to HIV positive and Hepatitis positive patients. Later it demanded an additional Dialysis machine for Covid-19 infected patients. The positive infected have to move to private nursing homes and private hospitals in and outside the district as such health care facility does not exist in any government-run hospital in the district. The infected patients have to pay more than Rs.12,000 per month to get the intensive care facility. Banchanidhi Das, resident of Ward No-5 under Baripada municipality, a Hepatitis positive (kidney ailing) patient has to bear Rs.12,000 per month to get intensive care from a private nursing home. "I have to pay Rs.12, 000 per month to get intensive care from a private nursing home. My family is facing hardship to arrange this amount every month. When I am battling with life for the infirmity and my family is reeling under financial crisis. The demand for the separate Dialysis Machines was brought to the attention of the government from the beginning of PRM MCH that was inaugurated by Chief Minister Naveen Patnaik on 6 September 2017. But this demand is not addressed so far. Chief District Medical Officer Rupavanoo Mishra said that as many as seven Dialysis Machines are functioning in the PRM MCH for giving intensive care facility for the patients and more than 24 to 25 patients are getting this facility per day. A private agency (Rahi Care) is providing the service with manpower of six persons but this service is not providing to Covoid-19, Hepatitis and HIV positive patients as no separate dedicated Dialysis machines have been provided in the medical college or any government run-hospital.

Lac cultivation gives hope to COVID-hit farmers, SHGs in Odisha

BARIPADA: The Integrated Tribal Development Agency (ITDA) of Karanjia subdivision in Mayurbhanj district has started an initiative to engage tribal farmers in lac cultivation in a bid to boost their income during the pandemic. A natural resin of animal origin, lac is obtained by rearing lac insects and

considered more profitable than Sabai grass or rubber cultivation. Apart from farmers, the agency has also engaged self-help groups (SHGs) and is imparting training to women in the making of lacquer crafts.

Since June, 60 SHGs and 100 farmers from B a d a b a l i p o s i, Mandalajhari, and

Chirupada under Thakurmunda block are involved in lac farming. Their first batch of harvest is due during February and March. ITDA gave each farmer and SHG 16 kg of brood lac (a stick with lac larvae) along with technical guidance and training for rearing and processing. By the end of this harvesting season, over 60 kg to 70 kg

lac harvest is expected. The project manager of Karanjia ITDA Biswanath Mishra said earlier, tribals in Keshadiha panchayat used to traditionally cultivate lac on Kusum trees. The sale was poor due to a lack of market linkage. The profits were also not much as they sold lac in raw form.

"While farmers sold raw lac at Rs 300 per kg, they can

now sell at four timesthe price after processing it. They will be growing lac twice a year as per the climate and environment suitability," he informed.

The ITDA is also training SHG members in making lac products like bangles, bracelets, and paperweights. These products will be sold with

market linkage under

Odisha Livelihood M i s s i o n , VanaDhanaVikasYojana, and producer groups under ORMAS. Steps are being taken to sell 'jou' or processed lac to the district administration for use in offices, Mishra said. Sources said plans are afoot to set up a processing unit in Keshadiha.



This is a delicate question put by Rabindranath Tagore inthe short story 'Trust property'. Brindaban is very unhappy with his father, JaganathKundu, whom he blames for the death of his wife. The two had long disagreed about how to live. Jagnath wanted a traditional life of simplicity and holiness. During the illness of Brindaban's wife, the difference arose. Brindaban wanted a costly British-style of treatment, but Jagannath wanted traditional. Jagannath asks; If costly medicines could save lives, why kings and emperors are not immortal?Brindaban takes his small son, Gokul Chandra, and leaves to live a more materialist British-style life. Jaganath doesn't miss his son at all but is lost without his young grandson, and his spirits sink. The story goes

on until eventually, a great tragedy occurs.

Perform Or Perish! Naveen Patnaik's ambitious '5T' Plan To make Odisha efficient takesoff on October 2019. Teamwork, technology, transparency, transformation, and the time limit will be the five factors on which the performance of Bureaucrats and projects will be judged. Who is the judge? Interestingly the judges are the same Bureaucrats. The elected legislatures or Ministers have been virtually nowhere in this ambitious program. Perhaps that is the reason behind the 5T program getting a flop tag. Why the elected were kept away?

Pyarimohan Mohapatra, a career bureaucrat, came into Naveen's life in 1997 soon after the Biju Janata Dal (BJD) leader landed in Odisha after the death of his father, Biju Patnaik. Having spent almost his entire life outside the state, Naveen did not know anyone when he came to Odisha.

During Biju Patnaik's tenure as chief minister between 1990 and 1995, Mohapatra worked as his principal secretary and was the eyes and ears of the legendary politician, but couldn't override him due to the strong presence of lieutenants around. With virtually no friends in Odisha, Naveen turned to his mother Gyan Patnaik, who advised him to seek the help of "Pyaribabu" to navigate the choppy waters of politics. Mohapatra paved the way Naveen's smooth ascension to the throne in 2000 when he engineered the expulsion and subsequent political checkmating of BijoyMohapatra, chairman of BJD's political affairs committee shortly before the assembly elections. Then the revenge of Mahapatra led the process of cleansing the veterans from the BJD started and the vacuum being filled by the politically naive and sycophants with allegiance to him.From early 2000, Mohapatra scripted almost all the moves of Naveen,

including advising him on the day-to-day running of the state. the new decade to make myself healthy, wealthy, and wise. Of course, it's a different matter that I put in no effort to ensure I was early to bed, or early to rise. But a new decade brings with it new possibilities, I told myself and decided that 2020 would be the best year of my life. Little did I know that the beginning of the decade brings anaubretia of viruses, locusts, and the endangered mother nature!

If 2020 was tried in court, it would find it hard to defend itself. How does one justify riots across the world, a virus that has affected nearly 7million people, the death of 1.54 million with no cure in sight, economies crashing to the ground, and natural calamities? It was a year when I had only two reasons that kept me going- uniting journalists to fight for their legitimate rights and spieling Madhuri Dixit. Allopaths object to surgery to be a part of Ayurveda

The government has notified compulsory surgical procedures for PG students of Ayurveda. How does Ayurveda deal with surgery, and why is the Indian Medical Association upset with the notification?

Pune: On November 19, a government notification listed out specific surgical procedures that a postgraduate medical student of Ayurveda must be "practically trained to acquaint with, as well as to independently perform". The notification has invited sharp criticism from the Indian Medical Association, which questioned the competence of Ayurveda practitioners to carry out these procedures, and called the notification an attempt at "mixopathy".

The IMA has planned nationwide protests on December 8 against this notification and has

threatened to withdraw all non-essential and non-Covid services on December 11.

How far is surgery part of Ayurveda?

It is not that Ayurveda practitioners are not trained in surgeries, or do not perform them. They take pride in the fact that their methods and practices trace their origins to Sushruta, an ancient Indian sage and physician, whose comprehensive medical

treatise Sushruta Samhita has, apart from descriptions of illnesses and cures, also detailed accounts of surgical procedures and instruments.

P Hemantha Kumar, professor and head of the department of general surgery at the government-run National Institute of Ayurveda in Jaipur, claims that at least 1,000 major surgeries are performed every year at his hospital. "There



would be many more minor surgeries being done," he said.

There are two branches of surgery in Ayurveda - Shalya Tantra, which refers to general surgery, and Shalakya Tantra which pertains to surgeries related to the eyes, ears, nose, throat, and teeth. All postgraduate students of Ayurveda have to study these courses, and some go on to specialize in these and become Ayurveda surgeons.

A Race To Space

In a historic decision, on June 24, 2020, the Modi government opened India's space programs for private companies. Now the private sector can participate in the entire range of spacerelated activities. The newly formed Indian Space Promotion and Authorisation Centre (IN-SPACe) will act as an arm of ISRO and help regulate and facilitate the Indian space sector. The private players will now be allowed to use ISRO's scientific and technical resources, infrastructure, and data for their programs.

India accounted for merely 3% of the global \$360 million space industry, of which only 2% is rockets and satellite launch. There was scarce participation from the private companies till now, which was primarily limited to the manufacturing and fabrication of components.

Most sectors today, ranging from transport to weather to even agriculture, need satellite data and imageries to chalk out their future business plans. ISRO would have to grow ten folds to cater to the growing demands within India effectively. This inability of ISRO to satisfy the everincreasing requirements has led to the need for private companies to share this load without compromising on the

quality of the solutions. This need of the hour and the timely change in the regulations has led to the introduction of a few startups who are leveraging their skill sets and ideas for a better future for India.

Pixxel is India's first private earth imaging company, working to provide affordably and round the clock real-time satellite imagery. Pixxel has raised \$5 million seed funding from Light Speed, GrowX and is set to launch the first satellite by December this year from a Russian facility. Between December 2022 and June 2023, Pixxel has planned to launch a constellation of 30 satellites with the help of ISRO.

Skyroot, India's first space launch startup, was founded two years ago by a rocket engineer team who previously worked at ISRO. The startup has raised \$4.3 million to date and hopes to secure another \$51 million in 2021. It will launch its first satellite, "Vikram-1," in December 2021. They have reduced the engine's mass by 50% and lead time for manufacturing by 80% using 3D print technology. Vikram-2 Vikram-3 are and planned to be launched around 2023 and hence compete with SpaceX. Astrome is a startup focusing on low internet connectivity in rural areas and different cities

across India. It could potentially compete with SpaceX to work upon connectivity problems by beaming high bandwidth internet. At IISC, the 18member team plans to 200 launch microsatellites by 2021 into space to provide the internet with 100GBps capacity via their patented technology. Agnikul Cosmos,

incubated in IIT Madras, aims to democratize small satellite launches and is looking forward to its first launch by 2022. Intending to launch vehicle-spaceport interfaces, the company has established itself as leading rocket technology company. The company aims to provide rapid, agile, and low-cost access to space. ISRO is working on the launch of more massive satellites, while Agnikul targets the market where thousands of satellites of around 100kg are set to be launched across the world.

From a million-dollar industry in the early '20s, Space tech valuations have reached whopping \$ 360 Billion industry in 2019. The Indian Space economy is currently valued to be 2% of the global space economy. Indian spacetech ecosystem is a dark horse that is expected to increase its market share with a significant cost advantage, a large skilled human resource pool, and high consumerdriven local demand for telecommunications. There were merely five significant deals in India amounting to just \$ 3.4 million. The downstream space sector consisting satellite communication and application consisted of 68% and the upstream industry of satellite propulsion, launch vehicle, a lunar roverapplication based consisted of 32% of the investment. At present, the ISRO undertakes two to three major satellite launches a year.

The Pillai committee recommended a greater role for the private sector for using ISRO facilities for satellite launches taking the number of annual launches to 15. The downstream space segment consists of the application of satellites for communication, scientific research, weather forecasting, geological and oceanographic studies, disaster management, agricultural studies, and all products and services related to these areas. With the right use of data analytics capabilities coupled with artificial intelligence (AI) and machine learning (ML) algorithms, the data generated by remote sensing satellites can be of immense value for decision making. There is huge scope for the commercialization of the ground operations like



mission support, satellite broadband gateways, and 5G backhauling.

The future scope of public-private partnership is dependent on how well the two entities can work together to achieve a common goal. The need for the load-sharing has led to the change in the rules and regulations thereby leading to the public-private partnership which seems to be giving satisfactory results at the moment; however, various initiatives such as upskilling talent force, encouraging FDI, developing investor's confidence and technological innovations, etc., need to consistently increase which will require a perfect balance between the two entities. InSPACe is expected to be functional within the next few months. Even though the internal threats such domination of profitability interests over society should be of prime importance, we cannot ignore the foreign threats at the same time.

The ambitions, current rate of raising funds, and the technological advancements of the Start-ups along with | considering affordability and agility will lead to significant growth opportunities in the Indian space arena in the upcoming future and will help the start-ups to take the legacy of ISRO further, thereby strengthening India's position in the space sector. The estimated growth in the space sector, before involving the private entities was 5 % by 2023; however, considering the current scenario, the new growth estimate is 7% by 2023. Therefore, it is more about uniting, evolving, advancing, spreading peace, and fighting against our enemy, if need be. So, let us win over the internal conflicts secure and motherland by winning the race to space.

Grand BJP Show Mars TRS Victory

TRS loses vote share too, AIMIM retains vote bank but Cong routed in GHMC polls



Hyderabad: The ruling Telangana RashtraSamiti (TRS) headed by K. Chandrasekhara Rao might have managed to retain the cash-rich Greater Hyderabad Municipal Corporation (GHMC) but not before suffering some considerable embarrassment.

Not only has the TRS lost its vote share, but lost 30 seats that it won in the 2016 polls. Contrary to this, the BJP not only increased its vote share from a mere 10 to 36 percent but also managed to win 48 seats, the TRS in 55 and AIMIM in 42).

Interestingly, the AIMIM has managed to retain its minority vote bank by winning 42 out of 44 seats they won in the last polls. AIMIM legislator AkbaruddinOwaisi's speeches which went viral on social

media seem to have benefited the BJP most but cost its "discreet" ally, the TRS, dear. In the 2016 polls, the TRS had won 99 of the 150 seats and created a history of sorts, while the AIMIM 44. The TRS's decision to go solo in the polls was not to lose its Hindu vote bank, but if poll results are anything to go by, it did not impress the voters much.

And, the worst sufferer in the polls is the Congress, which failed to improve its performance since the last Assembly polls. One of the reasons may be because the party is losing its credibility as most of its MLAs or councilors chose to jump onto the TRS bandwagon. As a result, the voter too seems to have realized that voting for that party is as good as voting for the TRS.

The BJP which has emerged

strongly in the GHMC polls is likely to occupy the principal Opposition role, dislodging the Congress from its roots.

What the TRS did not realize was that its surprise move to bring the polls forwards by a month-and-half and get endorsed by its hand-picked state election commissioner would misfire. The BJP, fresh from its Dubbak victory, has not only accepted KCR's challenge but has also taught yet another hard lesson to his party and government. It quickly roped in its national leaders, including the national party leader JP Nadda and the Union home minister Amit Shah, besides other political heavyweights like Uttar Pradesh Chief Minister Yogi Aditvanath.

The BJP top guns' decision to campaign indeed rattled the TRS, though not much the AIMIM. The AIMIM appears to have taken advantage of some hardcore BJP leaders' presence in election campaigns like Yogi to its advantage to win back its cadres.

Expelled Pradeep Panigrahi Arrested

Panigrahi, till recently considered close to CM Naveen Patnaik, has been arrested onhurridly framed charges of forgery, fraud, and criminal conspiracy

Bhubaneswar, Dec 4: In development with few precedents in the state, former minister and sitting MLA from Gopalpur Pradeep Panigrahi was arrested by the Crime Akash, along with his father, senior Indian Forest Service (IFS) officer Abhaykant Pathak, has already been arrested for amassing huge amounts of money disproportionate to their known sources of income

Panigrahi came under the scanner after it emerged during an investigation into the case of



Branch of Odisha Police on charges of forgery, fraud, and criminal conspiracy late on Thursday and sent to judicial custody for 14 days after his bail plea was rejected by Bhubaneswar subdivisional judicial magistrate (SDJM). In an equally rare happening, he had been expelled from the BJD for alleged 'anti-people' activities last Sunday.

Panigrahi has been charged with facilitating the duping of 68 youths in Ganjam district by his would-be son-in-law Akash Pathak, who has been arrested for collecting huge amounts of money from these youths by posing as the managing director (MD) of Tata Motors and promising them jobs in the company. Various sections of the Indian Penal Code (IPC), as well as the ITAct, have been pressed against the Gopalpur MLA, sources in the Crime Branch said.

disproportionate assets against Pathak that he (Panigrahi), along with the family of his would-be inlaws, had undertaken several trips to Mumbai, Pune, and other places on chartered flights and splurged huge sums of money in swanky hotels during and after the lockdown. But the arrest came only after specific evidence emerged during the ongoing Crime Branch probe that there were financial transactions worth over Rs 2.63 crores in Panigrahi's bank account in the last few months, a source in the CB said. The probe revealed that huge amounts of money had been deposited into Panigrahi's account, which had later been transferred to Akash's account.

The arrest of Panigrahi came under dramatic circumstances on Thursday evening with his wife raising questions about how he was taken away. A group of 12-15 Crime Branch officials, including some women, descended on Panigrahi's residence and whisked him away to an unknown destination, she claimed. "When I asked them where they were taking my husband, they said to the Economic Offences Wing (EOW). But when I reached the EOW, he was not there. I fear for the safety of my husband. If something happens to him, Chief Minister Naveen Patnaik will be responsible for it," she told the media.

Panigrahi was being questioned in connection with a case registered against him (case no 26/20202). The arrest came after he was grilled for two and a half hours. Sources in the CB said the agency may seek the remand of the arrested Gopalpur MLA to dig more into the case and may grill him face to face with the Pathak father-son duo, who are already in its custody.

There is little doubt that the case against Panigrahi has political undertones. But given the evidence of fraud that has already emerged during the disproportionate assets case against the Pathak father-son, it is difficult to see how he can wriggle out of the case. The state vigilance has already unearthed evidence of disproportionate earnings worth more than Rs 16 crores and expects to unravel more by the time the probe ends. With tell-tale evidence emerging now about money being funneled into Akash's account through Panigrahi, the former Naveen acolyte may well be in for a long haul.

Kadaknath, The Unique Black Chicken

Demand for Kadaknath, a unique black fowl found in the tribal-dominated Jhabua district of Madhya Pradesh has seen a surge amid rising COVID-19 cases, of late.

According to government officials, amid the virus outbreak, the demand for black chicken (Kadakanth) has gone up sizably these days. The demand had dwindled amid lockdown induced by the

COVID-19 outbreak but ever since the unlock has come into effect, the demand is going up all the time

The state government seeing the surge in demand has chalked out a plan to enhance its production and sale to ensure that the income of poultry farm owners is increased, an official statement of the MP government said.

This chicken has black

color skin, blood, and meat. Besides having immunity boosting features, the meat is low on fat, high on protein, and is beneficial for those suffering from heart, breathing, and anemic ailments, it added.

A total of 300 members from registered poultry farms in Jhabua, Alirajpur, Barwani, and Dhar districts to boost co-operative farming of this breed, said Addl Chief Secretary Animal Husbandry JS Kansotia.

The poultry owners from across the country are coming to our hatchery in their vehicles to buy Kadaknath chicks, IS Tomar, chief of Jhabua's Krishi Vigyan Kendra said.

The KVK although hasn't carried out any separate scientific study regarding Kadaknath chicken in the backdrop of Covid-19, it is a known and fact that this variety of chicken has a higher amount of protein and is low in fat and cholesterol than other breeds of chickens, said Tomar.

Vinod Meda, head of a Jhabua district-based cooperative organization associated with the production of this fowl, claimed the demand for this chicken has surged during the pandemic.

Kadaknath chicken from Jhabua district had got a Geographical Indication (GI) tag last year.

This variety of chicken, which is mainly reared in Jhabua and called 'Kalamasi' in the local dialect, is registered under the category of "Meat Product, Poultry, and Poultry Meat.

Eggs and chicken of this breed fetch almost ten times the normal ones.

Tata Power gets LoI for Odisha's WESCO and SOUTCO



New Delhi: Tata Power Co. Ltd on Friday announced that it has received the Letter of Intent (LOI) for supplying electricity to the consumers of two electricity distribution companies (discoms) in Odisha-the Western Electricity Supply Company of Odisha Ltd (WESCO) and the Southern Electricity Supply Utility of Odisha Ltd (SOUTHCO). Mint first reported on Thursday about Tata Power emerging as the winner in

bids for these two discoms in the privatization exercise. While WESCO supplies electricity to consumers in the distribution circles of Rourkela, Burla, Balgarh, Bolangir, Bhawanipatna, SOUTCO serves Behrampur, Aska, Bhanjanagar, Jeypore, and Rayagada.

Tata Power in a statement on Friday said that it has received the Letter of Intent (LOI) from the Odisha Electricity Regulatory Commission (OERC) for the

distribution and retail supply of electricity in Odisha's five circles of WESCO and six circles of SOUTHCO.

A consortium of India Power Corp. and French government-owned power utility Electricite de France (EDF) were the only other bidders for WESCO and SOUTCO respectively. However, their bids weren't technically qualified, resulting in only Tata Power's bids being opened on Thursday. While PwC

was managing the sale of WESCO, Deloitte had the mandate for SOUTHCO

"As per conditions of bid documentation Tata Power will hold 51 percent equity with management control and the state-owned (CESU Odisha) last December. Tata Power is also now the only bidder for North Eastern Electricity Supply Company of Odisha Ltd (NESCO), which supplies electricity to the districts of Balasore, Mayurbhanj, Keonjhar,

Odisha has an average

power demand of 4,000 MW. It was the first state to privatize its power distribution sector into four discoms in 1999. This was followed by Delhi, which privatized three of its discoms in July 2002-BSES Rajdhani Power Ltd (BRPL), BSES Yamuna Power Ltd (BYPL), and Tata Power Delhi Distribution Ltd. "While WESCO serves

of surgery at Tilak Ayurveda College and Tarachand Hospital, a semi-government facility in Pune, said for several surgeries Ayurvedic procedures almost exactly match those of modern medicine about how or where to make a cut or incision, and how to perform the operation. There are significant divergences in postoperative care, however.

"The only thing that we do not do is superspecialty surgeries, like neurosurgery. For most other needs, there are surgical procedures in Ayurveda. It is not very different from allopathic medicine." Hemantha Kumar said.

Before the notification, what were the regulations for postgraduate

Postgraduate education in Ayurveda is guided by the Indian Medical Central Council (Post Graduate Education) Regulations framed from time to time. Currently, the regulations formulated in 2016 are in force. The latest notification of November 19 is an amendment to the 2016 regulations.

The 2016 regulations postgraduate allow students to specialize in Shalya Tantra, Shalakya Tantra, and Prasuti evam Stree Roga (Obstetrics and Gynecology), the three disciplines involving major surgical interventions. Students of these three disciplines are granted MS (Master in Surgery in Ayurveda) degrees.

Ayurveda practitioners point out that students enrolling in Avurveda courses have to pass the same NEET (National Eligibility-cum-Entrance Test). Their course runs for four-anda-half years, followed by one year of internship, six months of which are spent at an Ayurveda hospital, and the remaining six months at a civil or general hospital, or a primary health care center.

Postgraduate courses require another three years of study. They also have undergo clinical postings in the Outpatient and Inpatient departments at hospitals apart from getting hands-on training in Ayurvedic treatment procedures. Medico-legal issues, surgical ethics, and informed consent is also part of the course apart from teaching Sushruta's surgical principles and practices, said Dr Vinayak Temburnekar, National President of National Integrated Medical Association (NIMA).

Ayurveda practitioners say the latest notification just brings clarity to the skills that an Ayurveda practitioner possesses.

"The surgeries that have been mentioned in the notification are all that are already part of the Ayurveda course. But there is little awareness about these. A patient is usually not clear whether an Ayurvedic practitioner has the necessary skill to perform one of these operations. Now, they know exactly what an doctor is Ayurveda capable of. The skill sets have been defined. This will remove question marks on the ability of an Ayurveda practitioner," Hemantha Kumar of the Jaipur-based National Institute of Ayurveda said.

What are the IMA's objections?


IMA doctors insist that they are not opposed to the practitioners of the ancient system medicine. But they say the new notification somehow gives the impression that the skills or training of the Ayurveda doctor in performing modern surgeries are the same as those practicing modern medicine. This, they say, is misleading, and an

"encroachment into the jurisdiction competencies of modern medicine".

The fact that Ayurveda institutions prescribe textbooks from modern medicine, or that they carry out surgeries with the help of practitioners of modern medicine, is not reason enough to allow this encroachment, said K M Abul Hasan, chairman of the IMA Junior Doctors' Network.

The IMA has demanded that the notification, as well as the NITI Aayog, move towards 'One Nation One System' be withdrawn. "If the government does not accept our demands, IMA will file a petition in the Supreme Court," said R V Asokan, Secretary-General of IMA.

Recreating The Golden Era Of Film Songs



The velvety voice of Talat Mehmood and the seductive voice of Ameen Sayani can instantly lift one's mood.

Listening to Sudip Banerjee singing the songs sung by the velvet-voiced Talat Mehmood was a bit of an emotional ride. The songs in themselves are mostly layered with melancholy, rich in imagery, and set to tunes that flowed like moonlight over water when Talat sang them. As suited the music of the composers who used his tremulous voice to advantage, among them Anil Biswas, Khayyam, SD Burman, and Madan Mohan, the orchestration supported the voice, setting it off like a softly gleaming jewel, letting the words slide over the tune and reach the heart. Talat, popularly called the King of Ghazals took the genre in films to its height, and the songs wooed, lamented, or celebrated love in its many moods for heroes as diverse as Bharat Bhushan and Dilip Kumar.

Banerjee's performance at the Jasn-e-Talat show which premiered on the Royal Opera House's Mumbai Opera Online website this week was a series of songs excerpted from his performance at the Kala Ghoda festival. It was wonderful to listen to the old numbers, and to his credit, Banerjee tried to make the songs reach out to the younger audiences by bringing in contemporary more instrumentation and creating a zany vibe. The tune, the words remained in their appointed places, and for those who had never felt their power, there is every chance that the performance may have created a few fans at least for the songs, if not the original numbers.

Yet, credit is due, for an attempt to revive songs that still retain their freshness and ability to touch the heart; but are seldom heard as fm stations dare not venture into the past beyond the 1980s in their bid to hold

listeners. It's only on Vividh Bharti that one gets to hear Talat originals on and off. And of course on SaReGaMaPa's Caravaan, or one of the music streaming sites.

Readers may do well to check out the songs. And let Talat cast his spell. They will be surprised at how powerful it can be.
