State Elections Start March 27, Counting On May 2

More than 18 crores are eligible to vote in these elections, Chief Election Commissioner Sunil Arora said



New Delhi: Elections in Tamil Nadu, Kerala, West Bengal, Assam, and Puducherry will be held from March 27 and the results will be announced on May 2, the Election Commission said today. Bengal will vote in eight phases,

March 27, April 1, April 6, April 10, April 17, April 22, April 26, and April 29. Tamil Nadu and Kerala will vote in a single round on April 6. Puducherry will also vote on the same day.

Assam will vote on March 27, April 1, and April 6. The model code of conduct is now (Page-8)

Why Petrol and diesel prices continue to soar, when and how relief is expected



New Delhi: Why Petrol and diesel prices are increasing? Petrol and diesel prices continue to soar with no limit in sight. It has breached Rs 100-mark in some states. After Rajasthan, the petrol price crossed the 100 per liter mark in Madhya Pradesh when fuel rates were increased for the 10th day in a row. The increase in fuel prices even continued on Saturday for

the 12th consecutive day.

In April last year, India had supported the decision of the major oil-producing countries to cut production as there was a sharp fall in demand amid the Covid-19 pandemic. India has urged the OPEC (Organisation of the Petroleum Exporting Countries) and OPEC plus countries to not go for a production cut as that is

impacting the fuel price in India, Union petroleum minister Dharmendra Pradhan said on Sunday. "There are two main reasons behind the fuel price rise. The international market has reduced fuel production and manufacturing countries are producing less fuel to gain more profit. This is making the consumer countries suffer," the minister said.

There are several reasons such as huge tax imposed by the Centre and state governments, affecting the petrol and diesel prices. Besides, there are global factors too behind the continuous increase in fuel prices. "Brent crude price in the international market has gone as high as \$65 per barrel. This crude rate is the

The reason behind this jump in crude oil is due to America, which is one of the biggest producers of crude oil, facing a problem with the supply. There is a huge dip witnessed in the US," he said. As per experts say 40 percent of crude production in Texas has been hit due to unfavorable climatic conditions. Apparently, due to extreme cold condition pipeline in Texas have frozen and employees are unable to work in this hostile condition. which is affecting the supply.

Another big reason is that OPEC (Organization of the Petroleum Exporting Countries), which supplies-almost 40 percent of crude to the world, has been (Page-8)

New guidelines for social media, OTT platforms

New Delhi: The government on Thursday announced new guidelines aimed at curbing misuse of social media and OTT platforms. The prominent feature of these guidelines was the government's direction to platforms to appoint grievance mechanisms and for them to disclose the first originator of mischievous information. The rules also asked the platforms to remove content depicting nudity or morphed pictures of women.

The rules were laid out in a press conference addressed by Information and Broadcasting Minister Prakash Javadekar and Electronics and Information Technology Minister Ravi Shankar Prasad.



Both the ministers said that the guidelines were prepared after widespread consultations.

Prasad said that social media intermediaries will be categorised into two categories

- 1. Intermediaries
- 2. Significant social media intermediaries



Prasad said that the classification has been done based on the number of users and that the government will soon notify the exact number of users based on which the classification will be done. Significant social media intermediaries will have greater obligations. As per the new rules, social media intermediaries have to appoint a grievance officer, who shall register complaints in 24 hours. The grievance redressal official must be resident in India, and monthly compliance reports will have to be filed by social media platforms.

Social media platforms on being asked by court or government will be required to disclose the first originator of the mischievous information.

Significant social media intermediaries will have to appoint a chief compliance officer in India. In addition to this, the platform will be required to have a nodal contact personresident in India-for coordination with law enforcement agencies, and have a resident grievance officer (Page-15)

Churning in North may impact Bengal, change nation's course

In a changing political perception, northern India is becoming more vocal in the wake of farmers' agitation. Will it change national politics?

Till a few months ago the region was not ready to accept any criticality against the NDA. The deviation was considered unnatural. It would still be a bit too much to say that the voters are drifting away but the people are forcefully discussing the moves that they consider harsh like rising prices. It is in contrast to the 2019 Lok Sabha poll verdict. The supposed discontentment various policies and performance was high but faith in prime minister Narendra Modi was giving the BJP a thumping majority.

Would it now impact the political syndrome? Punjab has seen the rout of BJP and its former ally Shiromani Akali Dal in the civic polls. Haryana is upset and Rajasthan may be changing. Now farm leaders' move to launch the campaign on tractors in Bengal to awaken the voters may heat the minigeneral polls.

The sit-ins around Delhi by farmers from Punjab, Haryana, and western UP against the three farm bills signify that the people in this region and across the castes possibly are changing their opinion about the ruling combine. The issue of two types of mandis -**APMC** private unregulated outside it - has raised suspicion. It is accentuated by the perception that the MSP is to be done away with and the farming class would be thrown into deep trouble as two big industrial houses are ruling the roost. The shift is being felt in the western UP's Jat belt, who overwhelmingly voted for the BJP.

The eastern UP is slowly responding to the moves of the western brothers. There is some churning but the expression is through popular jokes. Maybe the recent visits of Modi to his constituency and the beautification of Varanasi are doing the trick.

As many farmers are leaving the sit-ins around Delhi for the harvest season, the scenario is changing to the massive rallies being held across the rural hinterlands. The newly emerged farm leader Rakesh Singh Tikait's call to his clan to boycott the BJP leaders is getting effective. It started in Punjab and now the Jat belt of western UP, Haryana, and Rajasthan are seemingly getting swept with such feelings. Tikait and his fellow leaders have announced that if anyone mistakenly entertains a member of the ruling combine, he would have to feed 100 persons as a penalty. They do not conceal that they had voted the BJP to power in 2014 and 2019.

Till a few months back, the Congress leaders Rahul Gandhi and Priyanka Gandhi tried to politicize the rape and murder of a Hathras girl that led to wide media coverage and also of arrests some Despite newsmen. societal concern in the region over highhanded approach of the UP government, it was allowed to be passed off as an "aberration" and did not dent the popular hold of the party.

Within four months

there is change. Now the normally quiet rural people are openly discussing the situation and to the surprise of many, they are mocking the leaders, who are supporting private companies and singing paeans for them. Finance Minister Nirmala Sitharaman's statement that India would be left with only 23 public sector companies has also not enamored them. The rising prices are being attributed to the move to boost profiteering of the big houses, which are on a spree to capture airports, roads, arms, other businesses in the country and abroad, and the railways. Even people see their hands in the game of increasing petrol, diesel prices and junking of people's old vehicles and tractors. The people are no more buying the party's campaign that private is needed to cleanse the polity and a prospering economy.

Ridiculing leaders at tea vends or moving tempos and tirries (local three-wheeler transports) has become a usual pastime. Even the earlier saying that one who does not have a family doesn't need to be corrupt has changed to 'one who has a family would have limited greed' and 'if you have many families you would be greedy'. Such mentions follow loud laughter. Some have come out with jokes - 'in 1980 baratis (marriage party) were welcomed with pan parag, in 2021we are anti-dowry, just pay us for petrol'. Even manycore sanghis are coining wary jokes and coming out with 'performance' charts.

Overtly the farmer movement in the region is non-political, but a dormant RashtriyaLok Dal (RLD) has come back to life with a call from its leader Ajit Singh to Tikait. After the Republic Day tractor parade violence, Tikait had gone into depression. Singh's call and his son Jayant's support by sending thousands to the borders with water from his village in cans has not only revived the movement but the RLD has also got a boost. The Samajwadi Party's Akhilesh Yadav is trying to ride RLD. Congress is watching and acting quietly to blunt the sharp attacks of the BJP.

The BJP unaware of churning. On Sunday, February 21, it held a meeting of national office-bearers, state incharge, co-in-charge, and state chiefs. The day-long meeting inaugurated by Modi discussed threadbare the booth level strategies in poll-bound states and Bengal, the toughest and cynosure of its eyes. Party general secretary Bhupendra Yadav said the BJP in its political resolution has committed itself to uproot what he called the undemocratic+ government of Mamata Banerjee and retain Assam. He said the BJP would reach out to farmers to bust the myths being spread by the Congress on farm

That's natural. It would fan out its cadre to Bengal to counter sharp attacks by Mamata Banerjee. The recent cocaine seizure from an ABVP youth leader and CBI call at CM's nephew's house for investigating coal scams are being keenly watched by the voters. Farm and political leaders from other states plan to visit the state to boost campaigning against the center. Yes, Bengal is warming up every day. How northern changes fan it or not needs to be seen? The journey would not be easy in a do-ordie battle.

Rourkela, Feb 18: An interaction session was organized between Local Industries and planning officials of the different Departments of the Rolling Mills area of SAIL, Rourkela Steel Plant (RSP), by PIVD Section of Materials Management Department, RSP on 18th February 2021. Mr. C R Mohapatra, CGM Incharge (MM & Marketing) presided over the session. In all 15 industrialists from Dis-



trict Small Scale Industries Association (DSSIA), Odisha Assembly of Small and Medium Enterprises (OASME), Odisha Young Entrepreneurs Association (OYEA) along with 15 officials from New Plate Mill, Hot Strip Mill, and Silicon Steel Mill and Materials Management Department participated in the program. In his opening remarks, Mr. Mohapatraemphasised increasing steel consumption in the region by encouraging local industries to enhance their capabilities. The objective of the meeting was to explore possibilities of sourcing spares from local Small Scale Industries and focused on sourcing of Rolling Mills Spares through local industries and their capability to supply. Notably in the Plant Level Advisory Committee

NHRC asked Odisha Chief Secretary to relocate Satkosia villagers

Kendrapada (Rajesh Kumar Behera): The National Human Rights Commission (NHRC) recently asked the Chief Secretary of Odisha to complete the rehabilitation and resettlement of five revenue villagers displaced due to tiger and wildlife conservation projects in Satkosia in Angul district within three months.

While monitoring the case filed by Activist-Lawyer Radhakanta Tripathy the Apex rights Panel passed the order recently.

Tripathy raised the issue of rehabilitation and basic human rights issue of forest dwellers of five Rev-



enue Villages in Satkosia wildlife division. The Com-

mission took cognizance of the present complaint on

30-01-2014 and sought a report from the Chief Secre-

tary, Government of Odisha.

The Commission directed the State Secretary, to submit an additional/ requisite report in the matter. The response is awaited and the matter is pending for want of some additional information. Being a seven years old case, the matter has been placed before the Commission for reconsideration of its earlier proceedings. The present case relates to the rehabilitation of forest dwellers, whose villages, came under the tiger conservation project and were forced to evict, but the state government has not taken any re-

tion measures. In the above circumstances, the Commission directs the Chief Secretary, Government of Odisha to look into the matter and do needful within three months for settlement of Forest dwellers. The report further stated that as regards to relocation of village Marada in Mahanadi (WL) Division is concerned; due to left-wing extremist problem, the progress has been delayed.Earlier the Commission asked the Director, NTCA, to expedite the relocation and submit a report, but the Authority failed to respond.

Baripada ITDA breaches GST norms over development works

Baripada, 28 January: While core of rupees are sponsored the Government over development works for tribal belts across the State, the Integrated Tribal Development Agency (ITDA) of Baripada one of the Government Agency allegedly found busy manipulating the government fund ignoring their higher authorities. Some instances have come to light for the misappropriation of the Backward Region Grant Fund (BRGF) and Local Area Development Fund of an MLA. The bills on the construction work of projects were approved by the officers and payments against the bill were taken without doing any work physically.

Here is an instance; Sananda Marandi during his tenure as the MLA of Baripada had provided Rs. 5 lakh from his LAD fund in 2015-16 for the construction of Guard Walls in two locations. One would be erected near the bridge side of Raghunathpur and another guard wall would be erected close to the bridge in Janardanpur Ward No-22 through a construction agency. Later it was approved by the for department construction of guard walls in the two locations. As per case



record no-94, the bill of Rs. 5 lakh had been paid to the construction agency during 2017-18 but surprisingly the guard walls were not erected at those sights physically. Neither the MLA nor the concerned officers have physically inquired into the matter before approving the

According to BBC, several pairs of underpants were seized in the central city of Kryvyi Rih and are advertised on a justice ministry website for online auctions, called Setam. The starting price for one pair is

Setam was launched in 2015, and Ukrainian justice ministry figures say that some 14.1bn hryvnia (£364 million) of the property has been sold on it so far. The ministry also donates some confiscated property directly to orphanages, hospitals, and schools. A report published by the



19.4 hryvnia (Rs 50). The report says that the state has also been auctioning off cows and sheep. The solution to the farm impasse

The country must break out of the cycle where states escape their responsibilities and the Centre then pushes in, accumulating more power in the process. Let the states take ownership of state subjects. The current imbroglio over the farm laws highlights the Centre's growing intrusion into what are constitutionally state subjects. But they also highlight another uncomfortable reality. Many of the most serious economic afflictions facing the country - agriculture, water, power, land, health, and education are state subjects. And the failures of the states to do justice on subjects that are well within their constitutional obligations have created space for a futuristic Centre to

Here is an example. "Public Order" and "Police" fall under the "State List" of the Seventh Schedule, putting

the onus on state governments for the maintenance of the law and order in their states. In 1999, the Parliamentary Standing Committee observed that "of late the dependence of State Governments, all over, on the Central Para Military Forces in dealing with difficult situations arising on the law and order front has increased significantly. This changing trend over the years has given rise to a situation of contradiction wherein while on the one hand, the State Governments tend to demand more and more power and autonomy, on the other hand, they appear inadequately prepared to perform; one of the most primary duties of states for maintaining law and order and peace and normalcy. On every incident of minor or major proportion, they tend to seek the help of the central police forces, which only throws poor light on the efficiency of the states in

dealing with adverse situations. Little has changed. Over the past two decades, even as the states continued to underinvest in their police, the size of the Central Armed Police Forces (CAPFs) doubled, thereby ensuring the sneaking federalisation of a state subject. It is quite obvious as a natural rule.

The story is similar in agriculture. For the vast majority of India's farmers, the tiny size of their farms means that there is simply no way they can make a decent income on farming alone unless their incomes are artificially boosted by a plethora of input subsidies, price or income supports - or if they are part of the privileged few who have large

The only viable long-term answer for the majority of India's farmers, as BR Ambedkar observed a century ago, is to get out of farming.

At that time, India's population was a fifth of what it is today, and land fragmentation correspondingly less. Public policies of input subsidies (especially on fertilisers and water) that reinforced the Green Revolution certainly benefited the country broadly, in terms of both aggregate outputs as well as farmer incomes. But their sell-by date is well-past. Once farm incomes rose, the rural surplus should have provided the springboard for structural transformation, especially in industry.

The basic thrust of the farm laws was in the right direction. But their specific details and how it was done without broad deliberation and building consensus has been completely selfdefeating. A way out of this turmoil might lie in respecting India's federalism. The Centre should not pass farm laws that affect agriculture markets within states, but this should also mean no central government Minimum Support Price (MSP) and no government central procurement. The states say that agriculture is a state subject. It is. And they should have complete say in what subsidies they want to give

their farmers, for which crop, and how. The states that strongly believe in MSP and procurement should have complete ownership of both.

The Centre's involvement in procurement today is intimately linked to its obligations under the Right to Food Act. That Act had the right intentions but its cereal obsessiveness is having deenly damaging consequences for agriculture and agro-ecology. Crops, especially cereals, are lavished with subsidies while fisheries, livestock, and horticulture have grown much faster - and are more nutritious.

The Centre's involvement in agriculture markets should be to smoothen pan-India commerce - no state should be able to block the interstate movement of a commodity. For its part, the Centre should not ban agriculture exports if prices rise. Why should farmers not get the upside of prices when they have to suffer the downside when prices go down? If the government is worried about consumer reaction, it should either compensate farmers commensurately or subside the consumer directly, but not force the farmer to do so.

But all this cannot be done overnight. There needs to be an exit ramp for farmers and states to adjust. Here, the Centre should provide a clear road map along with performance-based incentive financing to ease the transition over three to four

The farm laws are illustrative of uncomfortable reality. There are many important issues that states are fully empowered to handle. But they don't. Problems arise. Then there is a clamour that "the government" should do more. But, inevitably, that means the central government. Of course, the Centre loves this, because it then exercises more power. And that has slowly, but surely, tilted the already imbalanced Union-state relationship even more in favour of the former.

The best bulwark against a hegemonic Centre is stronger federalism. But, for that to occur, states will have to up their game. Fundamentally, unless they bite the bullet and move to develop their non-farm sectors, most farmers will have increasingly precarious livelihoods. And the Centre can best help farmers by assisting states to make that transition.

in place in all the states. More than 18 crores are eligible to vote in these elections, Chief Election Commissioner Sunil Arora said.

This is the first major set of elections to be held in the middle of the coronavirus pandemic after the Bihar election. Poll officers will be vaccinated as frontline workers, said the Election Commissioner, adding that new rules for digital sites would be applied on social media. Polls will be held for 294 seats in West Bengal, 234 seats in Tamil Nadu, 140 seats in Kerala, 126 seats in Assam, and 30 seats in the Union Territory of Puducherry.

The Election Commission cited fear of violence while defending eight rounds and said: "We had an assessment of law and order on several factors. Last time it was seven phases so eight is not a big deal."

Bengal Chief Minister Mamata Banerjee lashed out at the Centre over the longest ever vote and said: "Why

is one district (24 Paraganas) voting in three rounds? Has this been done at the instance of Narendra Modi and Amit Shah? The daughter of Bengal has one thing to say. I will defeat all your conspiracies," she said.

Bengal is hurtling towards the most high-stakes battle of all with the two-time Chief Minister facing a tough challenge from the BJP. Her Trinamool Congress has been losing leaders - including her most trusted strategists -to the BJP and the bleed hasn't stopped. She also accuses the BJP of using central agencies to hound her party men with multiple investigations.

In Kerala, it's an intense battle for the ruling Left-Led front and the Congress-led opposition coalition. The voters have alternated between the two in past state elections. The CPM hopes to continue its gains in the only state it rules after a victory in the recent local body elections.

India to enhance capabilities in defence manufacturing: PM

The prime minister listed a series of measures taken by his government to boost self-reliance in the defence sector



New Delhi: India had an age-old experience in making arms and military equipment

but after Independence, this capacity was not strengthened, Prime Minister Narendra Modi said on Monday, asserting that now the country is committed to enhancing its capabilities in defence manufacturing at a fast pace. Addressing a webinar on the effective implementation of the Union Budget's provisions in the defence sector, the prime minister listed a series of measures taken by his government to boost self-reliance in the defence sector.

"Before Independence, we used to have hundreds of ordnance factories. In both the World Wars, arms were exported from India on a large scale, but after Independence due to several reasons, this system was not strengthened as much as it should have," he

said.

"The condition is such that even for small arms we have to look at other nations. India is amongst the biggest defence importers and this is not a matter of pride," Modi stressed. He said it was not that the people of India do not have the talent or capability and pointed out that India did not make ventilators before the coronavirus period but now manufactures thousands of ventilators. "An India that could reach Mars, could have made modern weapons also but it became an easy way to import weapons from abroad," he said.

But now India is working hard to change the situation and India is committed to enhancing its capacities and capabilities at a fast pace, the prime minister asserted.

Modi said with initiatives like de-licensing, deregulation, export promotion, foreign investment liberalisation, the government has taken several measures to give the defence manufacturing sector a boost.

He said with the establishment of the chief of defence staff post, bringing uniformity in the procurement process and induction of equipment has become easy.

Crowd gathering doesn't lead to revocation of laws: Tomar

Gwalior: Tomar urged the agitating farm unions to tell the government which provisions in these new laws they find anti-farmers. BJP sweeps Guj civic polls, AAP makes a stunning debut

AAP made a stunning debut in the state by winning 27 of the total 120 seats in Surat, virtually stamping out Congress, and emerging as the main opposition party.

In Ahmedabad, another debutant, Asaduddin Owaisi's All India Majlis-e-IttehadulMuslimeen, made a memorable launch at Congress' cost, winning seven seats in minority-dominated areas that were all bastions of the latter.

AAP won from the Pateldominated areas in Surat, signifying that Patidar quota stir leader Hardik Patel's entry into Congress has had little impact on the fortunes of the grand old

party. Of the 27 seats AAP won in Surat, 25 were held by Congress. It is all set to position itself as a formidable opposition party in Gujarat at a time when a weakened

Vijay Rupani's hometown Rajkot where it won 68 of the total 72 seats. In 2015, BJP had managed to win just 38.

Congress is fast losing both its leaders and support base.

New Delhi: India is set to clear 45 investment proposals from China, which are likely to include those from Great Wall Motor and SAIC Motor Corp, government and industry sources told Reuters, as military tensions ease at the

The proposals have been held up since last year after

India tightened controls on Chinese investment in the country in retaliation against Chinese troop incursions in the western Himalayan region. China blamed Indian troops for the standoff.

About 150 investment proposals from China worth more than \$2 billion were stuck in the pipeline. Companies from Japan and

the US routing investment through Hong Kong were also caught in the cross-fire as an inter-ministerial panel led by the interior ministry increased scrutiny of such proposals.

A Home Ministry spokesman did not respond to a request for comment on the proposals to be cleared.

Two government sources who have seen the list said

most of the 45 proposals set for early approvals are in the manufacturing sector, which is considered non-sensitive in terms of national security.

The sources did not elaborate but two other government officials and two industry sources who are privy to the process said proposals from Great Wall and SAIC are likely to be on the list.

Great Wall and General Motors (GM) made a joint proposal last year seeking consent for the Chinese automaker to purchase the US company's car plant in India, in a deal expected to be valued at around \$250-\$300 million.

Great Wall, which plans to invest \$1 billion in India over the next few years, said earlier that establishing operations in the country is a key part of its global strategy. It had planned to start selling cars in India from this year and was also mulling bringing in electric vehicles.

Great Wall said it continues to seek relevant approvals and investment clearances. "Should we be granted all relevant approvals, we will push all work forward in India, abiding by the laws and rules laid down by the Indian government," a company spokesman said.

A GM spokesman added: "We continue to seek all relevant approvals to support the transaction."

SAIC, which started selling cars in India in 2019 under its British brand MG Motor, has invested around \$400 million of the nearly \$650 million it has committed to India and would need the approval to bring more investment.

SAIC's India unit did not respond to an email seeking

comment.

The change in the government's stance follows an improvement in the border situation. Troops who were in the eyeball to eyeball confrontation have been withdrawn, the two countries announced on Sunday.

The plan going forward is to split up over 150 proposed Chinese investments into three categories depending on the risk to national security, the sources said.

Sectors such as automobiles, electronics, chemicals, and textiles are seen as non-sensitive whereas those involving data and finance are deemed sensitive, consultants and lawyers have said. Proposals from nonsensitive sectors will be approved faster, while those seen as "sensitive" will be reviewed later, one of the government sources said.

'Metro Man' E Sreedharan backs PM Modi, says 'it is now a fashion to oppose whatever BJP does'



New Delhi: It has become a fashion to oppose whatever the Modi government is doing, BJP-bound technocrat E Sreedharan said on Friday as he strongly supported the contentious new farm laws and asserted that there is no "intolerance" in the country.

He also said any attempt to malign the government before a foreign dispensation or medium can't be called "freedom of expression" as that would tantamount to "war against the establishment" and this constitutional right has to be controlled if it is misused against our own country.

Hailing from Kerala, the 88-year-old technocrat said that he wants to do things for the benefit of the state and those can be done by entering politics. He said his main aim is to help the BJP come to power in Kerala where the assembly polls are due in April-May this year.

Sreedharan said that he has known Prime Minister Narendra Modi for several years. When Modi was the Chief Minister of Gujarat, he had worked on various projects in the state. "I know him (Modi) from very close quarters. He is very upright, corruption-free, committed, very passionate about the country's interests, very hardworking, and very forward-looking," he added.

In an interview, he said the debate on nationalism that is happening is unfortunate and that there are "so many petty parties" that are all against the BJP and a combined attack is going on against it for no

"That is why all these things are happening. The government is so forwardlooking and dynamic, If they join (support) the (central) government, things will be so different for India and the world.

"Unfortunately, some of our friends in opposite parties are working against the interests of the country," he said. On the ongoing farmer protests against the Centre's new farm laws, Sreedharan opined that farmers might not have understood the benefits of these legislations.

When asked whether the protests could be seen as a kind of situation where it is about industry versus farmers, he replied in the negative and said, "It has nothing to do with the industry unless we are dragging industry into it."

"It is that either farmer has not understood or they don't want to understand for political reasons. It has become a fashion in this country that whatever the (central) government does, oppose it..... Anything that the government wants to do, there is an opposition, unfortunately," Sreedharan, better known as the 'Metroman' said

He was instrumental in developing the Delhi Metro Rail project apart from various other infrastructure projects. Ruling out the possibility of him acting as a mediator between the central government and the protesting farmers, Sreedharan said the issues have to be sorted out by the government. "They have to educate the farmers and tell them that it is in their interest. If this is not done, what is going to happen to them. They (protesting farmers) don't realize what will happen five years down the line," he noted.

To a query on whether he is optimistic about a constructive solution to the ongoing protests which have been going on for a few months now, he said the protests are not being dragged on by farmers really but "dragged on by elements opposed to the central

government". About debates nationalism intolerance, Sreedharan wondered where intolerance? and that all such things are only in talks. When asked about his views on the debate on freedom of expression, Sreedharan said it is a right in the Constitution but if the freedom of expression is misused against the country, then certainly that has to be controlled. "If you go to a foreign government or medium and complain about all sorts of things about the government and convince them that the government is wrong, then that is a wrong thing. This is not freedom of expression. This is sort of a war against establishment. government. This is how Hitler also started...Giving false opinion that this is | freedom of expression and misled people," he said.

China supports India hosting the BRICS 2021 summit

India took over the BRICS leadership comes at a sensitive time as New Delhi's ties with Beijing are facing their worst challenges in decades.

Beijing: China on Monday said it supports India hosting this year's BRICS summit and will work with New Delhi to strengthen the bloc, allaying concerns that the India-China border dispute will impact the forum.

India assumed the rotating chairmanship of the five-member summit, comprised of Brazil, Russia, India, China, and South Africa on January 1, taking over from Russia, which hosted the last summit as an online event in November because of the Covid-19 pandemic.

India taking over the BRICS leadership, for the third time since the group was formed, comes at a sensitive time as New Delhi's ties with Beijing are facing their worst challenges in decades. It's only after nine months and several rounds of negotiations that border troops have disengaged from the south and north banks of Pangong Lake.

"We support India in hosting this year's meeting. We will work with it and other members to strengthen communication and dialogue and consolidate the three-pillar cooperation, expand BRICS plus cooperation and work for greater progress under BRICS," the foreign ministry spokesperson Wang Wenbin said when asked whether the India-China border dispute will impact

The "three pillars" Wang referred to are policy and security; economy and finance; and culture and people-to-people exchanges.

China will "also help the world to defeat Covid-19, resume economic growth and improve global governance," Wang further added.

Wang said that BRICS is a cooperation mechanism of global influence consisting of emerging economies and developing countries which "in recent years it has seen greater solidarity, deeper practical cooperation, and a greater influence".

It is now a positive, stable, and constructive force


in international affairs," he

"China attaches importance to this mechanism, and we are committed to deepening strategic partnership within it to consolidate solidarity and cooperation," Wang said.

He did not respond to the question of whether President Xi Jinping will attend the BRICS summit in India.

In his address during the last summit, Prime Minister Narendra Modi said that India would focus on improving cooperation within the bloc.

"During our presidency in 2021, we will try enhancing intra-BRICS cooperation by strengthening all the three



pillars. We will endeavor to enhance intra-BRICS solidarity and develop a solid institutional framework for this purpose," Modi said.

In December, China complimented India for hosting the Council of Heads of Government of the Shanghai Cooperation Organisation (SCO) in late November, saying all member

states spoke highly of the conference's outcomes. It was first-time India had hosted the SCO Council of Heads of Government after it joined the eight-member grouping in 2017. Chinese Premier Li Keqiang on Monday attended the virtual meeting of the bloc which was also addressed by Vice-President Venkaiah Naidu.

Biban arrested for gangrape that tolled the chair of a CM 22 years ago



Bhubaneswar : An unexpected encounter inside a jail, a crucial mistake spotted in records, an elaborate threemonth intelligence operation in an Odisha village, suspicious bank transfers - and a last-minute escape bid.

These are the key turning points on the trail that led a police team from Bhubaneswar to Lonavala in Maharashtra last weekend and finally to the prime accused in a rape case that had rocked Odisha in 1999 and led to the resignation of then Chief Minister J B Patnaik.

On Monday, Odisha Police formally recorded the arrest of Bibekananda Biswal alias Biban, 50, in Bhubaneswar after bringing him from Aamby Valley where he was working as a plumber earning Rs 17,000 a month and holding an Aadhaar card in the name of "Jalandhar Swain".

"He was identified as Biban by multiple sources, including his family. Following identification, Biban was formally arrested and handed over to the CBI for further investigation," said Dr Sudhanshu Sarangi, Police C o m m i s s i o n e r , Bhubaneshwar-Cuttack.

But not without a few last-minute jitters, said an officer in Lonavala. At the workers' barracks in Aamby Valley, Biban tried to mislead a joint police team, including officers from Maharashtra, by claiming that he did not have a cellphone, and pointed to the wrong bed fearing a search when cornered, he even tried to flee. "He was immediately apprehended again," said the officer.

last November as part of a probe into an armed dacoity of Rs 12 crore from IIFL, a leading non-banking finance company. "I wanted to show the inmates some pictures of the accused in the dacoity case from a CCTV camera. That was when I came across one of the co-accused in the 1999 rape case, Dhirendra Mohanty. The jailer informed me that he was one of the oldest inmates, serving a life term. When we looked at the case file, we learned that the main accused was still absconding," Sarangi said.

That was the beginning of Operation Silent Viper, led by Sarangi and involving three other officers: Deputy Commissioner of Police, Cuttack; Special Squad Inspector, Cuttack; and Inspector In-charge, Baranga police station.

The case was particularly sensitive, police sources said, because of the impact it had on the state's politics at the time. The victim had accused Patnaik and former advocate general Indrajit Ray of having played a role in the incident

to intimidate her. Two years earlier, in July 1997, she had accused Ray of attempting to molest her and the Chief Minister of shielding him. In 2000, a CBI court sentenced Ray to three years rigorous imprisonment, charging him with attempted rape.

In the Baranga case, two of the accused, Mohanty and Pradip Sahu, were arrested 17 days after the incident while Biban managed to escape. In February last year, Sahu died while undergoing treatment for chest pain at a Bhubaneswar hospital. "In all the case documents. Biban was referred to as 'VK'. But while interacting with Dhirendra during our meeting in jail, he informed us that it was actually 'BK' for Baranga King," Sarangi said.

That was the first break. The next step, an officer said, was to mobilise a network in Baranga, the area where Biban hails from, and gather information discreetly about his family. "We suspected that the family could have been in touch with him," another officer said. Soon, the police

came to know that Biban's wife was trying to sell a piece of land that belonged to him and had applied for a death certificate to facilitate the sale. And, a closer look at the family's finances led them to believe that they had access to another source of income.

"Biban has a wife and two sons, with the elder son married. We learned that none of the sons had a regular source of income or job and yet, there was a constant flow of financial support. This strengthened our suspicion that the family was in touch with Biban," Sarangi said.

The team then zeroed in on the family's bank details and found cash transfers of amounts ranging from Rs 5,000 to Rs 25,000 to the account of Biban's elder son.

"We activated a network in Pune to learn more about Swain. As per his Aadhaar card, he was a native of Naranpur village in Baranga, which is where Biban's home is located. It identified his father's name as 'P Swain', and the initial matched the name of Biban's father, Purnanda Biswal. Finally, we confirmed that there was no person named Jalandhar Swain in the village," an officer said. On Friday, a three-member team from Odisha reached Mumbai, and a joint coordination meeting was held at the regional office of Pune Rural police in Lonavala. "We provided them local support

and information," said DySP Lonavala, Navneet Kanwat.

Dressed in plainclothes, the joint team reached Aamby Valley on Saturday and found the name "Jalandhar Swain" after a three-hour search of employee records. They took the help of another worker from Odisha to locate the barracks where they found Biban and started questioning him.

"We said it was a routine procedure and asked for his phone. He said he did not have one. When we asked him to point to his bed, he pointed to the wrong one where we found a phone that was not working. Then, we asked another employee to call his number and found the phone ringing from another bed. We brought him to a company office around the evening. While the team was preparing to leave, he tried to run out of the room," said an officer.

Workers at the site described Biban as a "secretive person" who "avoided being photographed" and "changed his appearance at least twice". "Once he grew his hair and kept a beard. Another time, he kept short hair and was cleanshaven," said a worker.

Supervisors said workers from Odisha started coming to the site in groups about 10-12 years ago. "He (Biban) used to work earlier on general maintenance jobs. He took up plumbing around six years ago," said a worker.

Odisha's "Looteri Dulhan" arrested for marrying and duping multiple men

Bhawanipatna: A 32year-old woman of Odisha's Sundargarh district has been arrested by police in Kalahandi district on charges of marrying multiple men and duping Kalahandi them. superintendent of police Dr Vivek M Saravana said the police arrested Elee Mahanta of Sundargarh district following complaints that she married at least three men after the death of her husband.

"She assumed multiple names after the death of her husband Kumudbandhu Patel in 2011. She then prepared an Aadhaar card in the name of Sindhumati Munda in September 2013 and married a person named Rajendra Das the same month. After the marriage, she visited her relatives at village Sarangarh of Chhatisgarh where she met a 51-year-old woman named Manju alias Mina Gupta who taught her how to cheat people in the name of marriage," said Saravana.

A few years later, she divorced Das and got a new Aadhaar card in the name of Elee Mahanta in May 2018. She again married another person.

In June 2020, she again got a new Aadhar card made in the name of Mamata Agarwal and married a man called Bikash Jain of Kalahandi district in October. "Her associate, Birbal Sharma, played the role of a mediator in the marriage and took ?4 lakh from Bikash's family members as his mediation fees. The gang also arranged a visit of the groom's family to Sundargarh and made it look like as if she belonged to some Marwari family," said the SP.

Police said the modus operandi of the gang was to

target elderly or divorced men. "While Elee used to be the prospective bride, the three others used to act as her mother, father, and uncle. They used to share the loot. When we raided the place, we found all of them there," said the SP.

The investigating officer of the case, Binita Toppo, said from the preliminary investigation it has been found that the woman married four times. "We suspect the number may rise further. Many people, who were cheated by them, are not approaching us fearing social stigma. We urge them

to register a complaint," said Toppo.

Apart from Mahant, others who were arrested include Birbal Sharma (60), Manju alias Mina Gupta (51), and Sraban Soni (36).

Police officials said the case seemed to be straight out of Sonam Kapoor-starrer 2015 Bollywood movie 'Dolly ki Doli' wherein Dolly, a young con artist, marries men from different religions and runs away with their wealth on



the night of the wedding. Her entire family consisted of con artists. After conning several rich men, she gets media attention and labels her as "Looteri Dulhan".

The BJPs game plan to breach Congress citadel in Puducherry

Puducherry, Feb 23: On Monday, the V Narayanasamy government in Puducherry, the only Congress government in the South, lost power following a spate of resignations of party MLAs over the past month. Before tendering his resignation, Narayanasamy blamed the fall of his government on the games played by the BJP.

But what does the BJP stand to gain in a Union Territory where it is yet to establish deep roots and has only three nominated MLAs in the Assembly?

And why has the BJP, which is in alliance with the N R Congress and the AIADMK, allowed this drama to unfold almost on the eve of scheduled Assembly elections?

Sources in the BJP say the party has reasons to be pleased about the developments in Puducherry. FIRST, the BJP, which



had declared its intentions of having a Congress-mukt Bharat when it came to power, has been on a mission to show the Congress and its leadership in a poor light as possible.

The opposition party's losses - be it in Madhya Pradesh, Goa, Manipur, or Arunachal Pradesh - has reinforced the image of the Congress as a "party that cannot rule or hold its people together", and that "its ideology is no

longer relevant for the country", BJP leaders said.

"What happened in Puducherry is just an add-on. Not that the BJP is going to form a government immediately, but it just reinforced the national narrative the BJP has been building," said a senior BJP leader who is familiar with the party's functioning in Tamil Nadu and Puducherry. "Since it happened just ahead of the Assembly election, no one can say that the BJP was hungry for power. Rather, the focus will be on the

Congress's failure, and its leadership's inability to retain power," the leader added.

SECOND, according to this leader, "whatever be the outcome of the elections, it will be a gain for the BJP". Of the five MLAs who resigned from the Congress, three have already joined the BJP. Others are also expected to follow, or they could contest as Independents, party sources said.

"This will further weaken the Congress in the state, and it might strengthen its ally DMK as well. It makes the chances of a Congress government bleak," said a source.

THIRD, BJP leaders said the party had been in touch with the disgruntled Congress MLAs for long - as the Narayanasamy government weakened, and the Congress leadership failed to intervene in Puducherry. They could have brought down the

government at any time, claimed a BJP leader - however, the move was finally made on the eve of elections so that the rebels could keep their supporters enthused as they contested again

"When a rebellion happens just ahead of elections, capitalising on the angst is easier," a BJP leader said.

A Namassivayan, who resigned as PWD Minister and joined the BJP, has considerable political influence in his Villianur constituency and surrounding areas. Such leaders can draw votes for the BJP in their areas, party leaders said.

FOURTH, BJP leaders said any move to destabilise the Congress government while Kiran Bedi was Lieutenant Governor could have hurt the image of both the BJP and the central government, due to the long-

drawn-out battle between her and Chief Minister Narayanasamy.

"By removing Bedi from the post, we have controlled the damage. If this had happened while Bedi was there, the party and the central government would have been blamed," a BJP office-bearer said.

FIFTH, it isn't just Bedi's removal - her replacement too, was part of the BJP's plan, according to party leaders. Making Tamilisai Soundararajan L-G has not only helped the party avoid criticism but having a Tamilian in the post is also expected to boost the BJP in terms of perception.

BJP leaders, however, conceded that efforts to put together a new government at this stage could create sympathy for Narayanasamy. The party remains undecided over the NR Congress demand for a new government in the state.

Toll collection reaches Rs.102 crores, on the first day of mandatory FASTag

FASTag is an electronic toll payment system that has been implemented across the national highways in the country since February 16.

New Delhi : The countywide rollout of FASTags to encourage digital payments at toll plazas has reached 23.2 per cent, the National Highways Authority of India (NHAI) announced on Saturday.In a tweet, the NHAI said that the total number of the transaction has crossed 63 lakh. It also said that toll collection though FASTAg has reached ?102 crores per day. Toll collection through FASTag sees a jump of 23.2% in just 4 days crossing the ?100 Cr mark on 19th Feb. Total no. of transaction crosses 63 lacks.

To facilitate the adoption

of FASTag, the NHAI has also launched a 'Free FASTag' campaign till March 1 by waiving the tag cost of ?100 over 770 toll plazas.FASTag is an electronic toll payment system that has been implemented across the national highways in the country since February 16. The system works through a unique code for every vehicle enabling digital payment of the toll tax when the vehicle crosses the sensors attached at the toll plazas.

The ministry of road and surface transport issued a notification which said that



any vehicle not fitted with FASTag or vehicle without valid, functional FASTag will pay a fee equivalent to two times the fee applicable to that category. In five days since its implementation, the 100 per cent cashless tolling at national highways has been positively received by commuters, the NHAI said. The government

body has also added a new feature called 'Check Balance Status' in the 'My FASTag App' which can be downloaded from Google Play and Apple's app stores."The My FASTag App will show FASTag wallet balance status in form of color codes i.e. Green for Active tag with sufficient balance, Orange/

Amber for tags with a low balance, and Red for Blacklisted tags," an NHAI statement said. After the mandatory FASTag, the too collection has reached ?102 crores per day, which means the annual collection would be over ?36500 crores per year. During his address, Prasad said that every social media platform was "welcome" in India but added that there should not be "double standards"

"If an attack takes place on Capitol Hill, then SM supports police action but if there's an aggressive attack on Red Fort, then you've double standards. This is not acceptable," he said.

He also said that social media platforms should have provision for a "voluntary verification mechanism of the users"

'3-stair mechanism for OTT platforms'

I&B Minister Prakash Javadekar spoke about the mechanism for OTT latforms.

"We have decided to have a 3-stair mechanism for OTT platforms. OTT and digital news media will have to disclose their details. We are not mandating registration, we are seeking information," he said

"There should be a grievance redressal system in OTT platforms and digital portals. OTT platforms will have to have a self-regulating body, headed by retired Supreme Court or High Court judge or very eminent person in this category"

Javadekar made a case for self-classification of content on OTT platforms

"For OTT, there should be self-classification of content -- 13+, 16+ and A categories. There has to be a mechanism of parental lock and ensuring compliance that children don't see that," he said.
