storm surge resilient embankments," he added.

Yaas, a severe cyclonic storm, had hit the eastern coast on Wednesday. While no major damages were reported from the state, four people were reportedly killed in incidents induced by the cyclone.

Bhubaneswar: The state administration has a tough task at hand because the COVID spread has not slowed down despite weeks of lockdown.

The Odisha government is in an unenviable position. As if battling the COVID-19 surge was not enough, it now has to deal with the aftermath of a cyclone that battered parts of the state on Wednesday.

More than half a million people had to be evacuated to cyclone shelters so that they could be protected from nature's fury. While it worked, Yaas has left in its trail scores of villages inundated by the tidal surge, with power and communication hit. As the government gets down to post-cyclone assessment and restoration work, Chief Minister Naveen Patnaik undertook an aerial survey of the affected zones on

Thursday. Prime Minister Narendra Modi too as scheduled hasto fly in to take stock of the situation on Friday.

Odisha has always been a favourite hunting ground for tropical cyclones. It was left in tatters when Fanipummelled the coastal districts in 2019. Last year, it had a close shave with Amphan. However, with Yaas, it has found itself between the proverbial devil and the deep sea. Post-cyclone reconstruction must be taken up, but the natural disaster has only exposed people, administration, and large relief and rescue workforce to the virus risk across (Page-7)

ASHA Workers To Be Incentivised

Bhubaneswar: Following the announcement made by Chief Minister Naveen Patnaik to incentivize ASHA workers for effective management of COVID surveillance in rural areas, the Odisha government on Wednesday directed the district Collectors to provide Rs 10,000 as financial assistance to them under 'Swasthya Sahaya'.

In a letter issued by the Health and Family Welfare Department, ACS PK Mohapatra wrote that the money can be used for various activities towards COVID management and non-covid essential healthcare services in rural areas and urban slums.

"As per the announcement made by the Chief Minister, Odisha on May 17, 2021, it has been decided to provide one-time



assistance of Rs 10,000 each to ASHA workers under Swasthya Sahaya (State Budget) to enable them to undertake various activities for effective management of Covid and facilitating non-Covid essential healthcare services at the community level both in rural areas and urban slums," read the letter.

The ASHA workers can utilize the assistance amount on any/ all of the following heads:

- Purchase of bi-cycle (if not purchased earlier or damaged)
- Umbrella, torch, chappal, water bottle carry

Following the announcement made by Chief Minister Naveen Patnaik to incentivize ASHA workers for effective management of COVID surveillance in rural areas, the Odisha government on Wednesday directed the district Collectors to provide Rs 10,000 as financial assistance to them under 'Swasthya Sahaya'.

- Mask, sanitizer, soaps, gloves, face shield, thermal scanner, helmet
- Mini battery operated
- Conveyance (POL/repairing of the cycle)

Requesting to release the incentive amount of Rs 10000 to each ASHA out of available funds under in ZSS-Misc A/c which will be recouped after receipt of funds under Swasthya Sahay, the department urged the Collectors to pay the amount based on self-certification in

the prescribed format duly signed by ASHA, mentioning that she has utilized the assistance amount towards any/all of the above said purpose.

While attending an all-party meeting on COVID management on May 17, the Chief Minister had announced a three-month door-to-door COVID surveillance to be undertaken by ASHA workers in rural areas and urban slums for which they will be incentivized.

Man Arrested For Selling 'Passes' In Bhubaneswar During Lockdown

Bhubaneswar: The Commissionerate Police on Tuesday arrested a man who was allegedly making fake passes and selling them to people who wanted to move around the city without any hassles during lockdown at a throwaway price.

The accused allegedly admitted to having prepared some passes and sold them to people for Rs 50 each. Many such fake passes have also been seized.

The alleged counterfeiter lives in the Damana area under the Chandrasekharpur police limits in the city, where he was carrying out such illegal



activities, police said.

Acting on a tip-off, a team of officials from Chandrasekharpur police station carried out raids at the house and caught the accused red-handed when he was preparing the passes using logos and graphics of different companies. The police team arrested him and his questioning is on at the police station.

The accused allegedly admitted to having prepared some passes and sold them to people for Rs 50 each. Many such fake passes have also been seized, police said.

He will be produced before a local court today for remand, police sources said.

Notably, police had earlier allowed the movement of employees of private organizations on the production of Identity cards. Later, some violators were found misusing their company Icards and move around the city without any genuine work.

Later, the police issued emergency passes to the employees of the various organization to facilitate hassle-free movement and check misuse of company identity cards.

The police had also launched an e-pass system yesterday to facilitate the smooth conduct of some social and cultural activities like marriage, death rituals, and thread ceremonies.

Even as the government has issued instructions to police to enforce the lockdown restrictions strictly to check the mounting trend of Covid-19 cases, some violators are giving open challenges to police administration in the Capital city by flouting the restrictions. This has also posed serious threats to public health and safety.

Multiple Taxes, unemployment, a high 10.49 percent wholesale price index(WPI) rise and severe income losses are thawing the nation amid high covid19deaths. The six-month high WPI figures in April would be straining the economy. The actual price rise at the retail level would be a minimum of 10.49 percent plus 4.29percent CPI inflation, not less than 14.78 percent. The super inflation in 1974 wasat 28.66 percent, and 16.94 percent in 1973. Those days purchasing power of thepeople had collapsed and protests marked the national scenario. It may not lookserious but if income losses of 84 percent of the people are added it appears grim. As per a study of the Azim Premji University study, the

pandemic has led to a worsening in quality of employment, with several salaried employees joiningthe ranks of precariously self-employed. The annual rate of inflation in April 2021, is high because primarily ofrising in prices of crude petroleum, petrol, diesel, manufactured products as compared to corresponding month of the previous year,"theCommerce and Industry Ministry (CIM)

As the most rise in prices, fares, freight is due to the CIM stated factors, the economy is slowing down, indicating a lower GDP as well. It is beingfurther complicated by rising joblessness at 8 percent in April amid thesecond covid19 wave from 7.4 percent in March

2021. A CMIE study -Consumer Pyramids Household Survey (CPHS) observes weeklyunemployment rate touched 14.5 percent on May 15. Cyclone shelters become unsafe, need urgent maintenance and repairing



Jagatsinghpur: Two decades ago super cyclone 1999, perhaps as one of the most ravaging natural disasters that had experienced Jagatsinghpur district, resulted in huge loss of human lives, properties, houses, road communication systems, and many more.

Both union and state governments had come forward obviating victim's woes as result different postcyclone restoration works had undertaken across the district. There is no denying the fact post-cyclone restoration and rebuilding works had progressed up and down, few projects had been completed successfully, but lack of sincere follow-up measures by government agencies, have come to dire state draws criticism from public domain till date. The glaring instance anyone can find looking cyclone shelters and school buildings constructed aftermath super cyclone in Jagatsinghpur.

The report said that about all schools in the Jagatsinghpur district were either damaged or razed to the ground in the past devastating super cyclone 1999 most of them have been rebuilt and repaired. Government agencies, several NGOs, and many public undertaking companies had undertaken such new construction and repair works as a result thousands of schools were repaired.but due to lack of yearly maintenance, most of the buildings bear dilapidated conditions and become unsafe for use

Government authorities are unable to provide adequate funds over the yearly maintenance works, meanwhile, the donor NGOs, public companies after completing the construction have escaped from liability of looking after the structures after handing it over to the authorities.

Official reports indicate that nearly 801 OBB school buildings have been constructed in Jagatsinghpur district by spending about Rs 16 crore, followed by as many as 972 primary schools, 192 high schools have been constructed and repaired after the super cyclone. Besides under cyclone shelter cum school building scheme

Paradeep Port trust and Paradeep phosphates limited had undertaken to build 181 school buildings from the Prime minister Relief funds [PMRF] each costing Rs 3.50 Lakh including 30 buildings had built in 4 blocks by National project Construction Corporation under PMRF.

Under the chief minister relief fund, nearly 8 school buildings and cyclone shelters had been constructed for Rs 10 Lakh each. Moreover,the Maharastra government who adopted Jagatsinghpur district after the super cyclone has constructed about 52 schools cum cyclone shelters by cost Rs 18 Lakh to 20 Lakh each

Initially, Dasheri, Amrapalli, Sundari, Gopal Bhog, Lengda, and Bombay Green earned Rs. 30 lakh onwards.

With more than 500 farmers members in the group that had earned Rs. 16 lakh by supplying 83 tonnes of mango to Mother Dairy at New Delhi, Bokaro Fruits and Vegetable Cooperative Society in Jharkhand. 

Farmers yet to get compensation for losing land due to rampant sand lifting

Baripada (SukantaSahu): Excess and illegal sand lifting in Budhabalanga river bed triggered resentment among people Badasahi tehsil in the Mayurbhanj district. The villagers of Arapata revenue village consist of Ward No-7, 8 and 9 of over the population of around 1000 had blamed to tehsildar of Badasahi who approved a lease to lift 2,900 cubic meters instead of 2,400 cubic meters to a leaseholder Pradeep Kumar Bindhani from 2016-17 for 5 years which completely violates mining rule, following which there wasthe erosion of the land at both sides of the river consequently farmers lost their lands. The interesting story is the leaseholder does not pay the royalty to tehsil for approving the excess of 5 cubic meter sand mining which government has lost crores of rupees of revenue. The officers from top to bottom are allegedly involved in the illegal sand mining racket.

The regular plying of dumpers, JCB and thousands of sand loading tractors roundthe-clock is leading to damage a village road and it is not repaired by either contractor or by concerned department as there is mining provision that at least



farmers in the locality. Due to the nexus of officials and leaseholders, tehsildar had approved the lease tender where 2,900 cum approved instead of 2400 cum that violated the mining rule and crore of rupees the revenue department is losing for excess and illegal lifting sand from the river bed. However the leaseholder had no power to provide power of attorney to other persons to lift sand from the river bed beyond the mining rule. The excess sand lifting from the beds had affected farming activities, it is alleged that despite full knowledge of tehsildar and sub-collector no action was taken to check the rampant illegal sand lifting from the river bed.

In case emergency, ambulance is reached to the village to take patients to the nearest hospital due to bad road conditions. "An ex-Sarpanch repeatedly brought the issue before tehsildar, BDO of Badasahi, subcollector of Baripada and Collector to repair the village road at least being roughed by plying of sand loading vehicle but not a single officer is made any attempt to repair of the damaged road. Farmer Ranjan Kumar Patra said that 2 acres of his farming land are eroded by the river due to excess sand lifting by mafias and leaseholders. "I used to manage my family by farming on my land but now I am unable to both ends as no farming land is left me to do the farming activity." Another affected farmer VimsenNaik ward no-9

of BadasahiGaneswar Patra assuring the affected farmers to get compensation as their lands were affected and road repair will carry out from time to time if it will be turned to damage despite he is+ paying tax to tehsil.

When contacted SanatanBijuli the MLA of Badasahi said that he was sitting on a strike in front of Badasahi police station for five days and demanded a check of illegal sand mining but no step has been taken yet.

When contacted, Collector Vineet Bhardwaj said that he will order an inquiry into the matter. If the leaseholder will not pay the royalty of 500 cubic meters of sand will be charged to him to despite besides tehsildar had been ordered to provide compensation to victim farmers and necessary action would be taken against persons who rampantly lift sand at said that the ex-MLA the river bed illegally.

Nepal President Bidya Devi Bhandari dissolves parliament



Kathmandu: Nepal plunged into fresh political turmoil on Saturday as President Bidya Devi Bhandari, dissolved parliament and fixed general elections in November amid worsening COVID-19 outbreak. The surprise announcement comes after a presidential statement said neither the caretaker Prime Minister KP Sharma Oli, nor opposition leader Sher Bahadur Deubawas able to demonstrate a majority to form a new government by the Friday deadline set by Bhandari.


"The president has dissolved the House of Representatives and ordered the first phase of general elections on November 12 and the second phase on November 19," a presidential statement issued after midnight said.

It said the decision was made on the recommendation of the cabinet headed by caretaker Prime Minister Oli, whose December 2020 dissolution of parliament sparked weeks of protests and was reversed by the Supreme Court as unconstitutional in February.

There was no immediate comment from political parties about the latest move.

Nepal is battling a deadly second wave of the pandemic and is reporting 8,207 new infections on average each day.

A Bridge Too Far



After limited success in Bengal, BJP is bound to target Odisha to achieve its east coast goals

The Bjp's aspiration to set foot on the East coast looks like 'A Bridgetoo far.' The just-concluded Bengal polls become an indication of that. However, the saffron party had the luxury to become an ally of governance in Odisha for a short spell of five years from 1999 to 2004. In 2021, the BJP in full throttle moved to the Bengal fray but had to contend with a second spot. Another state is Tamil Nadu that has already slipped for another five years. Odisha and Andhra are the two states to come to the polls in 2024 along with the general elections. Hence, the BJP can't go with full vigour as it will be facing the general elections across the country. However, among these two

states, Odisha may be a preferred target for the BJP as it is now the main opposition after replacing Congress and it registers a visible presence across the state.

Therefore, the BJP may shift its focus to Odisha where it has, however, failed three times to make a dent in the bastion of the Naveen Patnaik-led Biju Janata Dal (BJD) government in the last three general elections. There are several factors the BJP should not ignore, as to why the story in Odisha cannot be the same as that of West Bengal. In Bengal, the saffron party, despite not being able to prevent Mamata Baneriee's return to power, has considerably improved their presence, from 3 seats in the Assembly to 77. This is a colossal improvement, which has helped it become the main

opposition in Bengal, and the significance of its gains is also likely to weigh on the ruling TMC.

But here in Odisha, if Naveen Patnaik succeeds in camouflaging government's drawbacks and highlighting his successes, then the BJP may again have to bank heavily on the Congress vote bank in the eastern state. As far as Odisha is concerned, its chief minister is well versed in the saffron ideology and not alien to the BJP's strategic prowess. During the 2014 general elections, Odisha witnessed a campaign by the BJP that was a blitzkrieg, with its principal strategist Amit Shah going hammer and tongs to unnerve the BJD. Shah's barb, that the Naveen Patnaik government is like a "burnt transformer and is required to be thrown into Bay of Bengal,"

continues to echo in Odisha's political circles.

There is a marked difference, however, in how Naveen Patnaik and Mamata Banerjee react to barbs thrown at them by opposition parties in their respective states. Since the start of his political career 21 years ago, Naveen Patnaik has never reacted in a volatile manner nor has he used strong or melodramatic language. He barely reacted Shah's "burnt transformer" jibe. Patnaik always turned a deaf ear to jeers and proved his detractors wrong by his developmental fact sheet. This is, however, not the case with Mamata Banerjee. Unlike Mamata Banerjee, Naveen Patnaik has always managed to stay poised and keep his cool.

A prolonged silence interspersed with occasional smiles through the windshield was the image of 76-year-old Naveen Patnaik, who undertook a bus journey of over five to six thousand kilometers during the 2019 general election campaigns, taking on the BJP headfirst. There is also no doubt that during the 2020 COVID-19 pandemic,

Naveen Patnaik did much to contain the spread and prevent it from becoming uncontrollable, unlike many other states which crumbled even then. However, the second COVID wave has changed things a bit. The Odisha government's image currently has suffered a dent, with a 10 to 23 percent infection rate, and the death toll climbing. Naveen's extraordinary disaster management of the cyclone 'Yaas' will certainly compensate for the loss.

Seeking a mandate for the sixth consecutive terms may be difficult for Naveen Patnaik and several factors will come into play that the BJD must be cognisant of. Anti-incumbency is a major factor that should worry Naveen, and it remains to be seen if he has any other tactics in his political armor to counter the saffron surge in Odisha. What often worries political analysts is the absence of a succession plan in the BJD. But no turncoat from the BJD has been able to prove their worth without the 'Naveen

The BJP is likely to scratch some old wounds to ensure BJD's turning back to

the wall. The BJP must be practical according to its homework to claim the number of seats to win; in 2019 it declared to win 120 plus in Odisha, and in Bengal, in 2021 the claim was 200 plus which makes the public perception nothing but a laughing stock. Most importantly, the BJP has to cement the crack of factionalism in the state unit.

There are two things that the BJP in Odisha to note. First, it has refused to go full throttle against the BJD, as it did against the TMC in West Bengal. Instead, it has chosen to play footsie with the ruling party since the 2019 elections, inevitably inviting charges of 'foes in Bhubaneswar, friends in Delhi'. The party must realize that this 'running with the hare, hunting with the hounds' strategy is not going to take it anywhere. Second, it must stop banking recruits from disenchanted leaders from other parties and build its | organizational strength in the state, which alone would enable it to fight the welloiled BJD organizational machinery and its superefficient election management.

PM Modi's Special Concern For Odisha: Prompt & Proactive

Bhubaneswar: In his seven years of assuming the chair of Prime Minister, Narendra Modi's visit to the State in the aftermath of a major disaster will be his third but it will probably go down as the one which demonstrates his soft corner for the State like none of his other predecessors had for the eastern Indian state of Odisha.

Even though the PM has toured the State on multiple occasions, experts

and common man alike recall that such attention towards the State, just a day after the very severe cyclonic storm Yaas ripped through the State causing massive destruction, shows the special place PM Modi has for Odisha and the people of the State.

It was in May last year when India was battling the first wave of Covid pandemic and no picture of any vaccine insight, when nature struck with super ferocity with a tropical cyclone, probably the strongest the country's eastern coast had faced since two decades ago, the Prime Minister turned his attention fast towards Odisha where the storm had brushed along causing major damages before wreaking havoc in Bengal.

On Friday (May 28, 2021) too, he conducted an aerial survey of the cyclone Yaas-hit areas of the State and announced Rs 1000 crore financial assistance for immediate



relief activities. Besides, he announced an ex-gratia of Rs 2 lakh to the next of kin of the deceased and Rs 50,000 to the seriously injured in the cyclone and also appreciated the preparedness and disaster

management activities by the government of Odisha which resulted in minimal loss of lives.

Secularism; An Ado Of Squabbles

During a debate about granting independence to India the then British PM Churchill said; "Power will go to the hands of rascals, rogues, freebooters; all Indian leaders will be of low calibre & men of straw. They will have sweet tongues and silly hearts. They will fight amongst themselves for power and India will be lost in political squabbles. A day would come when even air and water would be taxed in India." With the advent of political development in India, I can't but be forced to realize the justification of the jibe. In the just-concluded Bengal polls, the Left parties along with Congress allied with the Indian secular force, an outfit floated by Abbas Siddiqui, a Muslim cleric of Hooghly district's Furfura Sharif. The CPI (M) has contended thatthe fledgling party is different from fundamentalist communal forces. Hence, the alliance will strengthen the secular force to fight communal BJP.Waw!

On November 15, 1948, when the newly independent dominion of India was in the midst of a heated debate in the Constituent Assembly, on the nature of the Constitution, Prof K T Shah made an intervention demanding the inclusion of the word 'secular' in the preamble. "Sir, I beg to move, that in clause (1) of Article 1, after the words 'shall be a' the word 'Secular' be included. The amended article or clause shall read as follows: 'India shall be a Secular, Federalist, Socialist, Union of

States'," he said. In the ensuing discourse, while the members agreed on the nature of the Indian state adhering to secular principles, the word 'secular' was dropped from the preamble.Ambedkar and Nehru realized the problem in incorporating 'secular'. Firstthe Muslim personal law can't be included in the constitution once 'secular' is taken therein. But, it made an appearance though, about three decades later, when during the emergency the Indira Gandhiled government included it in the document, as part of the 42nd Amendment of the constitution.

The word 'secular' is

known to have originated in late medieval Europe. Secularism, the theory that governments ought to have no religious connection, nor indeed anything to do with matters of religious belief or ritual, is manifestly a Western intervention, specifically a product of the Protestant Reformation and the Enlightenment. The majority of the makers of modern India, shaped as they were, by European thoughts and practices, were ardent supporters of secularism as well. Foremost among them was the first prime minister of the country Jawaharlal Nehru. For him, having a secular state was a crucial mark of modernity.Ironically though, it was Nehru along with the chairman of the drafting committee of the constitution, B R Ambedkar, who were also most opposed to the idea of including the word 'secular' in the preamble of the constitution. A closer examination needed of the circumstances in which the constitution of India was produced, and later of the time in which the word 'secular', the mother of all political squabbles went on to be



included in the preamble.

When the preamble to the Constitution was discussed in the Constituent Assembly, debate over the incorporation of secularism took up a large portion of time. All the members agreed, of course, on the necessity of establishing a secular state. Most shared an understanding of history in which the movement for the separation of religion and state was irrevocably a part of the project for democratization of the latter. The connection between secularism and the effective functioning of democracy had been well established in Europe, and since India was to follow the ideals of democracy, secularism was deemed essential.

"I accepted this secularism in the sense that our State shall remain unconcerned with religion, and I thought that the secular State of partitioned India was the maximum of the generosity of a Hindu dominated territory for its non-Hindu population. I did not, of course, know what exactly this secularism meant and how far the State intends to cover the life and manners

of our people. To my mind, cannot compartmentalized and yet I reconciled myself to the new cry," said LokanathMisra in the debate on December 6, 1948. "Do we really believe that religion can be divorced from life, or is it our belief that amid many religions we cannot decide which one to accept? If religion is beyond the ken of our State, let us clearly say so and delete all reference to rights relating to religion," he went on the state. Vice president of the drafting committee H C Mookherjee, on the other hand, stated that "are we really honest when we say that we are seeking to establish a secular state? If your idea is to have a secular state it follows inevitably that we cannot afford to recognize minorities based upon religion."

Nehru and Ambedkar were strongly committed to the ideal of secularism. "It is an ideal to be aimed at and every one of us whether we are Hindus or Muslims, Sikhs or Christians, whatever we are, none of us can say in his heart of hearts that he has no prejudice and no taint of communalism in his mind or

heart," said Nehru. Yet when it came to including 'secular' both were wary of its usage.Being aware of the development of Constituent Assembly debates and of how the Constitution was being shaped, they knew fully well that secularism, in the truest meaning of the term, as it was meant to be understood at its place of origin, could not be applied in the Indian context. They understood that since 'Enlightenment Secularism', with its core principle of separation, founded on the Protestant conception of religion as essentially a private concern with which states had no legitimate business, was never going to work in a country where rulers and religious publics had been interacting from time immemorial, it was better not to use the term at all than to use it fraudulently. To follow secularism in its truest form. State would be disallowed from making any of religious interventions, included the reservation system, protection of the Muslim personal law, and

the directive principle to

protect cows, all of which the Constitution went ahead with.

On June 26, 1975, prime minister Indira Gandhi proclaimed the state of Emergency and In the following two years, the prime minister was authorized to rule by decree. A series of Constitutional amendments were passed to prolong Mrs. Gandhi's rule. While the 38th amendment ensured that no judicial review of the Emergency could take place, the 39th amendment stated that the office of the prime minister could not be challenged by the Supreme Court, but only by a body constituted by the Parliament. The 42nd amendment came soon after. This 20 pages long detailed document gave unprecedented powers to the Parliament. Almost all parts of the Constitution, including the preamble, was with changed amendment. Thereafter the description of India in the preamble was changed from a "sovereign, democratic republic' to a 'sovereign, socialist, secular, democratic republic."The shocking consequence is constitution becomes unrealistic and contradicting.

Soon after emergency, and a short spell of Janata rule, the misuse of secularism multiplying until today. Shamefully nonthought over the self-contradicting constitution making a fussof the largest democracy in the world. As Churchill said "They will fight amongst themselves for power and India will be political squabbles". Wasn't he farsighted enough to read our politicians?

On Kejriwal's comment, Singapore says 'reserve right to invoke fake news law'





New Delhi: Singapore's high commissioner Simon Wong told a virtual news conference that his country was satisfied with the Indian government's clarification on Delhi chief minister Arvind Kejriwal's remarks about a new Covid-19 strain allegedly being detected in Singapore. Wong said the country reserves the right to invoke a domestic fake news law to prevent the spreading of misinformation.

High commissioner Wong said Singapore wants to put aside the "unfortunate chapter" caused by Kejriwal's remarks and focus on the shared fight against the pandemic. Referring to the law called Protection from

Online Falsehoods and Manipulation Act (POFMA), he added, "So, we reserve the right to invoke POFMA on some of the comments and assertions made by the honorable chief minister on this topic."

Kejriwal's remarks triggered a diplomatic spat on Wednesday, with the Southeast Asian country calling in the Indian envoy to object. Indian commissioner P Kumaran clarified Kejriwal had "no competence" to comment on Covid-19 variants, external affairs ministry spokesperson Arindam Bagchi said in a tweet. External affairs minister S described

Kejriwal's remarks as "irresponsible" and said the chief minister didn't speak for India. It is rare for the external ministry acknowledge that an Indian envoy has been called in by a foreign government to protest, and also to publicly criticize elected Indian official. Hours after Kejriwal tweeted on Tuesday about the alleged new Covid-19 strain in Singapore and asked the Centre to immediately suspend flights from that country, Singapore's health ministry dismissed his assertions and said the variant prevalent in many Covid-19 cases in recent weeks was the "B.1.617.2 variant, which

High commissioner Wong said Singapore wants to put aside the "unfortunate chapter" caused by Kejriwal's remarks and focus on the shared fight against the pandemic.

"Singapore Government called in our High Commissioner today to convey strong objection to Delhi CM's tweet on 'Singapore variant'. High Commissioner clarified that Delhi CM had no competence to pronounce on Covid variants or civil aviation policy," Bagchi tweeted. Jaishankar tweeted that Singapore and India are solid partners in the fight against Covid-19, and appreciated Singapore's role as a logistics and oxygen supplier. "However, irresponsible comments from those who should know better can damage longstanding partnerships. So, let me clarify - Delhi CM does not speak for India," he added.

Earlier on Wednesday, Singapore foreign minister Vivian Balakrishnan quoted Kejriwal's original tweet and wrote on Twitter: "Politicians should stick to facts! There is no 'Singapore variant'. "Balakrishnan included in his tweet a link to an article in the publication Nature with the headline "Coronavirus variants are spreading in India - what scientists know so far". The article said Covid-19 variants, including B.1.617, have been linked to the massive surge in infections in India in recent weeks.

Singapore's foreign ministry rejected "unfounded assertions" on social media by Kejriwal and expressed its disappointment "that a prominent political figure had failed to ascertain the facts before making such claims". These concerns were conveyed to the Indian envoy, the ministry said.

People familiar with developments said on condition of anonymity that the Singapore government reacted so strongly because Kejriwal's assertions had not gone down well with the public. Many people had taken umbrage at his remarks and publicly complained about them, the people said.

The Singapore health ministry's statement of Tuesday cited Indian media reports quoting Kejriwal and said, "There is no truth whatsoever in the assertions found within the reports."The statement added, "There is no 'Singapore variant'. The strain that is prevalent in many of the Covid-19 cases in recent weeks is the B.1.617.2 variant, which originated in India. Phylogenetic testing has shown this B.1.617.2 variant to be associated with several clusters in Singapore."

Kejriwal had asked the Centre to immediately suspend flights from Singapore because the alleged new strain was suspected to affect children. Union aviation minister HardeepPuri responded to Kejriwal's remarks by saying there were no regular flights between India and Singapore, except for a few under the Vande Bharat mission to repatriate Indian nationals.

The Pandemic rises Price, inflation touches double digits in April



New Delhi: India's wholesale price inflation galloped to double digits in April-an 11-year high-as pricing pressure built up due to rising oil and commodity prices, further aided by a low-base effect.

Data released by the commerce ministry on Monday showed wholesale price index (WPI) based inflation rose to 10.49% in April compared with a contraction of 1.7% during the same month a year ago. While food inflation rose by 4.92%, inflation for fuel and manufacturing items increased

to 20.94% and 9.01% respectively. Core inflation, excluding food and fuel prices, shot up to a record 8.4% in April. The global prices of many commodities have surged with the optimism generated by the covid-19 vaccine rollout and sharp economic revival in key commodity consumers such as the US and China, while landed costs were pushed up by the depreciation in the rupee.

In sharp contrast, retail inflation had eased to a three-month low of 4.29% in Aprildata released last week showed-as favorable base

effects. However, going forward, retail inflation may also see upward pressure with rising input costs and supplyside disruptions. "Unlike last year, when producers benefited from reducing input cost pressures, this year they are likely to witness margin pressure with higher commodity cost. The sharp rise in core WPI inflation indicates a rise in cost-push pressures from wholesale prices to retail prices," IDFC Bank said in a research note released on Monday.

Aditi Nayar, chief economist at ICRA Ratings

said there is a growing divergence in terms of the global optimism related to the vaccine rollout, which is pushing up commodity prices and the weaker domestic sentiment engendered by the continuing impact of the second wave of covid-19 infections in India. "The likely trajectory of the WPI inflation supports our view that there is no space for rate cuts to support the faltering growth momentum, even as we expect the monetary to accommodative. We expect the headline WPI inflation to rise further to 13-13.5% in the

current month before commencing a downtrend, whereas the core-WPI inflation may continue to rise over the next three prints to a peak of around 10.5%," she added.

The central bank is expected to keep the policy rate unchanged and will certainly maintain an accommodative stance to ensure ample liquidity and keep long-term interest rates from rising, the Asian Development Bank said last month. "While inflation will stay within the target range, upward pressure on bond yields may come from the large fiscal deficit, the

government's aggressive borrowing program in FY21, and higher global bond yields. Large capital inflow poses a challenge to the central bank as it strives simultaneously to maintain price and exchange rate stability and set interest rates that facilitate economic recovery," it added. Escalating covid cases have overwhelmed India's health system, forcing many states to announce localized lockdowns which are expected to delay a strong recovery in domestic economic activity. Moody's Investors Service on Tuesday slashed its FY22 economic growth forecast for India to 9.3% from 13.7% estimated earlier, citing the negative impact of the second wave of coronavirus pandemic. S&P Global Ratings last week said it expects India's GDP growth at 9.8% under its moderate scenario and to 8.2% under the severe scenario based on when the current infection wave peaks.


DRDO's anti-COVID drug 2-DG to be available at all hospitals from June

New Delhi: The anti-COVID drug 2-DG developed by DRDO will be made available to all the hospitals across the country from the first week of June, said DRDO Chairman G Satheesh Reddy, as quoted by news agency ANI. The first batch of the drug which was launched today will currently be available at AIIMS, Armed Forces Hospitals, DRDO hospitals, and other places in need.

Reddy noted, "The first batch of anti-COVID drug 2-DG will be used in a limited manner. It will be used in AIIMS, Armed Forces Hospitals, DRDO hospitals, and any other places where the need arises. From June onwards it will be made available to all hospitals."

He also said, "The production is underway and the second batch of the drug will come around last week of May. The regular production will take place from June onwards



commencing from the first week."He further mentioned, "In the second batch, the production span will be increased and from the first week of June it will be made available to all hospitals and other medical facilities in the country."This is because the production time and the cycle of this is about a month. After approval from the Drugs Controller General of India (DCGI), the industry is working hard but it will take a month to reach the normal production capacity," explained the DRDO chief.t

How does the vaccine work? Explaining how the vaccine works, Reddy said, "It works directly on the cells infected with COVID and gets absorbed in them. It then stops the virus from multiplying and moving to other healthy cells. 

Haridwar: A video, which surfaced on social media on Wednesday, has yoga guru Ramdev challenging authorities to arrest him. Earlier in the day, the Medical Indian Association (IMA) wrote to Prime Minister Narendra Modi to book the Yoga guru under sedition laws for questioning the efficacy of allopathic medicines and vaccines against Covid-19 disease.

In the 40 second video, Swami Ramdev is seen saying, "Khair arrest to unka koi baap bhi nahi karsakta Swami Ramdev ko... lekin ekshor macha raheyhain...ki arrest Swami Ramdev... kabhi

kuch chala detey hai....ki arrest Ramdev...Thug Ramdev...Kabimaha thug Ramdev... Kabi giraftaar Ramdev... chalate rahe hai..chalane do ('No one ..in fact no one's father can arrest Swami Ramdev...but they are making noise... arrest Ramdev, Thug (con) Ramdev...They are following trends ...let them)"

The war of words between the IMA and the yoga guru has escalated over the past couple of days with Ramdev raising 25 questions on the efficacy of modern medicine and the IMA Uttarakhand chapter threatening him with a Rs. 1000 crore defamation case. It all started with a video,

where Ramdev was seen calling allopathy a 'stupid science' and alleging that thousands of doctors had died despite taking the vaccine to prevent Covid-19 infection. He later retracted those comments following the IMA and Union health minister's objections.

Following Ramdev's continued questioning of modern medicine, the Delhi Medical Association filed a complaint against the yoga guru and IMA's Uttarakhand chapter has given him a fortnight to withdraw his remarks.

"Baba Ramdevdoes not know whatsoever regarding allopathy. Baseless opinion, allegations, and statements, as seen in videos surfacing in social media itself, points to his derogatory views about allopathy and doctors who are front line warriors," said IMA Uttarakhand secretary Dr Ajay Khanna.

Swami Shivanand Saraswati of MatriSadan ashram said it seems Ramdev has become an arrogant person.

"If allopathy has no significance for him, then why Acharya Balakrishnan was taken to AIIMS Rishikesh two years back for food poisoning. He should prove first that Coronil is much better than allopathic medicine treatment then raise fingers on Covid-19 treatment and fatalities.' said Swami ShivanandSaraswati.

Coronil is an ayurvedic immunity booster manufactured by Ramdev's firm Patanjali. Acharya Balakrishna is Ramdev's close aide and co-founder of the firm

Former president of IMA's Haridwar chapter, Dr Sandhya Sharma said Ramdev should concentrate on jointly fighting the war against Covid-19.

"Allopathic doctors are working day-night for past 14 months in the fight against Covid-19 and so are Ayurveda, Homeopathy, Unani, or Siddha medical therapies," said Dr Sandhya Sharma.

Bengal CM Writes To PM, President To Change Governor

Kolkata: West Bengal Chief Minister Mamata Banerjee has written to the President and Prime Minister demanding a change of Governor in the interest of "good governance" in the state. The letter comes immediately after the CBI arrested four Trinamool leaders, including two ministers, a former minister and a former Mayor in the Narada scam, on Monday.

Governor JagdeepDhankhar has been on an unusual offensive against the Mamata government after the ruling Trinamool Congress won a landslide in this summer's assembly polls.Banerjee's letters despatched on Tuesday alleges that Governor Dhankhar has been raking up an 'exaggerated version' of violence in West Bengal since the election.

It said the whole exercise is to project a 'highly inflated



version of the law and order situation in West Bengal, overlooking the fact that the incidents happened when the control of administration was not in our hands."The

situation is now under full control and the administration is busy fighting Covid, it said.

The letter also pointed out that Dhankhar was "crossing all limits" by raising the law and order issue during the swearing-in ceremony and tweeting about it in the public domain. It said the Governor is trying to 'destabilize the functioning of the government' at the time when the need of the hour was focused on efforts to control the Covid pandemic.

Trinamool Congress sources said the party was considering a resolution passed by the legislative assembly demanding the removal of the Governor. The Governor has been at daggers drawn with the Trinamool government ever since he took charge.

" He is trying to build up a narrative of a severe breakdown of law and order with malafide motive of destabilizing an elected government, " alleged Trinamool MP Saugata Roy.

But Raj Bhavan sources rubbished the Trinamool charges.One said the Governor was a lawyer by training and was " totally conscious of this powers and responsibilities."" He had raised valid concerns over breakdown of law and order. He had cleared the CBI to prosecute the politicians involved in the Narada scam," the Raj Bhavan source said.

BJP names 'author' of Congress 'toolkit'

New Delhi: Congress hit back and accused Sambit Patra of using metadata to name the author of a real document to claim that she also authored the fake documents. It reiterated the document on Central Vista was genuine, but the BJP concocted the other one on Covid-19 to defame the Congress

Bharatiya Janata Party (BJP) leader Sambit Patra on Wednesday named Saumya Varma as the author of the toolkit, a social media campaign playbook, that his party said on Tuesday was prepared by the Congress to

defame Prime Minister Narendra Modi and to build a biased narrative over the Indian government's handling of the second wave of Covid-19, and the Central Vista Project.

Congress accused Patra of naming the author of a real document (from its metadata) to claim that she also authored the fake documents. It reiterated that the document on Central Vista was genuine, but that the BJP had concocted the other one on Covid-19 to defame the Congress.

"...We made a research note on Central Vista for the



party It's genuine and fact-based. I tweeted yesterday [Tuesday] that the 'Covid-19 toolkit' is forged and is a 'Made in BJP' product. Patra is showing metadata/ author of a real document and attributing it to a fake," said Rajeev Gowda, the head of Congress's Research Department.

Congress leaders said Varma is part of the Congress's Research Cell and that she is not a worker or a member of the party but one of the many professionals engaged by it. She draws a monthly salary from the party, they added. "After 2019, the research team was truncated just as many other branches of the Congress. Varma and few others are running the research team," one Congress leader said on condition of anonymity.

The party refused to give her contact details. Gowda said: "You question me. Do not question my

staff."

BJP?leaders on Tuesday cited and shared a document circulating on social media. The document was on the letterhead of the All India Committee's Congress Research Department. Congress has said this letterhead is forged. The document asked its readers to tarnish Prime Minister Narendra Modi's image and "erode his popularity". It suggested using phrases such as "Indian strain" and "Modi strain" for the variants of Covid-19 that were first detected in the country. The document also

spoke about briefing foreign journalists over India's mismanagement of the second wave of the pandemic.

The Congress maintained the document on Covid is fake and has been concocted and lodged a complaint of forgery and cybercrime with the Delhi Police. It said in its complaint, filed by Gowda that BJP president JP Nadda, spokesperson Sambit Patra, Union minister SmritiIrani, among others, "shared forged" documents on Twitter. Tallinn, Estonia

In 2013. Tallinn, Estonia, became the first capital to make public transport free, and the experiment has been considered a great success. Tens of thousands of Estonians chose to register as residents of the city to benefit from the system, generating around 38 million additional euros (CA\$60 million) in local taxes.

Luxembourg (countrywide!)

While many cities across the globe have decided to offer free public transport to residents, all Luxembourgers have benefited from this service since February 29, 2020 - a world first! Environmental concerns played a key role in the country's decision to prioritize free public transportation.

Chambly, Canada

In 2012, the suburb of Chambly as well as other municipalities in Montréal's South Shore decided to offer free public transport to residents. In the autonomous province of Åland, Finland, the Mariehamn municipality offers free public transport to residents and visitors. The service was set up in 2000 and is managed by the company RödeOrm.

Monte Carmelo, Brasil

Over the past couple of decades, lots of towns and cities throughout the world have

Aero, Denmark

China's bid for Indo-Pacific foothold backfires in Samoa

New Delhi: Chinas bid to expand its influence in the Indo-Pacific has taken a hit, with Samoa, a strategically located nation in the South Pacific, signaling that it would not go ahead with a Chinese port development project. Samoa's new Prime Minister, Fiame Naomi Mataafa, whose election was upheld by the country's Supreme Court has told Reuter's news agency that she intended to shelve a \$100 million Beijing-backed port development project.

The Chinese intended to construct a wharf in Vaiusu Bay-a move that was fully backed by long-serving leader TuilaepaSaileleMalielegaoi, who lost his parliamentary majority during the April elections.Mataafa's decision is significant as it feeds into the China-US rivalry in the Indo-Pacific, a vast region of the Indian and the Pacific oceans linked by the strategic Malacca Straits.

The Samoan Islands are in contention because they are located roughly halfway between Hawaii and New Zealand, in the Polynesian region of the Pacific Ocean. Any rival Chinese military presence here can threaten some of the



key shipping lanes of the area. After World War-2, the US has been the most dominant player in the Pacific.

Given the brewing rivalry, the former U.S. National Security Advisor Robert C. O'Brien had last October signaled that Washington intended to carry out a feasibility study of basing US Coast Guard vessels in American Samoa, part of US territory southeast of mainland Samoa.

"The United States promotes a free and open Indo-Pacific region where like-minded nations uphold the international rules-based order," O'Brien's office had said in a press statement then. The US fears that after building a port in Samoa and elsewhere in the region, including Kiribati, the Chinese can send their paramilitary forces in the guise of fishing vessels, as has been done by Beijing in the South China Sea. Chinese "fishing vessels" a front for its paramilitary have regularly harassed fishermen in contested waters, with Japan in the East China Sea as well as Vietnam and the Philippines in the South China Sea.

O'Brien had told Honolulu Civil Beat, that China's People's Maritime Militia- a paramilitary force of military-trained fishermen who occasionally work on behalf of the Chinese Navy, conducting surveillance and other operations are a major concern among the US and its allies. The former US official said that warning signals that China may leverage its experience in Asian waters in the South Pacific as well. He said that a suspicious - and aggressive - fleet of Chinese fishing vessels had clashed with the Ecuadorian Coast Guard last summer. "It's just like a marauding band of fishing trawlers that come through and strip fish and then dumps garbage and plastic all over the ocean," O'Brien said of China's sea militia, as quoted by the Samoa News website.

The US sensitivities to the Chinese moves in the South Pacific have heightened after reports that the Chinese are eying a World War-II vintage military airstrip, which is 3,000 kilometers southwest of Hawaii, in Kiribati. The location is not far from busy commercial shipping lanes running from the US to Australia and New Zealand. Samoa's newly elected Prime Minister also signaled that her country was conscious about avoiding a Chinese debt trap, which Beijing can leverage for its political gains. "The level of indebtedness of our government to the government of China was a pressing issue for voters," said Mataafa, the country's first woman prime minister.

SundarlalBahuguna, who died of Covid-19 on May 20 aged 94, was known the world over as the man who taught Indians to hug trees to protect the environment. He was one of the main leaders of the Chipko movement in northern India in the 1970s. In Hindi, chipko means "hugging".

Heeding calls by Bahuguna and fellow activist Chandi Prasad Bhatt, men and women in the Himalayas embraced and chained themselves to trees to stop loggers from cutting them down. It was a powerful symbol that conveyed, 'Our bodies before our trees'.It also became a movement that brought to the world's

attention the devastation wrought by the environmental crisis in the world's highest mountains.

A devastating flood in Uttarakhand in 1970 had come as a rude awakening for villagers. They woke up to the "tenuous links between deforestation, landslides, and floods". Three years later, Bahuguna and fellow activists began embracing trees. Young men took an oath in blood to protect nature. Very soon, women in the Himalayas became an integral part of the movement too, embracing trees and tying rakhis - a symbolic red thread tied around a brother's wrist during the festival of RakshaBandhan - onto the

bark of trees. They walked in the snow and took away tools from loggers to stop felling

Bahuguna, who grew up in the Himalayas, connected the dots well. wrote that deforestation led to the erosion of fertile land and pushed the men out of the villages to look for jobs in cities. This left women to all responsibilities collecting fodder, firewood, and water, apart from farming". Not surprisingly, the Chipko movement became an important milestone in the fight to secure women's rights.

Over the years, Bahuguna, with his flowing beard and trademark

bandana, went from strength to strength. College students and women joined him in greater numbers. They peaceful staged demonstrations, hugged trees, and went on fasts.It yielded results: a fast in 1981 led to a 15-year ban on commercial felling of trees in Uttarakhand. Two years later, he marched 4,000km (2,500 miles) in the Himalayas to draw attention to environmental degradation. The indefatigable campaigner never stops lecturing, railing against the collusion of forest officials and private contractors in decimating forests.

When former prime minister Indira Gandhi was

be cut, I'm all for it."Despite the changing times, the symbolism of Bahuguna's movement lives on. In 2017, activists in Mumbai hugged trees to protect more than 3,000 of them from being axed to make way for a metro railway facility.

Bahuguna was a charismatic ascetic, a spartan man of Gandhian principles. He lived in a small ashram, denounced violence, and was essentially non-political. He believed in self-reliance and not in "so much foreign trade". He despised materialism. To become energy secure in a "non-violent and permanent society", he said, India needed to produce biogas

less energy, he suggested.

Born in 1927 in Tehri district in what is now Uttarakhand, Bahuguna grew up surrounded by sal, oak, and fir trees and sweeping pasture lands.Bahuguna found not seeking conflict or controversy, but an easy-going, gentle, and soft-spoken man, who had made the "early link between the cutting of trees and drying up of the springs in Himalayas". During his travels in the region, Baruah found the mountain springs were drying up and people walking \price long distances to fetch water. He says he understood that the campaigner's activism came from his own lived

An Age-by-Age Guide to Set Discipline Consequences for Kids



The pandemic covid-19 has brought about a sea of changes in our day-to-day life. Has restricted our visits to the clubs, markets, parks, and our social get-togethers have been severely hit. We'rebeing forced to stay at home, have to spend time with children. Why not we use our time with children discipline setting consequences in an interesting way acceptable to them. Stress Consequences

Emphasize the use of consequences over punishment, says a licensed

marriage and family therapist in Bellevue, WA. "They're related concepts but with a different purpose."

Punishments make children feel bad, or worse yet, suffer. "While punishments may 'work,' to interrupt a behavior short term, they have potentially negative long-term effects including causing children to feel bad about who they are (which also makes them more likely to act out again), as well as creating an adversarial relationship between parents and child."

C h o o s i n g Consequences

Part of an adult's job is to help children face the consequences of their behavior, explains Arquette. "I tell the kids who come to see me that they choose their consequences by their behavior. For example, if they refuse to clean up the toys at the end of the session, the next time they come they won't be able to use those toys. They can ensure using the toys again by putting them away when I ask."

Also, natural consequences work best to promote learning. Arquette elaborates: "If the natural

consequences get the child's attention and generate insight and remorse, there is no need to add logical consequences."

Logical consequences work best when they're consistent, firm, logical, and fair; wait until you are calm to impose consequences to avoid overreacting and avoid power struggles.

Examples of Appropriate Consequences for Kids by Age

Infants

Consequences/ punishments are not appropriate for infants.

Toddlers (3 years)

Change the tone of your voice (a loud, deep "no" is usually enough); redirect them towards another activity/toy/etc, or give a time out (the number of minutes should be equal to the child's age). "Put them in a location away from everyone and everything else going on; however, if they won't stay in that spot, just ignore them and don't worry - the most important aspect of a timeout is breaking the cycle of the behavior, not where they spend it," says Arquette. "Offering choices can help avoid many behavioral problems - try giving two options that are equally acceptable to you (for example, "do you want to put on your coat first, or your shoes?")."

Preschoolers (4-5 years)

Use the consequences you did in their toddler years, says Arquette, in addition to taking away toys or privileges for a short time. "For example, if your child is fighting over a toy, then put the toy in timeout for 20 minutes. Invoke the consequence as soon as possible after the misbehavior; if too much time passes between the behavior and consequence, kids at this age won't make the connection." Counting (from 3-10) is also effective with kids this age to get them to do or stop doing

School-Age Kids and

values. For older kids, losing time with friends or electronics can be powerful motivators."

Whenever possible, let natural consequences play out - if your child refuses to eat their dinner, let them experience the long wait until breakfast.

"Expression of disappointment or disapproval of a parent also can serve as a consequence."

Teens (13-18)

According to Arquette, ask yourself: "What matters the most to your teen? Those privileges or special items will be the most impactful to lose." For example, if your child uses their cellphone after bedtime, they might lose it for the next day.

Try to talk things out afterward to get to the root of the problem, explains cooperation down the line."

Focus on the Good

It's so easy to 'steam' when you're frustrated with your child. However, warns Arquette, parents can inadvertently reinforce poor behavior choices in children of all ages, by paying too much attention to it. "Try instead to catch your child doing good behaviors before the bad behavior has a chance to start." Thus, reinforce good behaviors with specific praise, such as "It's so helpful when you make your bed without a reminder, now we have more time to play."

Be careful not to taint the praise, which is when good behavior is highlighted, but a negative remark is added and takes away the good feeling typically fostered by praise, such as "It's so helpful



Tweens (6-12)

Use the consequences you did for younger kids, although you will likely have to extend the length of time for continued effectiveness. Says Arquette: "The loss of privileges or items are more effective when they're something your child

Arquette, and help your child understand how thoughts and feelings connect with behavior. "Teens can often be relied upon to give input on house rules and what should happen if they're violated. Giving them a voice may help in maintaining their

Rewards

High on brawn, baddies, and brutal action

Director Prabhudheva, of course, gives into many such temptations that potentially derail the narrative, but thanks to the relentless action and a formidable villain, the film remains watchable, in parts.
