The former Petroleum & Natural Gas and Steel Minister replaced Ramesh Pokhriyal 'Nishank' while HardeepPuri got the Ministry of Urban Development, Housing, clubbed with Petroleum & Natural Gas

Union Minister Dharmendra Pradhan got the Education, Skill Development, and

Entrepreneurship Ministries in the new Modi cabinet

Pradhan held the important portfolio of Petroleum & Natural Gas twice in the Modi government.

In 2014, when the NDA came to power led by Prime Minister Narendra Modi, Pradhan became the Petroleum Minister with independent charge. Later, he was promoted to cabinet rank and given the additional portfolio of Skill Development in 2017.

Son of former Union Minister Debendra Pradhan, Dharmendra was born on June 26, 1969, in Talcher. He belongs to the Other Backward Caste (OBC) category. He is married to Mridula Pradhan and has two children Nishant and Naimisha.

He started his political carrier as an AkhilBhartiyaVidyarthiParishad (ABVP) activist in 1983 while pursuing higher secondary education in Talcher College. He became the president of the student union in Talcher in 1985. Later, he became the national secretary of ABVP.

He did his M.A. in Anthropology from Utkal University in Odisha.

Cut in administered prices, and cash flow are boosters, not in FM's stimulus

A booster dose of about Rs 6.28 lakh crore stimulus to push credit is supposedly an official phenomenon to rev up the economy with about, but the market response looks muted.

The banks are expected to lend about Rs 2.67 lakh crore to fund the covid19-hit businesses. The lending does not help when moods are down. The actual infusion is Rs 1.5 lakh crore. A key element of injecting cash into the system that helps the poor remains elusive. India must demolish the digital Berlin wall, IMF had advised in 2019. Eight lakh Jandhan accounts were beneficiaries of PM Kisan funds of Rs 6000 each -Rs 480 crore. Digital is not the answer to stop fraud.

The share market

continued with a bear hug for four days before closing with a rise of 166 points on Friday, July 2, 2021-not a big deal but like most Fridays, it breaks the monotony into a visible surge for record's sake. The concern is that institutional participation in the stock market has declined to a 15-year-low.

Finance Minister Nirmala Sitharaman's largesse is a difficult move by a government with a severe financial crunch. This also is shadowed by galloping inflation fueled mostly by domestic factors though the global trends also are pushing it up. The FM should have looked around her table to rectify some she could have easily done - the fuel prices. The advisors who suggested that detrimental way are good theoreticians. They are not aware that central and state governments are the biggest guzzlers of fuel and the highest taxpayer to its kitty. It merely window-dresses the coffers. The outgoes, in reality, are more.

The worse it has hit all industries, people and virtually bulldozed the poor. Another set of advisors go on harping that road tolls, fees, and user charges, and high rail and transport fares must rip the roof "to sprint to fast development" forgetting it is eroding the very base of the economy - the purchasing power. Though the latest CMIE report says, that eight lakh people have their jobs restored in June but most of them on lower wages. The job losses are baffling everyone. The incomes of 97 percent of households have declined since March 24, 2020. The government free food doles sustain people. The CPI index could plummet many points if petrol and other fuel prices are cut to around Rs 40, vehicles are not scrapped in the name of pseudo-pollution concerns, transportation charges get reduced and high-handed police deals to the people for enforcing covid19 healthcare protocol are done away with. The police deals have hurt the shops, vendors, many offices, and individuals. They are not trained to behave but their rentseeking is ruining the lowest level of economic activities. Some studies have come out with miseries of many families, some even committing suicide. It need not be a welfare nation but at least could be humane. Uncertain official advices are bringing not a good name to the political masters, who pay the final popular cost.

The banks are also shaking the confidence of the people. Would more privatization mean more outgo from government and more miseries? No one is sure but banks themselves seem to be on a shaky platform. Despite the government's creditdriven stimulus to help tide over the impact of covid 19, bank credit growth hit a new low for the second year in a row in FY21 at 5.56 per cent - the lowest in 59 years, according to an analysis by SBI Research. It is lower than financial year'20 when it grew by 6.14 percent. In 1962, it clocked 5.32

The June purchasing managers' index (PMI) plummets to 48.1, lowest, below the critical threshold of 50, signifying contraction beyond the levels of April and May, when the lockdown was severe. This suggests demand-side problems - another testimony that people are lacking in cash.

This has impacted investments, a

determinant of future growth. The CMIE says year-on-year growth numbers look impressive for the private sector on a low base effect. The cost of continuing uncertainties is said to be heavy on actual investment. New i n v e s t m e n t announcements continue to be at low levels. The government itself is wary of investments because of strained finances. It has led HSBC to moderate GDP growth to 8 percent, lower than RBI estimates of 9.5 percent

The industry fears that as the government largesse would depend on higher credit from the market, lending for them would be costlier. The RBI itself has indicated a rate rise by the next quarter or so and is pessimistic of growth. The silver lining is that the Nomura India Business resumption index hints at recovery from a sharp collapse on May 23 at 60.3.

The market concern is reflected over the drop inflows from foreign and portfolio investors to the stock market due to elevated share valuations. In other words, there apprehensions about actual equity prices. In June, their market share dropped to 30 percent against retail investors of 70 percent. The average portfolio investment was around Rs 25,200 core a day at NSE and BSE, an

extreme low. The FPIs sold stocks worth Rs 8,500 crore between April and June after buying Rs 44,500 crore stocks during January-March. The interesting aspect is that the stock market is no indicator of buoyancy but hints at a conducive atmosphere.

Meanwhile, the bad bank that is to come up has a pile of Rs 2 lakh crore debt, about a quarter of the country's non-performing assets may not resuscitate the economy nor the privatization causing more outflow of public funds.

So the stimulus pushes theoretical expenditure to about Rs 36.6 lakh crore. It may not exactly materialize. The net push may be far less and may result in lesser flows to the purchasers though it might push the official deficit to 7.5 percent, in actuality it may be a few notches more. Many companies and units are closing down. Even the government is downsizing as costs go up with inflation.

A mere stimulus would not work. Digital pushes have blunted cash flow and increased operational costs. The country has to bring down administered prices, enhanced taxes, transportation costs to make the people and businesses comfortable. The solutions are there one has to trudge.

SAIL steelworkers observed a 24 hours strike to protest the long delay in wage revision

Rourkela, July 2: Ahead of the 24-hour strike call given by the trade unions, Rourkela Steel Plant Management, threatened the workers issuing a notice which stated that the strike on 30th June is illegal as reconciliation proceeding is on with the Regional Labour Commissioner, and advised workers not to participate. "Participation in the strike would lead to break in service and attract action under provisions of Wages Act, 1936 leading to loss of eight days of wages, rewards and incentives besides disciplinary action."

Despite the threat of wage deduction, trade union leaders were not perturbed by the wage deduction notice. Workers joined the strike in huge numbers. Rather in reply to the



warning, trade unions of RSP resorted to a day-long hunger strike at Bisra Square.

About 95 per cent of the employees joined the one-day strike called by five central trade unions including BMS, INTUC, CITU, AITUC, and HMS of all SAIL plants. Smaller unions at Rourkela also joined the strike.

Trade unions are demanding immediate finalization of wage revision of public sector steelworkers in the National Joint Committee on Steel (NJCS) meetings. The wage revision has been due since January 1, 2017.

Following strike notice given by the unions across the country, SAIL had started wage negotiation in the NJCS meeting from June 22. In a partial success, its offer of 13 per cent growth in Minimum Guaranteed Benefit (MGB) enhancement on basic pay and Dearness Allowance was accepted. However, the NJCS meeting ended abruptly on 27th June with SAIL rejecting the demand for growth of perks at par with SAIL executives. RSP management didn't specifically mention the loss they suffered due to the absence of workers. They claimed that despitethe strike the vital departments like Blast Furnace, Steel Melting Shop, Coke Oven, etc. did operate to around 15 to 30% of capacity.

Free dialysis service at Rourkela hospital

Rourkela: A free dialysis service has been started at the Government Rourkela Hospital (RGH). Rourkela MLA SaradaNayak and Sundargarh Collector Nikhil PavanKalyan inaugurated the free dialysis unit on 25th June. It would benefit people who cannot afford the cost and have to go to faraway places like Cuttack for treatment. The dialysis unit has four machines and this service began under the 'Sahaya' scheme of the state government.

Under the upgradation program, Rourkela Government Hospital(RGH)

is gradually augmenting its infrastructure and medical facilities. In October 2019, Chief Minister Naveen Patnaik had announced a three-fold increase in RGH's bed strength from 128 to 400 under the 'Mo Sarkar' initiative. But due to first and second waves of the Covid-19 pandemic slowed the progress of the proposals.

However, RGH has started augmenting its medical facilities and infrastructure as part of a continuous process. A free CT Scan facility has become functional a few months ago. There are plans to start a central pathology



laboratory and laparoscopy surgery in near future also. Meanwhile, civil work for the PSA (Pressure Swing Adsorption) Oxygen Plant has already started. RGH Director Santosh Kumar Swain informed dialysis center would remain open on all the days from morning 8 to evening 8 pm. He said the service would hugely benefit those who have to go to places like Cuttack for dialysis.

RSP Achieve Historic Milestone of 100 MT Hot Metal production

Rourkela: Rourkela Steel Plant has surpassed a historic milestone of 100 million tonnes (MT) Hot Metal production on July 5. With this achievement, SAIL has entered the elite club of the steel industries with such a distinction.

The journey of RSP had commenced on February 3, 1959, with the then President of India DrRajendra Prasad commissioning the first Blast Furnace 'Parvati,' which has now entered a higher orbit. In the last 62 years, RSP has consistently reinforced its commitment by providing one of the strongest metals available on planet Earth for use in every aspect of life and



living, right from household items to infrastructure and defense applications.

SAIL's Chairperson Soma Mondal in her congratulatory message for the achievement to CEO Chattaraj and RSP collective said, "The milestone has been crossed with the help of efforts put in by thousands of people who have contributed directly and indirectly to the growth of the steel plant which had come up in the remote part of the state of Odisha more than 60 years back. Shortage of doctors hit health service in Jagatsinghpur



JAGATSINGHPUR: The shortage of doctors at the headquarters hospital, Community health centers [CHC], Primary Health Centre (PHC), and other governmentrun hospitals are adversely affected in the healthcare scenario across the district.

As official reports informed that out of 220 sanctioned doctors post for Jagatsinghpur district, as many as 91 post doctors are lying vacant, six physicians have been sent on deputation to Cuttack and Bhubaneswar during Covid 19 pandemic, one

doctor has gone long leave and another one undergoing training. Out of 58 doctor's posts at district headquarters hospital [DHH] 39 doctors are working, sadly one anesthesia post is lying vacant for the past three years, following the urgency of any operation performed at DHH one PG student from SCB Medical College and hospital in Cuttack is regularly invited.

Echoing similar shortage of doctors in Biju Memorial Hospital in Paradeep out of 11 doctors only 5 doctors are working followed by in Kujanga hospitals out of 17 doctors only 7 doctors are in duty, in 6 hospitals under Erasama block out of 16 sanctioned doctors post 10 physicians are at work, in Raghunathpur block adjacent hospitals 11 doctors working out of 24, in Balikuda hospitals 16 doctors are in duty out of 26, 8 PHCs under Manijanga only 14 doctors at work out of 19. In Naugaon CHC too has witnessed a shortage of doctors, 6 doctors, out of 13, in Mandasahi CHC out of 15 only 9 physicians at work, moreover, in Biridi CHC and 2 PHCs 7 doctors are working out of 13 sanctioned physicians post, however, 10 dentists are working in different hospitals across the district.

A major chunk of the population belonging to the coastal rural areas and bordering villages of Erasama, Kujanga, and Balikuda of the district face issues as healthcare

infrastructure is not as robust as compared to other parts of the district. Patients from Paradeep face added problems due to its long distance from DHH and S C B Medical College and Hospital in Cuttack. Despite repeated requests to the district administration, no one is paying any heed in filling up vacant doctor posts However, sources informed that a central team had visited Covid hospitals functioning in DHH and Paradeep three days ago, where the team found no doctors in pulmonary medicine and Anesthesia and expressed strong displeasure.

Chief District Medical Officer Dr Bijaya Panda said due to the shortage of doctors, medical services are managed by alternating the duties of doctors between the centers, resulting in poor health services.

Odisha approves 5 mega steel projects worth Rs.1.46 lakh crore investment Odisha clears five mega steel projects

Bhubaneswar, July 6: The Odisha government Tuesday accorded in-principle approval for five different projects having 27.5 MT steelmaking capacity at an investment of ?1.46 lakh crore, official sources said.

The state, which started its steel-making journey from just 2 million tonnes per annum (mtpa) in 2000, has so far enhanced the capacity to generate 30 mtpa and Tuesday's addition of another 27.5 mtpa will take the capacity to 57.5 mtpa, he said.

Tuesday's approval will also provide the mineral-rich and tribal-dominated Keonjhar district with a mega steel plant of 3 MT capacity. This is the first big investment in manufacturing in Keonjhar, the official said.

This apart, the approval to JSPL's expansion plan of its Angul plant to 25.2 mtpa, will make the company the world's largest single-location steel plant. The approval was cleared at the State High-Level Clearance Authority, chaired by Chief Minister Naveen Patnaik.

The new investment to the tune of ?1,46,172 crore in metal and metal downstream sectors during the COVID-19 pandemic also made Odisha one of the favored investment destinations in the country.The



state has been able to attract investments to the tune of ?2.96 lakh crore in 2020-21 despite the Covid pandemic, he said, adding that with Tuesday's additional investments the total investments since last year will be ?4.43 lakh crore in the state.

These five projects are expected to create employment opportunities for 26,959 persons. "All these projects need a big push forward to realize the steel dream of Odisha," Patnaik said after approving these projects.

This will help to achieve the goal to produce 100 million tonnes of steel by 2030, a senior official said, adding that the state currently has a production capacity of 30 million tonnes, way ahead of a meager 2 million tonne in the year 2000.

The projects which got approval included, the expansion of Bhushan Power and Steel Limited's integrated steel plant from 5 million tonnes per annum to 15 million tonnes per annum against an investment of Rs.55,000 crores. The project will be set up at Rengali in Sambalpur district and will

generate potential employment opportunities for over 10,000 persons.

A proposal for the expansion of Tata Steel Limited's crude steel production from 3 million tonnes per annum to 8 million tonnes per annum, hot-rolled coil from 3 million tonnes per annum to 7 million tonnes per annum, 2.2 million tonnes per annum coldrolled products, and 2 million tonnes per annum long products against an investment of Rs.47.599 crores to be set up in Kalinga Nagar, Jajpur, also got the government's nod. This will generate potential employment opportunities for over 4,625

The expansion of Jindal Steel and Power Limited's 6 million tonnes per annum existing integrated steel plant from the proposed capacity of 18.6 million tonnes per annum to 25.2 million tonnes per annum at an investment of Rs.24,652 crores to be set up in Angul. This will generate potential employment opportunities for over 1,000 persons.

"This investment will take

JSPLs total investment to Rs.1,00,670 crore, making it the largest single-location steel plant capacity in the world," the official said.

Similarly, the expansion of Rungta Mines Limited's Integrated Steel Plant from the proposed capacity of 2.85 million tonnes per annum capacity to 7.55 million tonnes per annum by adding a capacity of 4.7 million tonnes per annum at an investment of Rs.11,001 crores to be set up at Jharbandh in Dhenkanal district. This will generate potential employment opportunities for over 6,200 persons, he said.

The expansion of Rungta Mines Limited's Steel Plant capacity from 0.53 million tonnes per annum to 3 million tonnes per annum at an investment of Rs.7,920 crores to be set up at Karakhendra in Keonjhar district, will also generate employment opportunities for over 5,134 persons.

Several steel-making andother downstream industries are already in various stages of implementation. The approvals granted on Tuesday are to the leading and reputed investors in the metal sector of the country and will further reinforce Odisha's position as the topmost investment destination in the country, the official said.

Man commits suicide after killing daughter and ailing wife

Basic amenities still a distant dream for Mayurbhanj'sKhadia families

Baripada, 11 July:Notwithstanding tall claims
of the State Government of
giving priority tothe
development of tribal
pockets, the Khadia people
under Particularly
Vulnerable Tribal
Group(PVTG) who are
living in tribal-dominated
Mayurbhanj district are
depriving of basic facilities.

As many as 25 Khadia families under PVTG who are residing in Dhipakocha hamlet village near Asuraghati hill under Bahalda block in the district are struggling to sustain themselves without basic facilities like housing, education, drinking water,



electricity, health, and road connectivity. As they are living close to the Odisha and Jharkhand border that may be their major mistake, they feel. Besides facilities like Adhar Card, Voter Identity Card, and Rational Card, other basic benefits like old-age pension, road, drinking water, health facilities are a far distance from the village.

While the benefits of both Central and State Government schemes such as MGNREGS, Pradhan MantriAwasYojana, and Biju PuccaGharYojana are for poor people, are yet to reach the tribals residing in the hamlet area.

BaskeyDehuri(65), GhasiyaDehuri(62) citizens said that they have walked around one-and-halfkilometers to fetch water from a stream due to the absence of a drinking water facility in the village. As there is no health center nearest to the village sans road connectivity, they carry patients on the cot and bring them to Bahalda hospital, situated 20 km from their village. Collecting sal leaf and other minor forest produce are the main source of income and

sustaining their livelihood through this income. Some additional income support is brought by selling goats but these supports are not enough to cater to their family needs, they expressed. Citizens Manguli Dehury (55) and Pana Dehuri (48) expressed their plight that they had their right to vote but did not get basic benefits from the government.

Balda BDO HemantaNayak said that he doesn't know the village. If there is a hamlet village under his block jurisdiction, he will go to the village and address their problems as per government rules.

cent.Commissioner of CT & GST, Sushil Kumar Lohani has instructed all the field officers to detect the wrong return filers by applying data analytics and collect all taxes from them as per the provisions of law

Similarly, clear instructions have been issued to Tax Officials to increase field surveillance so that potential leakages could be plugged.Senior officials said that the CT & GST Organization has focusing been increasing the taxbase of GST with regular surveys and registration. 7984 numbers of registrants have been brought under the GST fold from April-June 2021-22 in the State. All Circles have been instructed to ensure 90 per cent return filing within the due date. recorded a progressive growth of 80.29 per cent the progressive collection upto June 2021 stood at Rs 2812.93 crore against a collection of Rs 1560.20 crore upto June last year.Senior officials said that the growth of 13.13 per cent in OGST collection is due to better compliance by dealers having turnover of more than Rs. 5 crore during the previous year, increased collection from iron and steel as well as the mining sector, and collection from matured GST demand made by tax officers after return scrutiny.

The growth of collection in OGST is despite the extension of return filing date by the GST council, poor filing of returns/ payment of tax by dealers having turnover of less than Rs. 5 crores."There is also a

collection of Rs. 743.16 crore in CGST, Rs 842.65 crore in IGST &Rs 555.27 crore in Cess during June 2021. The total GST collection during June this year is Rs 2999.91 crore against Rs 2693.75 crore collected during June last year," an official release read. 

Living together, separately



Indians are largely conservative when it comes to religion. But social, and political barriers aren't insurmountable but it is too late, and too difficult a task

In the year 2071, if someone reads about India and its history, he will certainly bookmark two points- 1952 and 2014. The reason being that the first committed unpardonable mistakes and the later attempts to rectify them. The first Lok sabha commences on the 13, May 1952. That was the first Loksabha of independent India withcut-injuryof the fresh partition, the burning problem of Kashmir, and a dusting of salt over it by the Western powers. There were growing animosities between South Asia's two largest religions-Hindus and Muslims. The colonial project of 'divide et imperia' (divide and rule) fomented religious antagonisms to facilitate continued imperial rule and reached its tragic culmination in 1947. The division of British India into India and Pakistan, and communal strife between Hindus and Muslims, are the result of the British

machination that was intended to last forever and seal the fate of the Sub-continent. The leaders of the first Loksabha who would blueprint the destiny of India were deeply in the hangover of the British thought. The leitmotif should have first identified the citizens of the country, but appallingly, they brought about articles 370 and 35A through the presidential proclamations in 1954 only to further the gap between the two religions, and the state of Jammu and Kashmir from the rest of India. The Citizenship act should have been the first agenda of the first Loksabha to build a resilient India to prevent infiltrators and claim to be the citizen of India. We can hardly find a country where the citizens are not registered. Another bookmark point is 2014, from where India begins to rectify and starts from the squire one. The process of the National Register of Citizens (NRC) begins. Articles 370 and 35A were revoked through the same presidential proclamation making Kashmir equal with other

states of the Union of India with the motto of all states 'living together, never separately.'

The Hindu majority-India is home to Hindus and Muslims, Christians, Sikhs, Jains, Buddhists, Zoroastrians, and other religious groups. The problems emerge only between the Hindus and Muslims. Other groups of religions contend with the systems and provisions of the constitution. Why Muslims are unhappy with the Hindutwa with the present changes? The political ideology of Hindutya is an assertion of 'Indian identity and 'Indian nationhood'. Hindutva is cultural, civilizational, and nonreligious working for the wellbeing of all Hindus, Sikhs, Buddhists, Ayyavazhis, Jains, and Lingayats, as well as those Muslims, Christians, Jews, and Zoroastrians who accept India as their 'fatherland and their 'holy land'.But. for the colonial brainchild political parties would not accept it. They have been used to the anomalies of Hindu-Muslim muddy water to fish out of it. The core problem with Muslims is; they wish to be treated separately, not as an ordinary loyal citizen of the country while living in a secular democratic country. They are yet to accept the principles of a democracy i.e. decisions taken on consensus.

Mohan Bhagwat's statement of the similar DNA of all Indians be a Muslim or a Hindu is timely and appropriate. Whether the consistency with which he makes such statements shows a radical change in his or the Sangh Parivar's thinking is still difficult to say. But if there is someone who can initiate perestroika in the RSS, it is Bhagwat. Gradually, he has been trying to change the Sangh's attitude towards Muslims. Let us try to understand this vital and now clearly a visible change.

Bhagwat is an outspoken person. He speaks his mind and that, too, without any fear of retaliation from the extreme Hindu right. Lately, he has addressed the question of minorities in general and Muslims in particular. His comments reveal an abrupt change of heart. The Rashtriya Muslim Manch (RMM) was formed in December 2002 under the patronage of the RSS chief K S Sudarshan and is currently led by Indresh Kumar, who, like Bhagwat, believes that when Hindus and Muslims share ancestors, culture. and the motherland, there is no scope for confrontation. He rightly believes that once Hindus and Muslims understand and realize the spirit and soul of India, all the artificial barriers between the two communities would vanish. 15-17 crore Muslims cannot be thrown out of India. No NRC can exclude all of them. No country can accept them. Pakistan did not even accept the Bihari Muslims who chose to migrate to East Pakistan in 1947. How then can it accept those Indian Muslims who chose to live in a liberal and secular country rather than a feudal and theocratic Pakistan?

The RMM's primary function is to have a meaningful dialogue with the Muslim community. To do so, it should engage with those Muslims who are widely respected by the country as a whole. It should try to appreciate the Muslim perspective on several contentious issues. It must gain some credibility in the eyes of liberal Hindu activists and intellectuals, who enjoy much greater respect in the eyes of ordinary Muslims than their clergy or political leaders.

Many Muslims today indeed live under fear, and "trapped in the cycle of fear" that Islam is in danger in India. Simultaneously, Hindutva's foot soldiers and BJPleaders note that Hindus, too, are not in danger at all, even if recent electoral compulsions have tried to make it a dominant political theme. After the Second World War, Germany was divided and became bitter enemies, but was reunited. Similarly, the whimsical, religious, and machinated divide could be ended soon when we all learn to live together, never separately but jointly.

The meaning of Hindu

What is the meaning of the word 'Hindu'? When did Hinduism originate and who is the founder of this religion?

There is a reference to the word 'Hindu' by the Aryans. The term 'Hindu' in Vedic records did not refer to religion but is mentioned as the nationality of the people who lived in the region. At that time, the ancient name of the Hindu religion as Sanatan Dharma, an eternal or universal tradition referring to learning the right way of living life.

It is believed that the word 'Hindu' comes from the first letter

'H' of the Himalayas and the last words 'indu' from the Sindhu According to the NadistutiSukta, a hymn in the Rig Veda, Sindhu River, also known as the Indus River, is addressed as the mightiest of rivers. The river is also one of the longest in Asia, originating from the Manasarovar Lake and running through Ladakhto immerse in the Arabian sea. There are many beliefs behind the origin of the term 'Hindu'.It is believed that in the Zoroastrian holy book, the Avesta, the word 'Hindu' was used for the first time as a geographical

term for people who lived beyond the Indus River. The Persians could not pronounce the letter 'S'correctly and mispronounced it as 'H'. Thus, for the ancient Persians, the word 'Sindhu' became Hindu. Even today, people from the Sindh province in Pakistan are called Sindhis or Sindhus.

It is also believed that when Alexander came to India, he referred to its people as Indu, instead of Bharat. Thereafter, the east of the Indus was referred to as India, but initially, the Vedic name for the area was Bharat.

The sons of the Chief Ministers of Odisha have bedizened the headlines right from the aftermath of the sardonic emergency clamped on the country in 1975. These two CRPs go to those households for follow-up and monitor at ground zero whether they follow the prescribed guidelines and medicines. They, in real sense & spirit, act as barefoot doctors and help their community in exploding the myths and taboos regarding the vaccination.

Can a state get a governor removed?

The short answer is 'no'. The Constitution makes the governor a representative of the Union. A governor is appointed by the

President. And, only the President has the power to remove a governor.

But in effect, it is a political question, not a legal one. If a political party ruling in a state is in the truck with the political party ruling at the Centre, the state party can get a governor removed in the case of a tussle similar to the one between Mamata Banerjee and Jagdeep Dhankhar.

So, Mamata Banerjee's move is political with little constitutional value. A resolution could, however, be a record of the 'will of the people' against Governor Dhankhar.

What does the Constitution say?

Articles 155 and 156 of the Constitution make the governor the Centre's representative in a state "during the pleasure of the President".

Article 74 makes the President bound to aid and advice the Council of Ministers headed by the Prime Minister. This means that the ruling party at the Centre could get the President to have a governor of its choice in any state.

How Supreme Court has interpreted the law?

The BP Singhal case of 2010 is considered a landmark

judgment by the Supreme Court in this regard.

The Supreme Court laid down some binding principles while hearing the case of removal of the governors of Uttar Pradesh, Gujarat, Haryana, and Goa in July 2004 following the defeat of the BJP-led NDA government in the Lok Sabha election.

The Supreme Court said the President's power to remove a governor could not be exercised in an arbitrary, capricious, or unreasonable manner. It was to be exercised only in rare and exceptional circumstances for valid and compelling reasons.

But back then, the key issue was of a governor perceived to be at variance with the policies and ideologies of the central government. The ideological difference with the state government was not up for discussion.

Moreover, BJP has given the first minister in union council to Mayurbhani an erstwhile stronghold of Congress and JMM, observed a senior political analyst.

"The anointment of Bhubaneswar MP and former bureaucrat Aparajita Sarangi as national spokesperson earlier this year has then signaled the things to come. By giving organizational positions to battle-ready Lok Sabha MPs from Odisha, the party seems in the serious business of trying to shore up its organizational strength in the State to take on the might of ruling BJD. It didn't wish to burden them ministerial responsibilities to weaken the focus," the analyst further commented.

Confederation of Indian huge challenges due to low production of iron ore, rampant interstate dispatches, and thus the exponential increase in prices," CII said in a letter to the principal secretary of the department of steel and mines.

The companies, which have made huge investments in the valueadded industries by the setting of plants in the hinterland areas are facing a severe raw material crunch, it said.

"There is an urgent need to reactivate preemption rights of iron ore for state-based end-use plants to ensure a sustainable supply of usable ore," the industry body said.

Citing the policy by Karnataka government, where there is a total ban on the export of ore outside the



state, the industry body stated that similar steps would enable such amid the COVID-19 pandemic.

While Prime Minister Narendra Modi's government faces growing clamor to rein in rising petrol and diesel prices by cutting taxes, the reason for it not yielding to the demand can be traced back to the early 2000s. The present and the governments have a bill worth Rs 1.3 lakh crore to pay, thanks to the then governments' largesse of keeping petrol and diesel prices in check.

Of late, retail fuel prices hit over Rs 100 per liter in many states, including the national capital Delhi. Notably, various central and state taxes make up for up to 60 per cent of fuel prices. The central government mopped up Rs 3.72 lakh crore in excise duty on crude oil and petroleum products in the last financial year 2020-21; while the

governments collected Rs 2.03 lakh crore in sales tax and VAT on petrol and diesel. On the other hand, the government has to towards redemption of outstanding oil bonds worth over a lakh crore rupees.

What are oil bonds? Why did governments issue?

Oil bonds were issued

in place of cash subsidy oil marketing companies (OMCs) in former Prime Minister Manmohan Singh's UPA era, and also Atal Bihari Vaipavee's NDA rule. These sovereign oil bonds, issued in favour of oil companies Indian Oil Corp, HPCL, and BPCL, were transferable, allowing these companies to raise immediate cash at the time. During that time, OMCs were selling fuel at lower than international market prices to keep it The affordable. government compensated those companies for it.

The government has a liability to pay Rs 20,000 crore in the current fiscal year 2021-22 in the form of bond repayment and interest

outstanding oil bonds. While for the next six years, the government has a total debt obligation worth Rs 1.30 lakh crore.
