Bolangir, Sep 22: Congress workers staged demonstrations in front of the District Collectorate office in Bolangir during Chief Minister Naveen Patnaik's visit to the district to inaugurate a series of developmental projects on Wednesday.

The protest was over the fulfilment of a 14-point charter of demands which include the inclusion of all in the Biju Swasthya Kalyan Yojana (BSKY) smart health card scheme, declaring the district a complete drought zone, setting up of an agricultural university

and a High Court bench in Bolangir apart from the immediate revival of Deogaon sugar factory.

Earlier today, the police picked up Congress leader Ramesh Purohit along with 20 of his followers. The police action was subsequent to an announcement made by Purohit to hold a sit in outside the Patnagarh Sub-Collector's office during the CM's visit to the district today.

Purohit and his supporters were whisked away in a police van in the morning when they reached the Sub-Collector's office to stage the proposed agitation and submit a memorandum.

While the protest by Congress workers and leaders were on, the family members of one Prasadi Putel of Belgaon village in Saintala block in the district staged a demonstration at the site of the water supply project in the village which was later inaugurated by the CM in virtual mode.

Putel alleged that the local authorities had forcefully occupied 38 decimal of his land for the family construction of the project. However, the police swiftly picked up the protesting family later in the day. (Page-7)



US corp pledge elusive, and Bad bank is expensive

The visit of Prime Minister Narendra Modi to the US has tried to kindle hopes in an economy that needs investment but the American companies yet have not given any firm commitments at the meetings with corporate

India has taken many steps to bring in reforms through an asset reconstruction construction company (ARC) or the bad bank, lower interest rates, networked businesses, and chain of roads.

The Prime Minister held bilateral meetings with US President Joe Biden and Vice President Kamala Harris. He also met his Australian counterpart Scott Morrison and Japanese PM Yoshihide Suga. PM Modi also participated in the first inperson Quad meeting after

COVID-19. He also held meetings with five global CEOs for potential investment in India on Thursday.

Some companies like Qualcomm has investments wireless modem, digital media networking, transportation to defence. Now PM suggests them invest in hi-tech sectors measures strengthen the innovation ecosystem. Since Qualcomm is in India since 1996, it may continue to increase its operations but that would be its business decision.

General Atomics, which opened its first office in India in 2018, is making significant contributions to deepen India-US defence and security cooperation. It is working with both

governments to provide India with the latest defence systems and technologies. It has also partnered with Indian companies to develop solutions for Indian defence as well as capacity building.

Investments in real estate too are always lucrative. Blackstone has so far invested \$15 billion in real estate, private equity, real estate, education, fashion, packaging, and housing finance. It would continue to do so as per the meeting with its CEO Stephen Schwarzman.

Blackstone Real Estate Fund is said to be the largest owner of commercial real estate in India. The company played a key role in launching India's first real estate investment trust (REIT) along with its partner Embassy Group in 2019 and has since then launched two REITs in the country.

The Quad is the symbolic multilateral body. It provides a platform to seek cooperation from likeminded countries on issues like ensuring respect for territorial integrity, sovereignty, and peaceful resolution of disputes. It is a kind of united front to check the unceremonious belligerent activities of China. As US President Joe Biden says it plans to open up to build a free Indo-Pacific. The Quad leaders agree to scale up collective strategic cooperation. It is gaining momentum but still, China could not be contained to the extent it is planning.

There may be gains in the future. As of now, it is expectations amid not-sogood situations in the domestic arena. The country's non-performing assets increased because of not only the business cycle but also many underwritings. Various steps like taming inflation, the Insolvency, and Bankruptcy Act, Real Estate Regulatory Act, and GST did not add to the desired growth. These have shaken the system and market confidence. The rules are more stringent and do not help the people. The foreign investors though may be also keen have apprehensions, which partially the scrapping of the retrospective taxation may help.

Corporate tax rates were cut but it ignored the pivot of the individual. His taxes peaked during 2019. It hit the basic capacity of the individual to ride through a crisis pandemic situation. At 42 percent plus various cesses, India has the highest tax rates. The gestures by the foreign countries would not be enough to bring that confidence back. It would be welcome even now to cut the income tax rates. It would boost the individual's capabilities and benefit the whole economy as he consumes

The lower interest rate is playing havoc along with tax deductions on

deposit hedging against inflation that interest accrual does. It affects the developmental process. To accelerate development, the interest rates must be lowered.

Economic development is a complex matter. It cannot be done merely by the government but needs the involvement of all businesses and the public in their various sphere of activity. The pattern may be the level of cooperation and social discipline seen in ASEAN - Southeast Asian nations. The country needs to ponder how the entire system is revamped.

The new ARC or the bad bank with the limited government guarantee will remove Rs 22.14 lakh crore (\$30 billion) NPAs from the system. Since now it will be now under one entity resolution would be easier, it is being said. A bad bank is not all virtue. It started in 1988 with Mellon Bank, which created a bad bank to hold \$ 1.4 billion bad loans. Others who have it are Swededm following the Swedish bank crisis in 1992, UK, Germany, France, Finland, Indonesia and Belgium, and many others. The US sub-prime mortgage crisis has been one of the worst global tragedies.

The world experience sees bad banks having excessive and hidden fees, funds or cheques bounces, most expensive debts, loyalty means virtually nothing, large errors and mistakes, and failing to honor the promises. Though it separates the good funds from the stressed, it has not been a solution to the NPA crisis. It may reduce bailouts but it is not ruled out. It can create a new kind of market in dealing with stressed loans but there are apprehensions that asset buyers may resort to harsh unethical methods.

In a difficult situation. new methods are likely but it also has to be remembered that all Euro-US models of the capital market should not be copied as the financial literacy is poor here and even in the most developed countries. Moreover, Indian society isfar more complex and heterogeneous. complicated system may not be a proper solution. Hiving off bad assets may be practical but settling those or reselling those for the realization of dues is not easy and would have many complications as each of the cases are different. True, the nation will chart out its course. Setting the new course is not easy and none as of now has a clear idea of how it would

The country has to balance critical situations with well-thought-of measures. Demonetisation had done a lot of harm and had given a jolt to the economy. These new steps may have the capacity to give further jolts. While cajoling for foreign investments is a good idea along with make in India, but a self-sufficient atmanirbhar economy would need much more.

Positive Response to RSP's 5,000 Crore Expansion Plan

ROURKELA, Sep 22:: Rourkela Steel Plant (RSP) is all set for another expansion with the addition of new production units and technological measures at a cost of around Rs 5,000 crore. Although RSP will not have to acquire any extra land for the new units as an expansion program will be carried out inside the existing RSP boundary. So there is no threat of any kind of displacement of people from their homes in adjacent areas.

But all expansion and modernization programs carry

attending the public hearing were in favor of the projects. People attending the public hearing supported the RSP's move. 34 speakers of different

34 speakers of different political parties, labor unions, social organizations, and individuals expressed their views. Most of them supported the proposal. But they warned that no new land would be allowed to be acquired. They also urged RSP to provide jobs to local youths in the proposed expansion work.

It is to be noted that RSP proposes to set up in line with



some environmental, air, and water pollution issues with them. So to allay the fear of this regard a public hearing on environmental impact and to take approval for expansion projects worth 'Rs.5,419 crore was conducted by Odisha State Pollution Control Board (OSPCB) on 13th September at the Bhanja Bhavan Exhibition ground. Presided by Sundargarh ADM Biswajit Mohapatra the public hearing evoked a positive response.

Although the OSPCB hearing was meant to focus on environmental issues, it turned out to be a platform to express resentment against RSP for not fulfilling the rehabilitation and resettlement (R&R) conditions and not ensuring basic amenities to earlier displaced people living in Resettlement colonies. Speakers said locals support the RSP's upcoming initiatives, but the company should not make further delays to redress the grievances of the displaced people and extend basic amenities to the residents of its territorial jurisdiction.

Speakers also raised the issues concerning employment for local people and ensuring minimum salary for them as per union government's norms. Despite some strong resentment voices against the RSP majority of those

SAIL Employees Long Wait For Wage Revision Continues

Rourkela, Sept 22: 57 months have passed since the previous wage revision agreement between SAIL Management and its employees has expired. The public sector SAIL worker's wage agreement is revised every five years.

The wage revision is made through a collective bargaining process by a joint meeting between SAIL management and NJCS (National Joint Committee for Steel comprising members of five Central trade unions i.e., INTUC, HMS, AITUC, CITU, and BMS).

The last five years wage agreement expired on 31 December/2016. The new agreement should have come into effect from 1st January 2017. Workers were supposed to get newly revised wages and other benefits like MGB, perks, etc from the above-mentioned date. But it is still pending as both sides are not arriving at a

mutual consensus even after 12 rounds of negotiation in the last two years. This has infuriated SAILemployees and trade unions are on warpath to get due to wage revision as the latest discussion of the National Joint Committee for Steel (NJCS) held in Delhi on 6 and 7th September failed to finalize wage negotiation of employees. It is frustrating to see that negotiation which began on 1st March 2019 has completed 12

rounds so far but has yet to yield results.

Trade union leaders say due to inordinate delay in wage revision, the workers were not only losing financial benefit but were living with mental agony and financial hardships. The labor leaders urged management to make a final decision at the earliest. They say SAIL has been earning huge profits since the 2018-19 financial year.

Ex MLA Umesh Swain decries prawn Gheries demolition bid in the coastline

JAGATSINGHPUR. Sep 25: The former Balikuda MLA Umesh Swain has lambasted Jagatsinghpur district administration over prawn Gheries demolition drive launching in Erasama and Balikuda coastline. He described the act as discouraging prawn and marine fish production in the district as well inviting miseries for hundreds of Cherie growers and their dependents, in this regard, the ex-legislator Swain has apprised Odisha Chief Secretary [CS] Suresh Chandra Mohapatra seeking his intervention.

In the meantime, civil administration has clarified over Swain's allegations citing the prawn Gheries demolition has been undertaken following a High Court order and different provisions enshrined under environmental laws to protect coastal environment and

forest. Marine fish production has not been affected in the district, many shrimp farmers in coastal pockets have been assisted, the administration clarification revealed.

The tog war between Swain and the administration began causing Gheries demolition drive to start in Balikuda coastline in mid-August 2021. As many as 500 acres of forest land were detected under Balikuda seaside villages in Mala and Marichapur revenue circles. Few villagers have been utilizing the forest land erecting illegal prawn Gheries violating coastal Regulation Zone [CRZ] and coastal Aquaculture Act [CAA] and the Water prevention and control of pollution Act 1974.

Tahasildar Balikuda issued notices to the alleged prawn Gheri owners to demolish the prawn ponds and appear before the revenue courts for defending the allegation. As many as 228 encroachers had attended the Tahasil court and a punitive fine of Rs 3000 per acre had been collected from the alleged encroachers. Besides, that administration launched Gheries cleaning drive on August 18. Swain's allegations against the administration that before enforcing OLR Act section 4 and 6 the prawn growers had not been heard properly, they had been forced to pay fine superfluously, moreover the said OLR act section 8[A] stipulates that those had been occupying and encroaching government land above three and four decades are merit and eligible to get recorded the land his name, but administration disobeyed the rules.

Moreover prawn cultivation in the seashore a hereditary profession of coastal residents for decades, they are getting employment and contributing revenue to the state exchequer regularly, if prawn cultivation would be a halt in coast citing reasons of environmental degradation and forest destruction thousand would be unemployed and state will lose revenue, Swain alleged.

Jagatsinghpur administration defended Swain's allegations that the prawn cherries that had been reported in Erasama and Balikuda coast violate CAA and CRZ Acts and many prawn pond growers are encroaching forest lands and destructing mangrove forest.

Earlier Odisha high court WPC 7469/2017 had ordered to clear the forest land allegedly occupying for prawn culture and farming in seaside villages, so we followed all legal provisions with letter and spirit and described Swain's complaint against administration stands false and fabricated, and administration press release revealed.

Dhinkia residents oppose land transfer to IDCO

JAGATSINGHPUR, Sep 25: The Dhinkia Panchayat under Erasama block reported to be tense as villagers stage protests opposing a revenue department notification proposing land transfer to IDCO. The notification had instructed the general public and residents to furnish their opinion through affidavit and relevant records before Tahasildar Erasama within 30days.

Interestingly, in gross carelessness of the Tahasil authority to display the notification in Dhinkia Panchayat office on September 15, 2021, just three days ahead of the last day for the public to raise their objection and opinion.

In the meanwhile, due to incessant rains that occurred past three days, many low-lying areas of Dhinkia and Nuagaon Panchayat have been submerged, paddy fields have witnessed knee-deep waters, people are staying indoor, for now,

Villagers of low lying areas in Bishnupur **GP** of Balasore district evacuated



Baripada, Sept 19: With water in major river systems Subarnarekha and Budhabalanga in Balasore district are started receding from danger level on Saturday but the situation of the residents in low lying areas are very grimed as hectares of vegetable, paddy and jute along with house belongings and stocked rice and paddy in huge amount were damaged while the water in major rivers Subarnarekha and Budhabalanga entered to these areas. Particularly Bhograi, Baliapal, Bast, Jaleswar, Remuna, Nilagiri and Balasore Sadar block's 220103 people over 331 villages under 70 Gram Panchayats along with 11 wards in Balasore and Jaleswar Municipalities were affected due to heavy rainfall and

flood, said District emergency department official to TNIE on Saturday.

Though the water in major river systems have started receding, the water does not recede from 109 villages in low lying areas and have remained marooned for a couple of days, said district emergency officer Rizwana Kawkab. The district administration had evacuated at least 80 persons from low lying villages and taken them to flood shelter houses and nearest safer places like schools and three times dry ration, cooked food were provided to them after setting up of 3 kitchen centres in different locations. Fortunately no human and domestic animal casualty was vet to be reported in the tragedy.

the emergency officer said, adding that approximately crops in 27, 726 hectares submerged and 272 houses were partly damaged across the district. A medical team and a veterinary team were deployed besides distributing 30 quintal Chuda and 3 quintal Gud to people of affected areas.



Small Farm Mechanisation for Kharif Rice in Mayurbhanj district

Baripada, 18 Sep. 21:-In collaboration with Krishi Vigyan Kendra Shyamakhunta Mayurbhanj demonstration of Odisha University of Agriculture and Technology (OAUT) introduced bullock drawn puddler which as many as eight rows pre-germinated seeder conducted in farmers' field. Experimentally it was introduced in Rangamatia village under Shyamakhunta recently.

Prof Sangram Keshari Swain, the research engineer of the project, said about the benefits of the project that implements to the satisfaction of the huge gathering of farmers on the field. The OUAT Puddler takes only 4 hours to cover one acre with the provision of seating for the operator while conventionally for puddling, it takes around 16 to 18 hours with deshi (Country) wooden plow with lots of hard work for the operator who walks on the muddy field. The OUAT pre-germinated paddy seeder takes only 3



to 4 hours to cover one acre for line sowing of pregerminated paddy seeds on raised beds with the provision of seating for the operator. In comparison, in the conventional method for manual transplanting, around 25 man-days are required involving huge cost, labour, time, and drudgery. These Implements are available for the farmers with subsidy from the State Government as reported by Dr Swain. The small and marginal farmers of Mayurbhanj district still depend on animal energy for different field operations in

rice cultivation as the size of land holdings goes on reducing with an increase in population apart from undulated topography followed by prevailing poor socio-economic status. At the instance of the Indian Council of Agricultural Research (ICAR), Govt of India, the All India Coordinated Research Project on Utilization of Animal Energy operating in College of Agricultural Engineering Technology(OUAT) has been engaged since last decade to develop and popularize improved bullock

drawn implements suitable for smallholdings with higher output, lesser cost of operation, labour requirement, time and drudgery involvement. With the increasing shortage of agricultural labourers during peak hours of need, these implements are found just handy for the majority of rice-growing small farmers of the district. With a good number of programs in the district by the project, already scheduled it is expected that the farming community immensely benefited.



Chemical Discharge From Paradip Refinery Damaging Crops

Paradip, Sep 27: Farmers from Trilochanpur village and the adjoining areas under Dhinkia Panchayat in Jagatsinghpur district have alleged that their standing crop has suffered damages due to the discharge of chemical wastes from the nearby Indian Corporation Limited (IOCL) refinery at Paradip. The farmers claimed that water mixed with toxic oil, discharged from the refinery, flowing into their farmland has destroyed crops in an area of over 300 acres in the

village and surrounding

The residents of the Panchayat alleged that though they took up the matter with the local administration on several occasions, their grievances were not heard. The villagers of Trilochanpur also organised a Gram Sabha to discuss matter.Meanwhile, when informed about the farmer's plight, the Tehsildar at Ersama said that officials from the local administration would soon visit the village

for ground inspection. "A white layer has formed on the water due to which the paddy plants are gradually getting rotten. The water has even turned black due to the chemical discharge from the IOCL refinery," alleged Dhananjay Behera, a villager of Trilochanpur.

"A thick layer of oil has formed over the water due to which fish and other aquatic animals have been dying. The water has damaged the crops and causing skin problems in the villagers," alleged another resident o Trilochanpur village.

The villagers have also threatened to launch an agitation if the problem is not resolved at the earliest and compensation is not paid to them for the losses they have incurred. Refuting the allegation, IOCL authorities claimed that no such wastewater was released farmlands. "Following allegation of the villagers, officials from the Health Safety and Environment department of the IOCL visited the refinery and conducted investigation. No water is being discharged from the plant to the farmland. Wastewater discharge is stored in an oxidation pond which is then purified. 75 to 80 per cent of the treated water is reused by the refinery, while the rest 20 to 25 per cent is released into the deep sea. No wastewater is mixing with farmlands," said the Public Relations Office of IOCL, Sudhansu Sekhar Patra. 👳

JSPL to start mining at Kasia mine within a month: MD V R Sharma

Jindal Steel and Power Limited (JSPL) aims to start mining at Kasia iron ore block within a month, its Managing Director V R Sharma said.

The integrated steelmaker on Thursday announced bagging of the block, which has total reserves of 278 million tonnes (MT).

Speaking with PTI, Sharma elaborated on the company's plans with respect to starting operations at the Kasia iron ore mine, located about 17 km from JSPL's pellet plant in Barbil."It is already an operational mine, we can start mining within a month once all statuary approvals are there," the MD said.

He said JSPL will also put up a slurry pipeline from the pithead to its steel plant in Angul. This will help the company with 5-6 million tonnes of iron ore per year.

The e-auction for the Kasia iron and dolomite mineral block was held on September 18, 2021. It was earlier owned and operated by Essel Mining and Industries.


JSPL has been declared as the preferred bidder for the mine at a premium of 118.10 per cent. The mine has a huge resource of 278 MT of iron ore with an average



iron grade of about 62.5 per cent.

Odisha Poorest In Country, 46% Farmers Debt-Ridden



The NSSO Report All India Debt and Investment Survey 2019 has disproved the rosy picture of Odisha's growing per capita income. The condition of farmer households seems very wretched in the State.

Odisha's economy is agrobased. Over 80 percent of the population depends agriculture. Over the period governments have tried to shift the thrust of the economy to industries and mining but couldn't achieve any tangible results. The legendary leader Biju Patnaik tried many times to industrialise the state but failed. Finally, in the last year of his tenure, he realised the truth and shifted his attention to the rural economy and agriculture. But he couldn't return to power in the 1995 elections. Congress during its tenure from 1995 to 2000 committed the same mistake of shifting the thrust to industrialisation. BJD led by Naveen Patnaik came in 2000 but didn't carry forward the half-left job of his father. Agriculture and farmers continued to be neglected. The government did

not appropriately focus on irrigation. Cooperative societies created to assist the farmers were gradually defuncted without the patronage of the government. Farmers to meet their crop finance turned to money lenders at an exorbitant rate of interest that varies from 30 to 50 percent. Finally, on crop failure or any other eventualities; takes the extreme step of suicide. The state government tries to cover up, but the truth will always prevail.

In the Gini's Coefficient of State-level asset distribution and rank of State by average asset value, Odisha has been ranked at the bottom - both rural and urban. The state ranked 36. The debt to asset ratio (DAR) of farmer households in Odisha is at a highrisk level. The DAR in Odisha is estimated at 5.5. The DAR value of farmer suicide-prone states is also high.

Even as the Odisha Government has been claiming of bringing in rapid economic growth and a consequent rise in per capita income of the people in the State, the All India Debt and Investment Survey by National Sample Survey Organisation seems to have pricked the muchtouted rapid growth bubble.

The big bombshell dropped is, Odisha finished as the poorest state in the country. In the indicator of the average value of assets (AVA) per household, both the urban and rural, Odisha holds the lowest asset value at hand in the country.

As per the NSSO report, the average asset value (AVA) at hand per household in rural Odisha has been mere Rs 5.32 lakh. The figure in urban Odisha has been estimated at 13.41 lakh. The rural household in Odisha is the poorest in the country. Rural Assam has an AVA of nearly 7 lakh.

In the neighbourhood, Odisha ranked the poorest. Jharkhand rural household's AVA is Rs 8.6 lakh, whereas rural Chhattisgarh has an AVA of Rs 8.9 lakh. In West Bengal, the rural AVA is Rs 7.89 lakh.

Seems interesting here is when Odisha and Andhra Pradesh have a continuous face-off over Kotia and similar such villages, and reports say rural dweller in the villages has developed a fascination for the neighbouring state. The rural household in Andhra Pradesh emerges as the 11th richest among the major 18 states.

The NSS report reveals that rural Odisha AVA per household is less than half of the national average. The AVA per household in urban Odisha is also over 40 percent less than the national average, and Odisha finishes at the bottom. In the Gini's Coefficient of State-level asset distribution and rank of State by average asset value, Odisha has been ranked at the bottom - both rural and urban.

Notwithstanding the muchtouted KALIA Yojana, Odisha has been ranked among the 10 states, where maximum farmer households have a high incidence of debt (IOD). Hence the KALIA plan appears to have in no way helpful to make the farmer free of debts or can make the farmers selfsufficient. Except luring beneficiaries to be attached with, the scheme doesn't play any role in the upliftment of farmers of the state. Moreover, the State Government's claim that farmer's per capita income in Odisha high seems to have fallen flat, as the NSSO report ranked Odisha farmer households AVA as the poorest in the country.

As per the report, the average value of asset per cultivator household in Odisha has been

estimated at only Rs 6.21 lakh. And a massive 46.4 percent of households live with debt over their heads. In the ranking of Incidence of Debt among cultivator households, Odisha has been ranked 9th in the country. Only 24 per farmer households have taken debt from institutional sources like banks and other financial institutions.

For over the years, the Naveen Patnaik-led BJD government has debunked the reports of farmer suicides in the State. Even the 2019 NCRB report had manufactured nil suicides by farmers in the State.

The NSS report recently released puts the debt to asset ratio (DAR) of farmer households in Odisha at a high-risk level. The DAR in Odisha is estimated at 5.5. A whopping 45 percent of farmer households have cash debt that carries an interest rate of as high as 30-50 percent.

A glance at the farmer's suicide-prone states reveals big. The DAR is high there. In Andhra Pradesh, the DAR is 8.7. It is 5.7 in Telangana and 7.4 in Kerala.

High DAR shows that the asset is mostly funded by debt. Since the DAR is such high, it hints that the household will default on the loans taken at times with high-interest rates. In case, they meet some eventualities like crop loss due to floods, drought, pest attack, and high-interest burden. It is this fear of default that forces the farmers to take the extreme step of suicide.

Joda Tribals eat Iron dust while miners cheer profit

There is no emergency need for iron ore in the state as the existing industries already have captive mines to produce steel. Tata steel has also gone for the public hearing to enhance production to over 17 million tones to cater to its need of raw material for its Kalinganagar steel plant and Jamshedpur steelworks at Jamshedpur in Jharkhand. Surprisingly, there is no plan to increase employment to match the enhancement of production. So, why there is such a hurry for auctions more and enhancements of productions if these are not solving the acute unemployment problems the state faces? The only consequence will be to destroy the valuable forests of the state which will take at least 500 years to replenish if destroyed now? Shouldn't we preserve the minerals for future generations through responsible mining?

Odisha is among the

The Odisha government on September 9, announced, after a meeting with the union minister of mines, that it is preparing to auction five more mines in the next two months.

In July 2021, the Odisha government issued a notice inviting tenders for the auction of 11 mines (seven fresh blocks and four lease renewals) in the state. The activists claim that the seven new mines are expected to result in the loss of 4,000 acres of forest land.

The move for opening untouched forest areas for mining by the state government has, however, led to environmental activists expressing fear about an impending 'ecological disaster' in the state. They claim that even as a proper impact assessment of the mining projects is yet to be carried out, preliminary analysis suggests that the mining activity will severely impact the flora and fauna of these areas. The activists claim that close to 4,000 acres of forest land in the state, mostly in the Keonjhar and Sundargarh districts, will be destroyed due to the auction of these seven fresh mines. However, there is no official estimate as vet.

In Keonjhar's Gandhalpada



The people of the Joda mining area suffer because of the air pollution primarily generated by the reckless mineral transport on a socalled road forenamed as Bijupatanik highway. There is a CHC at Kamarjoda in Joda built 30 years back, but it is yet to be fully functional and remains inaccessible because the road connecting to it is not usable either by walking, by two-wheelers, or four-wheelers. The hospital runs on the funds of the DMF. Are the people of Joda not entitled to get a CHC from the health departments as other areas of the state are entitled to? The National Mineral Policy 2019 defines minerals as shared inheritance by citizens of a state and mentions that the among others.

A recreational facility that would cost Rs 30.42 crore (funded from the DMF) and would have a musical fountain, amphitheater, jogging track, children's play area, gazebo, cluster sitting, etc, is being built in Sundergarh as well.

Odisha's Rural Debt Burden Up 127%, Urban Down By 54% In 6-Yrs

As per SBI report, in the pandemic backdrop, the rural debt is projected to more than double nationally. Coincidentally, debt-enriched rural Odisha had been third in country where rural caseload was around 80 percent

Even as the Naveen Patnaik led BJD government's pet slogan has been 'Ama Gaon, Ama Bikash', and moreover when Rs 1200 - 1500 cr annual allocation were being made for rural development, the shocker is the average debt burden per household in rural Odisha had grown by a whopping 127 per cent.

The heights of rural distress in Odisha is evidenced by the fact that 43 per cent share of cash debt has been from the 'sahukars' (money lenders), not banks. What looks worrying is the share in 1981 was only 19 per cent.

The comparative numbers show rural Odisha now is borrowing more from sahukars than banks. As the interest rate quoted by sahukars were being astronomically high, the vicious cycle of debt burden may sink rural Odisha. And the outcome could be devastating, feel experts.

As per SBI research, based on NSSO's All India Survey on Debt and Investment 2019, the average amount of debt per rural household in Odisha in 2012 was Rs 14,000. However, as per the NSSO report, the amount in 2018 clocked a 127 per cent rise to touch Rs 31000.

Odisha Vs Neighbours

While the rate of growth in the average amount of debt per rural household in Andhra Pradesh was 118 per cent between 2012 and 2018, the growth in Chhattisgarh had been mere 28 percent.

Similarly, when the growth rate had been 60 per cent in rural West Bengal, the rate in Jharkhand was 56 percent.

The above comparative number-crunching shows the extent of rural distress is higher in Odisha vis-a-vis the neighbouring states.

Rural Penury Vs Urban



Rural poverty In Odisha

As per the SBI analysis. the urban households in Odisha have grown richer, whereas rural counterparts had turned debtors.

"In urban Odisha, the average amount of debt per household had nosedived by 54 percent to touch Rs 53000 from Rs 1.16 lakh in 2012. Odisha is the only state to record such a steep drop in average debt amount per household," the data reveals.

But the same story of affluence is not registered in rural Odisha. The debt amount here has more than doubled.

Similarly, as per the SBI analysis, when the DAR (Debt to Assets Ratio) per household in Odisha was up by 95 per cent between 2012 and 2018, in urban Odisha the ratio had tumbled by 1070 percent.

Odisha is the only State to record this north-south pole divide between the rural and urban households in the indices of financial conditions.

The above comparison clearly outlines the lack of equitable growth in Odisha. While urban Odisha has been recording a decline in debt burden, deterioration has been observed in the rural regions.

The point to note here is 83.3 percent population in the State dwells in rural regions, only 17 percent inhabit urban areas.

SBI On Debt 2021 Amid **Pandemic**

"As per the AIDIS report 2018, the average amount of debt among rural households is at Rs 59,748 and in urban households is Rs 1.20 lakh. We estimated the 2021 rural & urban HH debt to track the impact of COVID-19 on the households. In 2021 the rural HH debt is expected to increase to Rs 1.16 lakh and urban to Rs 2.33 lakh, indicating that COVID impacted the households significantly,"

observed SBI chief economic adviser Soumvakanti Ghosh.

Odisha Impact

When in a normal year the State had recorded a sharp rise in indebtedness, going by the SBI report, the distress in rural Odisha would have touched rock bottom in 2021. This is not a mere surmise.

A detailed glance at an earlier SBI report shows that the rural districts in Odisha took a pie of 79.6 per cent of the State's daily caseload to occupy the 3rd spot in the country, after Chhattisgarh and Andhra Pradesh.

Moreover, the report finds that among the top 3states, Odisha is the only state that showed a maximum rise in its rural districts vis-a-vis the cases in the first wave.

A look at the overall scenarioof debt and pandemic clearly hints that rural distress in Odisha has become more acute in the pandemic times.

Pradipta Mohapatra Proceeds On Leave; R K Sharma To Officiate



Bhubaneswar, September 16: Additional Chief Secretary (Health and Family Welfare) Pradipta Mohapatra Kumar proceeding on leave amid the ongoing fight against COVID resurgence in Odisha has triggered discussions in different circles, with speculation rife that he was asked to do the same by the

powers that be.

Agriculture Production Commissioner Raj Kumar Sharma has been made Secretary (in-charge) of the Health and Family Welfare department, official sources said.

While some believe Mohapatra's has taken leave due to the pressure following Orissa High Court expressing dissatisfaction over the affidavit filed by the health department on COVID deaths in the state, some others think he took leave due to personal reasons.

There speculation administrative circles that those calling the shots in the government asked Mohapatra to proceed on 28 days leave, following certain 'differences'. Mohapatra could not be contacted for comments.

The General Administration & Public Grievance Department, however, said that he was granted EL September 14 to October 11 on personal grounds.

On September 8, the High Court termed the department's affidavit filed as 'inadequate'. "The manner in which the death statistic was arrived at and the period covered is not clear," the division bench of Chief Justice S Muralidhar and Justice BP Routray observed.

The Health Secretary was asked to clarify as to whether the death position submitted relates to the entire period of the pandemic and file a detailed supplementary affidavit by October 4.

The government had stated that the reporting of COVID deaths slowed down during May, June and July when the cases were soaring, and doctors in the hospitals were busy saving the lives of patients. The 4,925 deaths as of July 15 is the number of updated scrutinised data pending the final decision. After the severity of the pandemic declined significantly during the second half of July and August, the scrutiny of all the backlog records of the patients who died was expedited to find the primary cause of death. The COVID-19 deaths were ascertained to be 8,022 in the state till August 30, the affidavit added.

The next hearing is on October 7.

The future of global tech

Following their first inperson summit in Washington, Quad countries - Australia, India, Japan and the United States (US) announced a set of principles that will guide how they design, develop, govern and use technology. These

broadly rest on three pillars technologies should support democratic values; build trust, integrity and resilience; and foster competition and collaboration that drive advances in science and technology. The direction that Quad countries take will have a significant bearing on the future of technology. A key driver of Quad is balancing China's influence on global security and economy, and the future of technology sits at the heart of both.

In this context, the principles outlined reflect a significant commitment to a counter-China approach. Take, for example, the stress on values: Technology should be designed, governed and used to promote "shared values of autonomy, agency and dignity of individuals". This contradicts some of the principles China has embraced. It has a sprawling

deployment of digital tools that help keep a strong check on the activities of its people. In 2019, the US blacklisted several Chinese companies for furthering China's "campaign of repression, mass arbitrary detention, and hightechnology surveillance" in the Xinjiang region. In fact, the principles explicitly condemn the misuse of technology for "malicious activities such as authoritarian surveillance and oppression, for terrorist purposes or to disseminate disinformation". This is a message to autocracies, but it is also a message to democracies to live by their own ideals.

A second core area of focus relates to how the Quad countries envision the future of their tech industries. Technology ecosystems must be built with "trust, integrity and resilience". Again, the China backdrop is

conspicuous. In recent years, all Quad partners have blacklisted Chinese hardware giants such as Huawei over concerns that they could open security backdoors for China. Quad also aims to reorient the semiconductor supply-chain dominated by Beijing. All four Quad partners are well positioned to make a meaningful pivot if they address this overreliance. Crucially, India will stand to gain as it attempts to become an alternative to the powerhouse of the tech industry that China has become. But for that to happen, India's commitment to the principles will be under close scrutiny. In the shortterm, this could have a bearing on how India approaches regulation of big tech which, for a while now, appears to be on a collision course with the Global North's light touch policies.

Auction Of Virgin Karlapat Bauxite Block In Odisha Put On Hold

Bhubaneswar, Sep 22: The auction of Karlapat iron ore and bauxite block has been put on hold. The Directorate of Mines on Tuesday said that this has been done in compliance with the September 9 interim order of the Orissa High court.

A source had earlier told that the auction of the first bauxite mineral block will be held as scheduled unless a specific instruction is received from the HC, where a petition has been filed by an Odishabased mining contractor.

Karlapat was among the 11 mineral blocks, including seven virgin mines, put up for auction by the Odisha government for which the bidding process began on Saturday. Incidentally, Karlapat bauxite block lies near the Karlapat Sanctuary, a designated elephant corridor in the Kalahandi district, and is considered ecologically very sensitive.

In a letter to Chief



Minister Naveen Patnaik, environmentalist Prafulla Samantra had earlier said that mining the Karlapat bauxite block would dry up 300 large and small streams in the sanctuary. "Not just the wildlife but even tribes and indigenous people living close to the forest and dependent on the resources will be adversely affected," he said.

Mineral Blocks

Of the blocks up for grabs, seven are iron ore blocks, two composite blocks of iron ore and manganese, one composite block of iron ore and dolomite and a bauxite block. Except for Nadidih (Bico), whose lease period expired before March 31, 2020, six blocks of Purheibahal, Chandiposhi, Jumka Pathriposhi Pahar, Dholtapahar, Netrabandha Pahar (West) and Gandhalpada are greenfield mines.

The other four are Kasia, having both iron ore and dolomite, Nadidih (Feegrade) and Teherai, which are composite iron ore and manganese blocks, and Karlapat, a bauxite mineral block

THE AUCTION

On Saturday, Jindal Steel and Power Limited (JSPL) bagged the Kasia iron ore at a premium of 118.1 per cent. Seven companies were in the race for this mining block, spread over 194.19 hectare with geological resources of 278.04 million tonne of iron ore (having an average Fe grade of 63.2 pc) and 0.693 mt of dolomite ore.

The second day of the mines auction in Odisha saw ESL Steel Ltd winning Nadidih iron ore block BICO in Sundargarh district by committing to pay a premium of 95.6 per cent. The mineral block, spread over 73.85 hectares, is one of the oldest in Koira mining sector.

Odisha has received 123 bids for the 11 mineral deposits. Jindal Steel and Power Limited, Adani, JSW, Tata Steel, ArcelorMittal, Essel Mining and Industries Limited, Rungta Mines Ltd, MSPL, Vedanta and NMDC are in the race, sources said.

On Wednesday, he was also scheduled to attend a meeting of the G-20 foreign ministers on Afghanistan and of the Gwhich is seeking permanent seats for India, Brazil, Japan and Germany on the UNSC.

Jaishankar met his South Korean counterpart Chung Eui-Yong and had wideranging conversations on different aspects of the bilateral relationships, including Southern Policy and India's Act East Policy. "Pleased to meet FM Chung Eui-Yong of the Republic of Korea. A wide-ranging conversation on different aspects of our relationship. RoK's New Southern Policy and India's Act East Policy have strengthened our

convergence in the Indo-Pacific," tweeted Jaishankar.

While interacting with his Italian counterpart Luigi Di Maio, who is the current G20 chair, Jaishankar discussed challenges related to vaccine accessibility and smooth travel. The Union minister also met with his Finnish counterpart Pekka Haavisto discussed humanitarian situation in Afghanistan. Earlier, in his address to

Erdogan had raised Kashmir in his address also in 2019, which was the last in-person meeting of the UN general assembly. At that time, Prime Minister Narendra Modi had reiterated India's support "independence, sovereignty, territorial integrity and unity" of island nation after a meeting with Cyprus President Nicos Anastasiades. Cyprus backs India's claims to a permanent seat in the UN Security Council.

The long ongoing conflict in Cyprus began in 1974 when Turkey invaded the northern part of the country in response to a military coup on the island which was backed by the Greek government. India has been advocating a peaceful resolution of the issue in accordance with the UN resolutions.

In a 1998 resolution, the UN Security Council called upon "all States to respect the sovereignty, independence and territorial integrity of the Republic of Cyprus and request(ed) them, along with the parties concerned, to refrain from any action which might prejudice that sovereignty, independence and territorial integrity, as well as from any attempt of partition of the island or its unification with any other country".

The UNSC resolution also called for the "all concerned to commit themselves to a reduction in defence spending and a reduction in the number of foreign troops in the Republic of Cyprus to help restore confidence between the parties and as a first step towards the withdrawal of non-Cypriot forces".

Punjab Fire Spreads to Rajasthan, Some Push for Sachin Pilot's Take off

Jaipur, Sept 20: Speaking to media on the demand of change of guards in Rajasthan, Sharma, who is believed to be in Pilot's faction, said, "There should be a leadership change in Rajasthan too. The Congress government was formed in Rajasthan on the basis of Pilot's hard work, in such a situation, the high command should make Pilot the Chief Minister of Rajasthan. NCW chief demands Channi's resignation as Punjab CM

Delhi, September 20: The National Commission for Women or NCW chairperson Rekha Sharma has demanded the resignation of Charanjit Singh Channi, who on Monday took oath as the 16th chief minister of Puniab, over allegations of sexual harassment against him. Calling Channi's appointment to "shameful", Sharma said the new chief minister needs to be held "accountable and should resign from the post." "We do not want another woman to go through the same experience and endure the same harassment that the IAS officer would have faced," the NCW chief added. The

The Indian Administrative Service officer accused Channi of sending inappropriate texts to her, but no formal complaint was registered and the issue was resolved

following intervention by the former chief minister of Punjab Captain Amarinder Singh. However, the case was reopened in June this year Punjab Women Commission chairperson Manisha Gulati sought a reply from the Punjab government. This move became an issue within the state Congress circles with ministers supporting Channi calling it a 'witch hunt' by the Captain camp.

After Channi's appointment, Bharatiya Janata Party's (BJP) IT cell head mockingly said "well done, Rahul" to address Congress leader Rahul Gandhi. He referred to the #Metoo allegations against

On Monday, Sharma said that she was shocked and "utterly disappointed" to find Channi being appointed to the top post of the state.



"One can only imagine what would be the state of women's safety in [Punjab] given the one at the helm of affairs is himself accused of threatening women security," she added.

Corrupt Babus Give Two Hoots To Odisha Vigilance, Conviction Chances 50-50



Even as the Odisha Vigilance claimed of registering 93 DA (disproportion assets) cases, including the high profile Abhay Pathak - Pradeep Panigrahi case, in the Covid-19 hit year, the big fact to fore is for the first time in Odisha's anti-corruption crusade history, the lowest ever cases were registered under the prevention of corruption act (PCA) in the State.

As per the NCRB report, Odisha Vigilance had registered only 245 cases in 2020. The earlier lowest tally was 285 cases in 2004.

Fear In Crooks?

A detailed glance at the data shows, the crooked babus in Odisha have only become a little alert. The data shows trap cases by Odisha Vigilance had posted a sharp slide in recent years. The total trap cases in 2018 were 182. The tally in 2020 stood at 103.

But a rise in registration of DA cases tells the real story. After all why a Sarkari babu would fear the law, when data with the Vigilance for the period 2001-2020 shows that there is only a fifty per cent chance of getting convicted for looting public money.

In 2017, the conviction rate was 47 per cent. The rate in 2018 was 51 per cent. In 2019, the rate dropped again to 48.6 per cent. The rate limped back to 50 per cent in 2020

The above data shows that for nearly half of the accused, there is a fair chance to achieve an acquittal in the court of law

Why Jail Or Acquittal 50-50?

As per NCRB data, of every 100 corruption cases registered, only 2 reach the trial stage. And in any crime delay in a trial means a gateway to escape the noose.

Consider the data. Including pending cases from previous years, the total cases under investigation under PCA stood at 1738. The State Vigilance could file charge sheets in only 153 cases. The charge sheeting rate is just around 9 per cent (8.8%).

"Poor charge-sheeting rate indicates the vulnerability of prolonged or say delayed investigation, which in a way lends a long rope to the accused (who are generally influential in power corridors) to tamper with and manage themselves wriggle out of the PCA mess with a clean slate. This is the reason behind a 50-50 chance of jail or acquittal," rued a former Vigilance DG.

Is Fight Against Corruption Serious?

"Real-time trials require vigilance courts in proportion to the cases filed, remarked a senior IPS officer. Moreover, for speedy investigation, the anti-graft body needs adequate manpower, which is grossly lacking in the State. And the decline in the number of PCA cases in the State for two consecutive years hints very big," quipped the senior officer.

Vigilance Arrests Electrical SDO in DA Case in Keonjhar

Keonjhar, Sep 22: Vigilance on Wednesday arrested Maheshwara Sethi, SDO (Electrical) of TPNODL in the district in a disproportionate assets case.

Vigilance officials conducted simultaneous raids on the properties of Sethi, SDO (Electrical), Meter Relay Testing of TP North Odisha Distribution Ltd (TPNODL) at five places in the district on Tuesday.

During the raids, Sethi was found in possession of two double-storey buildings in Keonjhar district, 4 plots including 3 in Keonjhar town and one plot at Ghatagaon, Keonjhar, 3 two-wheelers, bank deposits over Rs 24.63 Lakh, insurance deposits over Rs 24 lakh and other movable and immovable properties, totalling over Rs 2.57 crore.

After search, inventory and further enquiry, the assets of Sethy was found in possession of assets disproportionate to the known sources of income to the tune of Rs 2,13,22,084.

As Sethy could not account for the properties satisfactorily, Vigilance registered a case and arrested him. Later, he was forwarded to the Court of Special Judge, Vigilance, Keonjhar which remanded him to judicial custody till October 5.

Woman Cop Sentenced To 2 Years For Graft

Convict Budhuni Minz, a former sub-inspector of Mahila police station in Rourkela, is presently posted at the office of Superintendent of Police, Keonjhar.

Aspecial Vigilance court in Sundargarh on Saturday convicted a woman police officer in a 14-year-old bribery case and sentenced her to rigorous imprisonment for two years.

The court also imposed a fine of Rs 5,000 on the convict, Budhuni Minz, a former sub-inspector of Mahila police station in Rourkela, who is presently posted at the office of Superintendent of Police, Keonjhar.

Failure to pay the fine will invite additional rigorous imprisonment for three months, the court said.

According to sources, Minz had been facing trial in the court of Sundargarh Special Judge in connection with a case filed against her at Sambalpur Vigilance police station in January, 2007.

She had allegedly received illegal gratification of Rs 5,000 from a person to facilitate the release of the latter's parents on bail.

The court of the special vigilance judge, Sundargarh pronounced the verdict today and sentenced her to undergo rigorous imprisonment for a period of one year and pay a fine of Rs 5,000 for the offence under Section 7 of the Prevention of Corruption Act, 1988.

She was also convicted under Sections 13(1)(d) punishable U/s 13(2) of the Prevention of Corruption Act, 1988 and sentenced to undergo rigorous imprisonment for a period of two years and to pay a fine of Rs 5,000.

In case of default, she will have to undergo further rigorous imprisonment for a period of three months. Both the sentences will run concurrently, the court ruled.

Saudi daily lauds India's industrial sector, 'Make in India' initiative

Riyadh [Saudi Arabia], September 20: Saudi Gazette, an English-language daily, has lauded India's industrial sector, especially the 'Make in India' initiative which promotes manufacturing in India and has been a pushing factor for the country's economic growth.

The manufacturing sector continued to contribute to India's GDP growth and helped the country achieve its aim of becoming an 'Atmanirbhar' economy or self-reliant economy. Though India's industrial growth was hit by COVID-19 and resulted in negative growth, still the industrial sector contributed to the country's growth, reports Saudi Gazette.

According to the National Statistical Office (NSO) data,

the Index of Industrial Production (IIP) in India got increased to 131.4 points in July 2021 as compared to 117.9 points last year.

In the annual meeting of the Confederation of Indian Industry (CII) which happened last month, the scope of the industry and manufacturing was highlighted in the meeting and efforts of the central government in promoting industries through reforms were discussed.

India's defence exports have jumped more than four times in the last seven years. In the last 7 years, the Country's defence exports have crossed INR 38,500 Crore. According to data provided during the monsoon session in Lok Sabha, India's



defence export stood at 1,940 crore rupees in 2014-15, which has increased to more than 8,434 crore rupees in 2020-21.

Along with the 'Make in India' initiative, India has also started with Production-Linked Incentive schemes to boost employment and exports. Also, the government has also

removed retrospective taxation, reports Saudi Gazette. Despite the pandemic, India has pushed itself towards self-reliance and making steady growth in the industry sector. The country also handled the COVID-19 outbreak and has touched milestones in vaccination.

India needs more big banks the size of largest lender SBI: Nirmala Sitharaman

India needs at least four or five banks of a size matching its biggest lender, the State Bank of India, to meet the growing needs of its economy, Finance Minister Nirmala Sitharaman said on Sunday.



New Delhi, Sep 27: The rationale for merging banks even before the pandemic was to scale up to meet the new, changing and growing requirements of the economy, Sitharaman told an annual meeting of the Indian Banks' Association.

"The economy is shifting to a different plane altogether," Sitharaman said. "Even before the pandemic the driving force for amalgamation (of banks) was that India needs a lot more banks, but a lot more big banks."

She added, "Now all the more reason we would need four or five more SBIs in the country."

She did not give details. But the government has been consolidating state-run banks to combat the pandemic slowdown and create bigger and stronger banks while it also looks to sell its stakes in, and privatise, at least two state-run banks.

Last month, State Bank of India reported record firstquarter profit and bet on economic activity picking up to contain a spike in bad loans, sending shares of the state-run bank to an all-time high

Sitharaman commended banks that merged for having done so successfully during the pandemic without inconveniencing customers, but said banks' internal systems must be able to communicate with each other even on a regular basis.

"You cannot any more be in a digital silos," she added. "All of your systems should be speaking to one another."

Banks are less burdened today as cleaner books will

cut the government's burden in recapitalising them, she added

Domestic banks have struggled to limit bad loans, especially in their retail portfolios, as the pandemic and resultant lockdowns hit economic activity and limited borrowers' ability to repay.

The recently formed National Asset Reconstruction Co and the Debt Restructuring Co will together be able to cull non-performing assets (NPAs) from the banking system, restructuring and selling them, Sitharaman added.

"This is not a bad bank. Because it is bank-driven and because it is driven with a sense of having to clear up quickly, you have given yourself this framework which is going to help in speedily disposing of them (NPAs) with responsibility," she said.

"It is a formulation which you gave yourselves and therefore which I think will work and will work speedily."

Sidhu bulldozing Punjab cabinet, Rawat building bridges with Pakistan: Chugh

Chandigarh, Sep 23: BJP national general secretary Tarun Chugh today questioned if the new Punjab chief minister Charanjit Channi was being "bulldozed" by Punjab PCC president Navjot Sidhu.

In a statement here Chugh said the way Sidhu has been overbearingly guiding and accompanying the chief minister and the two deputy chief ministers was a clear indication of the AICC that Sidhu would be calling shots in Punjab and the rest of the cabinet would play second

president Sonia Gandhi and Rahul Gandhi if they had to make the chief minister and his deputies tools in the hands of Sidhu then why did the AICC high command not appoint Sidhu as a chief minister.

"The Congress has heaped an insult of the people of Punjab by making this kind of an arrangement for the government to run", he said.

Chugh also lambasted Harish Rawat, the Congress observer for Punjab, for saying that Pakistan Army chief Gen Bajwa was his "Punjabi Bhai".

Pakistan: Hindu Family Tortured, Held Hostage For Taking Water From Mosque Tap

Lahore, Sept 20: Farm workers from a Hindu family in Pakistan's Rahim Yar Khan, city have landed in trouble for taking water from a mosque tap, according to a media report.

Some village landlords tortured and held them hostage for "violating the sanctity" of the place, Dawn news reported.

The incident took place a few days ago in Rahim Yar Khan when Alam Ram Bheel, a resident of Basti Kahoor Khan in the city suburbs, was picking raw cotton along with his other family members, including his wife, in a field.

When the family went outside a nearby mosque to fetch drinking water from a tap, some local landlords and their men beat them.

When the family was returning home after unloading the picked cotton, the landlords held them hostage at their 'dera' (outhouse) and tortured them again, the Dawn news report said.

Later, some Muslim residents of Basti Kahoor



Khan got the Bheel family released.

Ram Bheel said the

Airport police station did not register the case as the attackers were related to a local parliamentarian of the ruling PTI. Ram said he held a sit-in outside the police station, along with another clan member Peter Jhon Bheel to protest the high-handedness, the report said.

Also a member of the district peace committee, Peter Jhon Bheel told Dawn news that they approached PTI MNA Javed Warriach who helped them lodge the FIR.

Jhon said he requested other members of the district peace committee to call an emergency meeting over the issue but they did not take him seriously.

PTI's south Punjab minority wing secretary general Yodhister Chohan told Dawn news that the incident was in his knowledge but due to the influence of a ruling party MP he preferred to stay

District Police Officer Asad Sarfraz said that he was looking into the matter.

PM Modi vs Imran Khan India and Pakistani PMs' UNGA address: A study in contrast



Since Pakistan has always used the United Nations General Assembly forum to spew vitriol against India and so no one was surprised when Pakistan Prime Minister Imran Khan named India more than a dozen times in his prerecorded speech aired at the 76th session of UNGA. Neither did the allegations levelled by Khan against India arouse much interest as it was the same old story-that the present government in New Delhi was "fascist"; it was propagating "hate-filled

Hindutva ideology [that] has unleashed a reign of fear and violence against India's 200 million-strong Muslim community" and responsible for "gross and systematic violations of human rights."

As was expected, he dwelt at length on Kashmir. He brought up the issue of Article 370 abrogation once again, calling it "illegal", but since he failed to quote any legal clauses to substantiate his allegation, his claim found no resonance within the international community and

even the media. He also spoke about what he referred to as "gross and systematic violations of human rights" by Indian security forces in Kashmir and cited the dossier containing details of such incidents that Pakistan had circulated. However, since Khan did not substantiate his litany of allegations with any credible evidence, neither the international community nor the media took serious note of the same

In sharp contrast to Khan's tirade, his Indian

counterpart Narendra Modi didn't even mention Pakistan once during his UNGA address. Instead by saying that "When India grows, the world grows. When India reforms, the world transforms," he made Indians proud by making it clear to the international community that the world's largest democracy was flourishing and had made its mark in global affairs. Unlike Khan. Modi substantiated his assertion that "India is a great example of a vibrant democracy," by adding that "The strength of our democracy is demonstrated by the fact that a little boy, who once helped his father at a tea stall in India, is today addressing the UNGA for the fourth time as Prime Minister of India."

Modi also emphasised that "We also need to ensure that no country tries to take advantage of the delicate situation in Afghanistan and use it for its own selfish interests," and this suggestion was very well received as it's an issue that's worrying the international community. At the same time, by adding that "At this time, the people of

Afghanistan, women and children, the minorities there, need help, and we must fulfil our responsibility," he showed compassion for the hapless Afghans thus making it clear that the people of Afghanistan shouldn't be punished for the wrongdoings of the Taliban regime.

While Pakistan Foreign Minister Shah Mehmood Qureshi or his diplomatic team at UNGA couldn't refer to authoritative endorsement of its claims, the Indian side had a lot to say about how New Delhi's views were affirmed by Washington. Foreign Secretary Harsh Vardhan Shringla told the media that "In all the meetings the Prime Minister had, beginning with US leadership, there was a suo moto recognition of the concerns that Pakistan represents as a country that has in many senses both supported and nurtured cross-border militancy, including in Afghanistan and from Afghanistan."

While replying to Khan's misleading statement on Kashmir, the Indian side made it clear that the Union Territories of Jammu &

Kashmir and Ladakh, including "areas that are under illegal occupation of Pakistan were, are and will always be an integral and inalienable part of India." India went a step further by saying, "We call upon Pakistan to immediately vacate all areas under its illegal occupation."

Modi also spoke out against excessive exploitation by emphasising resources available in the oceans are meant to be used not abused. Simultaneously, he advocated free passage by saying that "Our oceans are also the lifeline of international trade. We must protect them from the race for expansion. The international community must speak in one voice to strengthen a rule-based world order."

There's much debate in the media on who won the Indo-Pak battle of words at UNGA and the scales clearly tip in favour of Modi, because while Khan's UNGA speech was more of a list of complaints against India and the US, the Indian Prime Minister addressed issues that had global implications.

He's in this just for the money and for women. Chiraunji feels their late father Ullat Baba, was a great tantrik and they should carry forward his legacy of genuinely helping people. Their father has left a book of spells with them, which is written in a dead language and Chiraunji is forever trying to decipher it. Maya (Yami Gautam) comes searching for them. She's the owner of a tea estate in Dharamshala. 27 years ago, their father had exorcised an evil spirit from the estate, which has seemingly returned. While Vibhooti looks upon this as a god-given opportunity to milk the rich heiress for money, Chiraunji feels that finally he

can put his occult knowledge to good use. They travel with Maya to her estate, where they meet her sister Kanika (Jacqueline Fernandez), who wants to sell their property and move to London. A sceptical Vibhooti knows that there is a human hand behind the ghost sightings. Chiraunji uncovers the key to the book of spells and is searching for a cure there. The truth lies somewhere between both their beliefs...

Director Pavan Kirpalani's various 'inspirations' for the film includes The Exorcist, Evil Dead, The Hound Of Baskervilles, Scooby Doo and Ghostbusters. In fact, the van where they live in and operate from is hugely reminiscent of both The Ectomobile from Ghostbusters and Mystery Machine from Scooby Doo. The film starts off as pure comedy and then segues into the horror-comedy genre, with

scenes replete with black vomit, walking on roofs and jump scares galore. A little girl mysteriously appears and disappears, roots creep in from windows and ceilings, a ritual gets interrupted... common horror tropes used liberally. Though it's not the Conjuring kind of horror and won't make you close your eyes in fear.

The horror part of the film is definitely weak. What the director and his writing team gets right is the comedy. The most hilarious scenes revolve around mock exorcisms where various devices are used to fool the gullible masses. The witty dialogue takes digs at everything from superstition to nepotism. You laugh when the masses are made to chant Go kichkandi go. or when Saif asks for the GST amount to be included in their fees. Jaaved Jaffrey's character was made to marry a goat seven times and starts bleating like one when he gets afraid. Taken out of context, it all seems extremely silly but works well within the parameters of the

What makes the film work is the camaraderie between Saif and Arjun. They come off as brothers who may not see eye to eye on everything but nevertheless love each other to the core and are willing to lay down their lives for each other. Saif is shown to be a motormouth who loves to watch Naagin and has a collection of old Playboy magazines. His constant commentary on everything, especially his younger brother's naivete is hilarious indeed. Arjun gets to play an honest kind of conman. His decency and dogooder spirit keeps his elder brother grounded. Yami Gautam plays a hardworking businesswoman who dreams of resurrecting her father's business and doesn't have any other layer to her character. It's Jacqueline who surprisingly gets the better role, that of a Instagram-cazy individual who turns out to have a shrewd brain behind the bimbo act. Thankfully, the director hasn't invested in a romantic track either between Saif and Jacqueline or

The actors have done their job for most parts. Saif Ali Khan gets the best lines and his chatterbox act leads you away from the flaws of the film. He's really enjoying himself as an actor in these off-kilter movies. His comic timing is spot on and he should continue to invest more in comedies. Arjun Kapoor too gets his share of limelight. He's not playing a brooding character for once and keeps it all light-hearted and fun. He gels well with Saif, feeding off him and providing ample laughs in the process. This is perhaps the most commercial film in Yami Gautam's career. Her character is pure vanilla at first but later shown to be spirit-possessed and she has essayed both

versions nicely. Jacqueline Fernandez is the surprise package and essays her selfishsister act with aplomb. Let's hope she gets more meaty roles in future.

All-in-all, Bhoot Police is a clean comedy devoid of potty jokes and sexual humour. It doesn't scare you much but will certainly make you laugh. It's set up for a sequel so be prepared to follow the further adventures of Vibhooti and Chiraunji.
