Govt cuts excise on fuel tweaks duty on raw materials

Sitharaman urges states to follow suit; Kerala cuts taxes; duty on iron ore exports hiked to 50%



New Delhi, May 22: With retail inflation surging to an eight-year high, the Saturday government announced a series of measures including reduction in excise duty on petrol by Rs 8 per litre and on diesel by Rs 6 per litre along with reduction in customs duty for raw materials of plastics and steel and an increase in export duty on iron ore and steel intermediates.

Union Finance Minister Nirmala Sitharaman said the cut in excise duty on fuel has



a revenue implication of Rs 1 lakh crore a year and urged state governments to follow suit. Hours later, Kerala announced a cut in tax on the prices of petrol and diesel by Rs 2.41 and Rs 1.36 per litre respectively.

A subsidy of Rs 200 per gas cylinder to the beneficiaries of Pradhan Mantri Ujjwala Yojana has

also been announced.

The duty cuts on auto fuels effective Sunday have brought Central taxes on petrol and diesel to prepandemic levels. The move, analysts said, could help reduce inflation by up to 20 basis points from June on.

Announcing the duty cuts, Sitharaman tweeted: "This will reduce the price of petrol by Rs 9.5 per litre and of diesel by Rs 7 per litre...I wish to exhort all state governments, especially the states where reduction wasn't done during the last round (November 2021), to also implement a similar cut and give relief to the common

Rolling out a slew of

Sitharaman said, "Keeping in line with @PMOIndia @ narendramodi's commitment to help the poor & common man, TODAY, we are announcing more steps to help our people," she said.

Prime Minister Narendra Modi tweeted: "It is always this will have a revenue implication of around Rs 6,100 crore a year.



Veteran communist leader Sivaji Patnaik passes away



BHUBANESWAR, 23: Veteran communist leader and former Bhubaneswar MP Sivaii Patnaik passed away here at 2.10 pm on Monday. He was 92. He was one of the main founders of the Odisha unit of the Communist Party of India (Marxist).

The Left party leader is survived by his wife, three sons and a daughter. He was admitted to a hospital on Sunday after the potassium level in his blood dropped. His body will be brought to the party's state headquarters near Jaydev Vihar here at 10am on Tuesday for the last darshan.

"Comrade Sivaji Patnaik had a wish that his body will be donated to a hospital after his death. After consulting with our leader's family members, we have decided that we will donate his body to AIIMS Bhubaneswar on Tuesday afternoon," said CPI(M) state secretary Ali Kishore Patnaik.

Odisha governor Ganeshi Lal, chief minister Naveen Patnaik, Union education minister Dharmendra Pradhan, senior congress leader Niranjan Patnaik and dignitaries condoled the death of the communist leader.

The veteran leader had won three times in CPI(M) tickets from Bhubaneswar Lok Sabha seat in 1977, 1989 and 1991 by defeating Congress candidates. He had defeated Bipin Dash of Congress in 1, 45,346 votes in 1989. Bhubaneswar was a bastion of communist party, but it lost the grip over the constituency later.

CPI(M) State secretary said Sivaji Patnaik had received his party membership in 1947 from the undivided communist party. "He was a member of the CPI(M) since beginning of the party. He has nurtured and trained many communist leaders including me. He fought several people's movements to protect the rights of common people especially marginalised sections of the society during his lifetime. His death is the end of an era," he added.

He was the second state secretary of CPI (M) Odisha unit after Banamali Das. He remained in the post starting from 1972 to 1990. He was a member of the party's Central committee from 1978 to 1989. He was the first state president of Centre of Indian Trade Unions (CITU).

Keonjhar jumbo deaths: Showcause notice issued to DRM, ranger

March to 2047 - BJP targets the poor

Rides economic feat, living ease, growth

In the 75th year of Independence, the BJP is setting the goals to work continuously till the centenary, 2047, riding on its strong eight years of reign 'ensuring ease of living for the poor and the middle class.

The goal is set by Prime Minister Narendra Modi at his address to party workers in Jaipur and the strategy was finalized for the "Sewa, Sushashan and Gareeb Kalyan" campaign. The party and the government carved out an intense blitzkrieg of publicity, one-to-one contact to capture all the states that are not in its fold. Too ambitious but with 744 central schemes sponsored 72 programs and millions of cadre across the states it finds the task tough but not difficult.

Even march to Dakshin - the South - is part of its yatra. Its senior dedicated leaders are carving out strategies in Chhattisgarh, Telangana, and Andhra. The Rs31,500 crore project stones laid by Modi in Chennai target Tamilnadu. But would TN chief minister MK Stalin let it happen! None knows politics accept strange bedfellows.

The massive campaign is to make all belief in its economic feat, improvements in living standards, digital economy inclusion of the poor, a caring government for a grand success by 2024 in Lok Sabha and at least 16 states that go to the polls in the next two years.

The thrust of the BJP in government or the party would be to focus on the wider benefits that the programs like DBT, PM Kisan and Swachha Bharat, universal vaccination, and various pension and employment including schemes. Mahatma Gandhi National Rural **Employment** Guarantee.

The core would be nine-plus programs that have touched the neoaspirant classes. They reach the households and are said to make a qualitative difference in the living conditions. It is not an aspiration but the basic needs like Har Ghar Jal (Jal Jeevan Mission), Har Ghar Shauchalay (Swach Bharat Mission), Har Ghar Bijli (Saubhagya Yojana), Har Ghar Gas Cylinder (Ujjwala Yojana), Har Ghar Ration (Gareeb Kalyan Yojana), Har Ghar Bank account (Jan Dhan Yojana), Har Ghar Swasthya (Ayushman Yojana), Har Ghar Teeka (Largest Vaccine Drive), Har Ghar Pakka Ghar (PM Aawas Yojana).

The schemes are reaching grass root levels and stated to better the lives of the poor. Even separate meets with different caste and Dalit groups are planned. The BJP claims such strategies led to the shifting of the 8 percent extreme poor minority votes in UP elections. The Rashtriya Muslim Morcha is drawing crowds, and financial

support to the madrassas, which the party hopes would help them catch young.

Is not GDP growth or inflation a problem? The party does not believe so. Growth has been around 8.2 percent, even 7.2 predicted by RBI this year is the world's highest. Apart from in real terms GDP has doubled despite the pandemic. People have accepted 7.79 percent inflation as normal. This is less than the US inflation now at an unprecedented high of 8.3 percent. Inflation during UPA was one reason for NDA coming to power. But its publicity management has blunted the criticism as also sweetened by the freed food dole.

The income of the common man has also almost doubled. It's not untrue but a recent PM's Economic Advisory Council report mentions that five to seven percent of the country's income comes from the top one percent, while 15 percent earn less than Rs 5000 a month. The top ten percent earn Rs 25000 a month, about 30 to 35 percent of the total income.

The report card says that MSP for wheat in 2014 was Rs 130 per quintal and rice Rs 1310 per quintal, in 2022 wheat is Rs 2015 and rice 1940; farmers' monthly income has risen to Rs 10428 from Rs 6426 in 2014. The employment rate was 42.8 core and now 39.98 crores; 3.4 percent were

unemployed and now it is 8.7 percent. According to Pew research, the middle class shrank by 35 million while the number of people who were pushed into poverty was 75 million because of Covid-19 pandemic-led recession.

It may be one of the longest canvassings and campaigning for a party that has to capture several states held by the opposition. Some like Telangana chief minister K Chandrashekar heading TSR has posed visibly a challenge. Parties like AAP are eyeing Himachal and Gujarat, going to hustings in December this year. Ten states will form new governments in 2023 and four states that are to have an election by June 2024 may cast vote with the Lok Sabha elections.

An election is a tough game so the party is taking its blitz to booth level, according to BJP president Nadda. India's international standing, the prime minister's charisma in foreign lands, and the success at the Quad or the Pacific meet would all be told to the people. Possibility of wheat exports managing critical power situation and creation of jobs through Mudra, Skill India, Rs 15 lakh crore Jandhan, the latest National Family Health Survey figures about the amelioration of the people's living conditions. Subtly the Hindutva icing may cap it.

The BJP stress is more on man-to-man contact by

lakhs of party workers up to remotest villages to explain to the people what the party has done for them beyond the free food dole that is sustaining 80 crore people. Thousands of groups would carry on the reeducation of the masses in all states.

How big is the splash is anybody's guess. The UPA government too had splurged Rs 2658 crore as per official statements on publicity. During the eight years, the BJP has also spent a substantial sum. To cite the extent it would suffice to say that an election to the last Delhi assembly had a splurge of Rs 170 crore by BJP and opposition together. The cost was Rs 5500 crore in the 2017 UP elections, according to the Centre for Media Studies (CMS). And this surpassed Rs 8000 crore in the 2021 UP elections, according to reports. In the West Bengal elections in 2021, the publicity expenses were estimated at around Rs 500 crore. The early start by the BJP will pressurise its opponents to match the splurge to remain relevant.

The central government spent Rs 1698 crore on publicity and advertisements between 2018 and 2021 for print and electronic media. The party has a different statewise budget.

The campaign for the next 25 years is ambitious, not easy, and aims at changing the gamut of Indian politics.



6 Tourists Killed, 40 Injured As Bus Overturns

Berhampur, May 25: At least six tourists from West Bengal, four of them women, were killed and 40 were injured late on Tuesday night when the bus they were travelling in rolled down the road at Kalinga Ghat in the borders of Kandhamal and Ganjam districts of Odisha, police said.

The incident took place midnight Durgaprasad village in Ganjam and 15 people among the injured are in serious condition, the police said on Wednesday.

The bus carrying 77 people, about 65 of them tourists from West Bengal's Howrah and Hooghly districts, was moving towards Visakhapatnam in Andhra Pradesh from Daringibandi in Kandhamal district when the mishap took place, Ganjam

superintendent of police Brijesh Rai said.

Police and firefighters from nearby Bhanjangar rushed to the spot and rescued the bus passengers, 40 of who were injured. The others received minor wounds.

Police suspect that the bus rolled down the road while negotiating a curve in the hilly terrain after the driver lost control over the vehicle.

The bodies of the six tourists who died in the mishap were retrieved after breaking the window panes of the bus, Bhanjanagar sub

Mishra said.

Sources said the tourists had reached Daringbadi on Tuesday. After spending the entire day in the hill town they left for Visakhapatnam at

Plant 50 trees for fining illiterate woman without hearing her case: Orissa HC to Tehsildar

Cuttack, May 21: Orissa High Court has directed a tehsildar to plant 50 trees as punishment for imposing a fine on an illiterate woman without hearing her case properly.

The court of Justice Biswanath Rath recently asked the tehsildar of Kakatpur in Puri district to plant the trees along involvement of the tehsildar claiming bona fide action

Tehsildar Biranchi Narayan Behera had taken suo motu action against the woman, Mita Das, for allegedly squatting on a 0.08 acre 'gochar' (grazing) land in Balana village and building a kuccha house, and issued her an eviction order on September 15 last year besides imposing a penalty of Rs 1,000.

Hearing a petition filed by the woman's lawyer, Justice Rath observed that the tehsildar had passed a "bizarre" order without giving an opportunity for a hearing. Her friends had directed the woman to the lawyer.

"For the matter is heard

involved herein to see no repetition of this nature of order by such authority in the state of Odisha, this court directs the tehsildar to plant at least 50 numbers of tree needed to be planted in roadside in any sector in the CDA area," the court order

The tehsildar had taken action against the woman under the Orissa Prevention of Land Encroachment Act. The woman's lawyer said

that the petitioner being illiterate, was not aware of the law involved, and the tehsildar should have given an opportunity to her to file show-cause.

The tehsildar's counsel said that he had held the woman as encroacher after due assessment.

"When a proceeding is initiated under a statute, it has a definite purpose for more consideration, particularly, when matter involves encroachment. The tehsildar should not have rushed to decide



the matter on that date itself.

"Looking at the nature of the case and for the involvement of eviction of a person from his residence, the tehsildar has a responsibility to find whether the encroacher is an educated and law knowing person or not. Further, the tehsildar has to see if the encroacher belongs to weaker section or is a person downtrodden in the society having not even sufficient income to take aid of counsel," Justice Rath said in the order.

The court said the tehsildar had no disclosure on particulars of land, no assigning of reason and conclusion before holding the person as an encroacher in the final order. While holding as encroacher no opportunity was provided to the person to have statutory appeal remedy.

It found that there has been mechanical disposal of the encroachment proceeding. It remitted the matter back to the tehsildar with a direction to the petitioner to appear before the tehsildar on May 27 or May 30 along with its show cause and the tehsildar to give opportunity of hearing by fixing a date for it and pass a reasoned order.

The court also ordered that a copy of the order be communicated to the principal secretary, Revenue and Disaster Management Department and principal secretary to Law Department for making an endeavour to ensure that such mistakes are not repeated by tehsildars across the state and restrict loading of such cases to the high court involving unnecessary litigation.

Mami was elected member samiti uncontested. In the block chairman election, she was pressurised BJD support a candidate. She has been ostracised for not obeying them.



Gung-ho Template Politics



Odisha is the land of gods. The tradition of Shakti Puja in Odisha is old. In the of villages Odisha, worshipping of deities has been going on since time immemorial. Better late than never; Odisha CM Naveen Patnaik appears to realize the truth, but the critics perceive that it was a political need of the hour. However, unfazed by controversies over the vicinity development of the Jagannath Temple in Puri and the Lingaraj Temple in Bhubaneswar, the Naveen Patnaik government has continued to pump in massive funds for the facelift of Hindu religious places across Odisha, a move widely perceived as beating the BJP

CM Patnaik inaugurated the newly developed Tara Tarini Temple on the bank of Rushikulya River in his home district of Ganjam on May 18, the fifth and concluding day of special pujas. On his return to the State capital, the Odisha CM did not waste time in approving the development of the Chandi Temple in Cuttack at an estimated expenditure of ?70 crores.

at its own game.

The project is part of the 'Integrated development of heritage, monuments and tourist destinations' being taken up by the 5T (Transparency, technology, teamwork, time and

transformation) Department helmed by V. K. Pandian, the CM's trusted lieutenant. On April 27, Naveen Patnaik gave the go-ahead for the Rs.100-crore development of Nilamadhav Temple, Kantilo in the Cuttack district. The Nilamadhav temple, Rahasbihari Mandap, Raghunath Mutt and Batamangala Temple will also be developed.

A day before, on April 26, Mr. Pandian visited the Sarala Temple in Jagatsinghpur district and reviewed the scope of development around the temple. In all likelihood, the government may announce a temple development project running into crores of rupees.

At present, the State government has directed the expedition of the estimated ?200-crore Samaleswari Temple development in the Sambalpur district. Simultaneous temple facelifts have been undertaken in Mayurbhani, Puri, and Khordha districts. According to a senior Biju Janata Dal (BJD) leader, at least one temple in each district would be taken up for redevelopment.

Setbacks to projects

The BJD government-led by Mr. Patnaik, however, experienced setbacks to its flagship projects - the 12thcentury Jagannath Temple, Puri, and the 11th-century Lingaraj Temple.

The Rs.800-crore Shree Mandir Parikrama Project at Puri and the ?700-crore peripheral redevelopment of Lingaraj Temple had run into controversies when the BJD government was criticized that it was trampling on archaeological treasures in its unyielding resolve to give facelifts to temples.

Workaround the Lingaraj Temple almost stopped after the Archaeological Survey of India (ASI) stumbled upon ancient temple structures below the land identified for redevelopment around the 900-year-old temple.

When massive pillars were erected barely a few feet away from Jagannath Temple, Puri, experts, and political leaders expressed fears about its possible impact on the main temple. Multiple independent bodies like the lawyers association in Puri, locals, civil societies active in the holy town, and even the BJP, have raised concerns around structural stability of the 12thcentury monument as JCB machines are being used to dig up the area within the 75meter radius of the shrine to set up public amenities. BJP MP from Bhubaneswar Aparajita Sarangi had also raised the issue Parliament. Sarangi had alleged illegality in the implementation of the project and claimed that the state government continued with its construction work in prohibited areas near Shree Jagannath Temple despite a letter to stop work issued by the Archaeological Survey of India.

After a public interest litigation plea was filed in the Orissa High Court, the ASI informed the court that the State government had not obtained the requisite permission for construction, which falls within 100 meters of the no-development zone of Puri temple.

In both cases, the ASI, the Central agency and custodian of monuments, was seen by BJD as a roadblock in the development. There was a growing suspicion within the rank and file of the regional party that the BJP was waging a shadow fight by bringing the ASI to the fore.

In the national political scenario, the BJP is perceived as the way ahead of other parties in competitive temple politics. The BJP-led NDA is now basking in glory for the ongoing construction of Ayodhya Temple and the completion of the Kashi-Viswanath Corridor project. The BJD grumbles that when such projects of massive scale did not face ASI hurdles, why the two projects in Odisha alone were entangled in restrictive monument laws.

However, the regional party is in no mood to give leverage to the saffron party. It is seen that the BJD has started hijacking the Hindutva model of the BJP. The BJP has found itself on a sticky wicket. The party doesn't want to be seen as blocking temple development projects and at the same time,

it cannot let the BJD runway with credit for temple development, which has been its forte.

While the State unit of the BJP is maintaining a studied silence over the allegation of Naveen Patnaik government steamrolling laws to redevelop temples, Bhubaneswar MP and spokesperson national Aparajita Sarangi and her colleague Sambit Patra are at the forefront of criticizing temple projects. Political observers said the BJP, through the two leaders, was testing the waters.

The Odisha BJP had only announced the 'Save Jagannath Temple' campaign on social media. Sri Mandira Surakshya Abhijan had said it would move the Supreme Court with a plea to stop construction in Puri.

Despite the Orissa High Court hearing a public interest litigation plea and the ASI submitting a damaging report, the controversial construction around Jagannath Temple is going on. The Naveen Patnaik government announced it would change its detailed project report to address ASI reservations, but it would not deviate from its redevelopment plan.

The BJD leadership has realized that its 'womb-to-tomb' welfare programs and woman empowerment drive would be difficult to be matched if the BJP could make inroads into the political space by whipping up religious issues. By undertaking massive temple development projects, the regional party has hopes to block the BJP of this possibility too.

World is a bridge, pass over it, but build no house



Before the Gyan Bapi Masjid issue in Varanasi, Indian Muslims were in a state of despair after the Ram Mandir Bhoomi puja in Ayodhya on 5 August 2020. It doesn't end here; the issue of Mathura, Tajmahal, Qutub Minar, and many more are in the line to follow soon. But this despondency is nothing new - they have been haunted by such depressive anxiety for a long time- right from the blood soaked partition of country

in a daze for many years. A secular and democratic polity did handhold them as they limped back to normality. But, in a twinkling, they relapsed into the same narrative that had earlier also brought them grief. Identity continued to be their new shibboleth.

Since Indian Muslims, as Muslims, never had much power, it would be wrong to say that they lost any. The ruling class had a preponderance foreigners. They were Turks, Persians, Afghans, and Arabs whose religion was Islam. In the transition from medieval to modern, and from feudalism to capitalism, most of them fell by the wayside. Still, in the new order, they could have had a proportionate share. But they went for the easier option of dividing the country. The remaining



independence. Soon after the independence, they are just trying to come to terms with what many in the community perceive to be their altered standing in India. They became too dependent on the politicians transformed them into their vote bank. Again and again, the constitution tinkered with, and new acts were passed to appease them. So for an Indian Muslim. morbid melancholia was stylized as a cultural trope, and victimhood became their favorite dope. Ideally, the Independence of India has stimulated them with new vigor as it did to every other Indian. But the self-inflicted injury of Partition kept them

Muslims, in the remaining part of India, sheltered by a democratic and secular Constitution, did have an opportunity to make their mark. If they haven't, some introspection is in order, they should ask themselves whether they, like their compatriots, undertook socio-religious reforms, and dotted the country with institutions of modern learning instead of the religious madrassa. If the answer is the negative, they have a lot of catching up to do.

The Indian Muslims have another perpetual problem. Not surprisingly, most of the Muslim upper castes are of foreign origin, and nearly all the Muslim lower castes are of Indian



origin. The upper caste Muslims in India claim that they are the torchbearers of Islam in India and the lower caste Muslims (converted) follow. They take the lead to play a victim card against developmental any program. They never allowed the common Muslims to join the mainstream of ordinary citizenry of India's democratic system by demonizing the majority of Hindus. Perhaps that is the reason the Muslim community in India opposes the CAA and NRC considered an essential part of a modern country. During the COVID days, the Muslims strangely went allout against the free government-sponsored vaccination program. Even after many centuries of Mogul rule, this attitude is still visible in Muslims who take pride in their foreign lineage and remain disdainful of their indigenous co-religionists.

Even though Muslims are better off than earlier, what's the reason for their frustration about not remaining as powerful as they were in the mythical past? They haven't lost anything, and neither has


Islam. However, theology of supremacies has been neutralized. Other people became equal to them, which theologians, steeped in the idea of supremacism, could not tolerate. The narrative of loss emanates from an outdated theology, which lacks the conceptual tools to make sense of a world beyond the binary of Darul Islam and Darul Harb - that is, the lands already conquered and the ones yet to be conquered have become things of the past. In this narrative, the profession of faith and observance of rituals do not suffice unless the believer has a monopoly over political power. Indeed, Islam is no longer the politically dominant religion. But neither is any other religion, including Hinduism, which, in theological terms, does not present itself as the maker and arbiter of India's politics. Hindutva is an ethnic-nationalist movement, which very avowedly anchors itself in nationalism, not in religion. Muslims, on the other hand, continue to think of politics in terms of religion because of the lack of reform. A narrative is a story one weaves to inhabit as a character. Indian Muslims wove a false narrative and immured themselves in it There could be another-India's rise. They would be indispensable to the plot if they could rewrite their story. The Indian Muslims should take a cue from their ancestor emperor Akbar who didn't hesitate to accept a Christian quotation, and probably that mindset of respecting other religions has enabled him to consolidate the Mogul dynasty in India:

Fatehpur Sikri is the ruined Mughal capital built by the emperor Akbar just outside Agra at the end of the 16th century. At its center lies the Buland Darwaza or Gate of Victory, one of the great masterpieces of Indian architecture and the most imposing monument in the city. A towering archway topped with lines of minars and chattri cupolas; it exudes the sort of refined arrogance that defines Muslim architecture at its most self-confident and imperial. It is about the last place on earth you would expect to find an overtly Christian inscription. But emblazoned around the arch

quotation itself was unfamiliar if you go down to Akbar's successors finally zeroing at Aurangzeb.

To realize the real meaning of "the world is a bridge" is easier said than done. Consequently, the successors of Akbar measurably failed because their arrogance and ego developed with the prolongation of the Mogul dynasty. The tendency to suppress or destroy other religions continued and took them miles away from Akbar's philosophy that the World is a bridge to pass it over; not to stay there for eternity which Akbar knew was an impossible proposition. During the rule of Aurangzeb, thousands of temples were destroyed or converted into Mosques. 

"The Qutub Minar is not a place of worship and since the time of its protection from the Central government, the Qutub Minar or any part of the Qutub Minar was under worship by any community," the ASI said in its affidavit.

During the course of the hearing, ASI's counsel submitted that the apprehensions the of appellant were misplaced as the agency was not contemplating any removal or shifting of the idols as of now.

Shifting of the idols would involve various permissions from different agencies, and have national implications as it would amount to a policy decision, counsel clarified.

The appellant alleged that around 27 Hindu and Jain temples were desecrated and damaged in 1198 under the rule of Slave Dynasty ruler Qutub-Din-Aibak raising the construction of the said mosque in place of those temples.

The ASI, in the submission said that there is no denial of the fact about the deity's presence. It stated that the architectural materials and images of Hindu and Jain deities were reused in the construction of the Qutub Minar Complex.

"This is very clear from the inscription in the complex which is open for public viewing," it said.



15 years on, WTC in Odisha yet to see the light of day

BHUBANESWAR, May 25: Odisha government may have claimed to be all going out industrialisation and facilitating entrepreneurs, but an International Convention Centre-cum-Trade Zone here that would have promoted global networking and brought foreign investment is yet to see the light of day even after 15 years of being proposed.

The Industrial Infrastructure Development Corporation (IDCO) has already spent Rs 14 crore towards consultancy fees and other related expenses. But the project has been inordinately delayed as a suitable site is yet to be finalised. The project was conceived in 2006 after the then vice chairman of World Trade Centre (WTC),

WTC at Bhubaneswar to give international visibility to the industrial potential of

While inaugurating the WTC's branch office in Bhubaneswar in 2014, Naveen had announced that the construction of WTC would be completed in three years to facilitate interactions among global and local traders. Already seven years have passed since then, and there has been no tangible progress in the project.

the Sources said convention centre-cum-trade zone was proposed by the government at a cost of Rs 300 crore to cater to the demand of meetings, incentives, convention and exhibitions (MICE) segment Bhubaneswar. Accordingly, IDCO had appointed the four agencies for providing different consulting services required for establishment of the convention centre-cum-trade

zone (CTZ) at Bhubaneswar.

Though IDCO has identified four locations -Janata Maidan, Info Valley, Satva Nagar and unused land of IMMT and OUAT for the proposed project, a suitable piece of land is yet to be selected. It was found that three land parcels were not centrally-located and lacked in hospitality sector, which is an essential factor for such an establishment.

Since the trade centre would house plenary hall of 2,500 capacity, meeting halls of 1,000 capacity and 500 capacity, small conference rooms/business centres, indoor exhibition hall of 40,000 square feet on the ground floor, outdoor exhibition / congregation space for 25,000 30,000 people and adequate car parking with support infrastructure of four-star

hotel facility, it needs to be centrally located.

Meanwhile, IDCO has discussed with chairman, OMC and Principal Secretary of Steel and Mines Department to obtain approval for 'Janata Maidan' land from the State government and finalise the funding pattern.

As the Janata Maidan land is with BDA, the GA department has been urged to go for a joint inspection and demarcation of the land in favour of IDCO. The government is also planning to allow OMC and IDCO to form SPV and jointly fund the project. Admitting that the project has been delayed due to land issues, IDCO Managing Director Bhupendra Singh Poonia said the discussion is on to finalise the location at the earliest.

Odisha makes high security number plate mandatory for old vehicles

Bhubaneswar, May27: The Odisha government has made affixation of high-security registration plates (HSRPs) mandatory for all classes of vehicles which were registered prior to April 1, 2019.

The HRPS has already been made mandatory for all deadlines have been set for vehicles as per their registration

As per the order, August 31, 2022 is the deadline for the vehicles carrying an Odisha registration mark and registration number ending with 1 and 2, while September 31, as soon as possible but not later than the above schedule.

If the vehicle owners fail to replace the existing number plates with HRPS before the deadlines, e-challans will be issued against the offending vehicle and it will attract a fine of Rs 5 000 or Rs 10 000 under Section 192 of the Motor Vehicles Act, 1988, the commissioner warned.

The government order said legal action will be initiated against dealers or any other person found to be selling and supplying HSRPs in the state without being authorised by vehicle manufacturers.

All regional transport officers (RTOs) have been instructed to comply with the order to ensure that HSRPs are fitted on all motor vehicles registered prior to April 1, 2019, in a seamless manner.

The commissioner has directed the RTOs to convene meetings with the dealers functioning under their iurisdiction to sensitise them about the modalities for fitment of HSRP on old vehicles within the scheduled date.

Puri: Shree Jagannath temple survey sparks BJD-BJP war



Puri, May 23: The war of words between the Biju Janata Dal (BJD) and the BJP has intensified over the ongoing work for the development and beautification of the 12th century Shree Jagannath temple under the Puri Srimandir Heritage project.

Both sides traded charges as the administration carried out the Ground Penetrating Radar (GPR) survey and impact assessment study for the project on the intervening night of Saturday-Sunday near the 12th century shrine. While BJP's national spokesperson Sambit has been exposed again on the issue of GPR. "Earlier, we had maintained that the deep excavation work was done without conducting the GPRS. But Misra tweeted stating that GPRS was duly done. Allegations about digging without doing GPR are baseless," Patra said.

Patra even maintained that the Archaeological Survey of India (ASI) in its affidavit maintained that digging was done without the GPR. "We want to know why a team was found busy in conducting the GPR survey at the project site at midnight," Patra said

Patra raked up the issue and targeted the Odisha government, Biju Janata Dal spokesperson Sulata Deo countered the charges and asked the BJP to refrain from politicising the issue.

The huge advantage of GPR is that it allows crew to pinpoint the location of underground utilities without disturbing the ground. The BJD maintained that this was done at the time of excavation near the shrine; however, the BJP said the BJD was misleading people on the issue.

Patra accused BJD's Puri MP Pinaki Misra of misleading the people on the issue. The BJD countered and asked Patra to refrain from doing politics over the issue. "Stop playing electoral politics with Srimandir project, there are many other issues to do politics on," BJD's Sulata Deo tweeted.

Earlier, targeting the state government on the issue of GPR survey, Patra said, "The area near the temple was dug up using JCB machines without conducting the GPR. Now the survey is being carried out at night."

Targeting Misra in particular, Patra said Misra's lie

Earlier, Puri MP Misra had tweeted: "Documents will show GPRS was duly done and therefore allegations about digging without doing GPRS are baseless. The High Court affidavit will clarify all these aspects. All that's needed is a little more patience and a little less

Deo on Sunday accused Patra of creating obstacles and obstructing the ongoing work by making false and misleading claims. In a series of tweets, Deo wrote: "You very well know that the GPRS study was done earlier and was submitted along with the detailed project report to the National Monument Authority (NMA). But still you are trying to mislead the people of Puri. NMA had permitted the reception centre at a lower height. It was shifted to the regulated zone since the government wanted to make it taller. Your false and misleading statements are hurting the sevayats and the Jagannath Premis (devotees of Jagannath) severely,"

She also tweeted: "The sevayats of Puri who have donated their land and the Jagannath Premis will not forgive you for obstructing Puri project and regularly making false and misleading statements on it."

Pakistani politicians fume after Yasin Malik gets life imprisonment

New Delhi, May 25: Pakistani politicians, who, over the last few days, have been expressing their solidarity with convicted Kashmiri separatist Yasin Malik, reacted with 'outrage' shortly after the Jammu & Kashmir Liberation Front (JKLF) chief was sentenced to life imprisonment by a Delhi court on Wednesday in connection with a 2017 terror funding case.

Shehbaz Sharif, who, last month, succeeded the ousted Imran Khan as the nucleararmed state's prime minister, said the day was a 'black day' for India's democracy and justice system. "India can imprison Yasin Malik physically but it can never imprison the idea of freedom symbolises. imprisonment for valiant freedom fighter will provide fresh impetus to Kashmiris' right to self-determination," the PML-N leader wrote on Twitter.

Pakistan foreign minister Bilawal Bhutto Zardari has written to UN High Commissioner for Human Rights Michelle Bachelet to urge India to acquit Kashmiri separatist leader Yasin Malik from all charges and ensure his immediate release from prison so that he can be

"The letter apprises the High Commissioner, in particular, of the Indian government's ongoing attempts to persecute and repress the Kashmiris and their leadership and to implicate them in fictitious and motivated cases," according to the FO.

The Foreign Minister urged the high commissioner and the Human Rights Council to take immediate cognisance of India's targeting of indigenous Kashmiri leadership through motivated cases, particularly the treatment meted out by Malik.

He asked the high commissioner to urge India to acquit Malik from all baseless charges and ensure his immediate release from prison so that he can be reunited with his family, recuperate his health and return to normal life.

Separately, Foreign

Minister Bilawal has written a letter to the Secretary-General of the OIC, Hissein Brahim Taha, apprising him of the dire human rights and humanitarian situation in Kashmir.

New Delhi has also told Pakistan that it desires normal neighbourly relations with Islamabad in an environment free of terror, hostility and violence.

Their reactions came even as supporters of expremier Imran clashed with the Lahore Police as the former managed to push their way into Punjab in their bid to reach the Capital, Islamabad, where the Pakistan Tehreek-i-Insaf (PTI) chairperson is scheduled to hold a massive rally against the 'imported' government of Shehbaz Sharif.

Meanwhile, clashes broke out in Jammu and Kashmir's Srinagar as well, with supporters of Yasin Malik clashing with the J&K Police. Security forces fired tear gas shells to disperse the agitators.

experience together to catalyse infrastructure delivery to the strategically vital region.

The Quad leaders committed to working closely with partners and the region to drive public and private investment to bridge gaps. To achieve this, Quad will seek to extend more than USD 50 billion of infrastructure assistance and investment in the Indo-Pacific, over the next five years, the statement said.

"We reaffirmed our shared commitment to deepen cooperation on infrastructure, which is critical to driving productivity and prosperity in the Indo-Pacific region. We also share a commitment to addressing debt issues, which have been exacerbated by the pandemic in many countries," the statement

The Quad is widely seen as a counterweight to China's growing clout in the region. But members have emphasised that it is a group promoting what it calls "practical cooperation" in areas such as coronavirus vaccines, infrastructure, climate change and critical technologies.

Pakistan on boil: Trees torched, tear gas fired during Imran Khan's march

Violence was reported in Islamabad, Lahore, Rawalpindi, Karachi and parts of Khyber Pakhtunkhwa where supporters of Imran Khan's party Pakistan Tehreek-i-Insaf clashed with cops.

Islamabad, May 26: Clashes erupted across several cities of Pakistan amid the Azadi March call by the ousted Prime Minister Imran Khan Niazi. After Rawalpindi, Karachi, Lahore and parts of Khyber Pakhunkhwa, the Pakistan Tehreek-i-Insaf supporters and workers resorted to violence in the federal capital Islamabad, where the party chief is set to hold the rally.

The Islamabad Police said the protesters during the march set fire to trees and vehicles in the Blue area of the capital, prompting the authorities to immediately call fire tenders. The security in the Red Zone has been beefed up after the protesters set trees on fire on the Express Chowk too.

"No one is allowed to enter the red zone. If anyone tries to enter the red zone, it will be dealt with severely. In other places, officers are instructed not to use force. Protesters are urged to remain calm. Do not throw stones and damage property," the Islamabad police tweeted a statement by Inspector General Akbar Nasir Khan.

During a brief stopover just 50 kilometres away from Islamabad, Imran Khan said

he and his supporters won't vacate the D-Chowk in the capital until a final election date was given by the Shehbaz Sharif government, Dawn reported.

"We have entered Punjab and insha'Allah we will move

Former Pakistan information and broadcasting

minister Chaudhary Fawad Hussain had tweeted that the PTI supporters had reached D-Chowk and Imran Khan would be anytime soon. Pakistan news website Dawn reported of intense shelling in the Blue area as television footage showed smoke rising from the ground.

Earlier in the day, clashes erupted in Punjab province after the PTI members in Lahore tried to remove the shipping containers which had blocked the routes to Islamabad. The police fired tear gas shells and arrested several protesters. The Punjab administration has

imposed Section 144 as it alleged the PTI wanted to disrupt peace.

However, the PTI in a tweet alleged that the Punjab Police in Lahore fired teargas shells on the protesters.

The situation was no less tense in Sindh's capital Karachi where the police and PTI workers clashed at the busy Numaish Chowrangi intersection, Express Tribune reported. The PTI workers even torched a police van and removed all hurdles set up by the law enforcement agencies. The cops resorted to firing in the air and teargas shells to disperse the protesters.

While Khirwar, who worked as principal secretary (revenue) with the Delhi government, was transferred to Ladakh, Dugga was sent to Arunachal Pradesh, a notification from the Union Ministry of home affairs (MHA) read. Their new

postings will come into effect immediately, and will be in force until further orders, it further stated.

Additionally, the MHA sought and received a report from chief secretary, Delhi, about the 'factual position' on the alleged misuse of facilities at Thyagraj Stadium by the couple.

Earlier today, The Indian Express reported, citing athletes who train at the Delhi government-run facility, that sportspersons who train there were being forced to finish training early so that Khirwar, who is from the city itself, could take a walk with his pet inside the ground. In a photo which went viral, the couple is

seen walking with their dog on what looks like an athletics track. Khirwar, on the other hand, told The Indian Express allegations against him were 'absolutely incorrect.'

Ramban tunnel collapse: All 10 bodies found, families informed, say officials

New Delhi, May 21: All ten bodies have been recovered from the debris of an underconstruction tunnel that collapsed in Jammu and Kashmir's Ramban on Thursday. Ten labourers were trapped after a section of a tunnel on the Jammu-Srinagar national highway caved-in, triggering large-scale rescue ops by teams of police, the Army and state and national disaster response forces.

"All 10 bodies are recovered and families have

been informed. Five of 10 bodies are from West Bengal. This operation is complete. Bodies shifted to hospital," district official Mussarat Islam was quoted by news agency ANI.

"One more body was seen... machines have been (used) to remove the boulder... we are nearing the end of this rescue op," Ramban district police superintendent Mohita Sharma said, adding that those could be rescued would be saved and all bodies would be recovered.

Ramban rescue work was suspended yesterday because of 'shooting stones - large and small rocks and debris that come hurtling down a hillside due to inclement weather conditions.

The first body - a labourer from Bengal - was found on Friday.

The audit tunnel of T3 on the highway near Khooni Nallah in Ramban district caved in at the start of work at 10.15 pm on Thursday.

Rescue work began immediately but was briefly suspended yesterday because of 'shooting stones - large and small rocks and debris that come hurtling down a hillside due to landslides or other inclement weather conditions.

The debris was the result of a nearby landslide - part of a mountain in the Makerkote area collapsed and forced a temporary break in rescue operations.

Parents resort to begging to save son suffering from kidney ailment

Nirakar's parents, residents of Pathara village under Khallikote block in Ganjam district, is getting Rs 1,500 from Biju Swastya Card for dialysis which is not enough.



Khallikote, May 27: According to sources, Nirakar had gone to a neighbouring state to eke out a living. As he frequently fell ill, he came back to Odisha. After doctor's consultation, his parents came to know that Nirakar was suffering from kidney ailment. Though Nirakar's parents took him to several government and private hospitals for his treatment, but he is yet to be cured. They have spent Rs 13 lakh for their son's treatment, but he is vet to show any sign of improvement. They have already sold all their gold and silver jewellery apart from house for the sake of their son's

Currently, Nirakar undergoes dialysis three times a week. However, they are getting Rs 1,500 for the dialysis from Biju Swastya Card Yojana which is a meager amount for the treatment. Nirakar's father is a fisherman. Now doctors who are treating Nirakar have asked his parents to arrange funds so that Nirakar undergo kidnev transplantation. As kidney transplantation requires lakhs of rupees, his parents have resorted to begging to save their son's life.

"We have also sold our house. Nothing has left with us for our son's treatment. Finding no other go, we are begging to raise funds," said his mother. "For last five months, I am not able to go to Chilika to catch fish due regular visit of hospital. We have spent Rs 13 lakh so far for Nirakar's treatment and need more funds for his kidney transplantation. I would be grateful if the state government extends a helping hand and provides required funds for Nirakar's treatment," said his father.

A helpless Niarakar has requested for a kidney donation to save his life.

"Both of my kidneys are not functioning. I request for a kidney donation from a Samaritan to save my life," he said.

The Reserve Bank of India, while reducing the repo rate by 40 bps in an out-of-turn monetary policy meet earlier this month, had flagged concerns over high food and fuel prices feeding into inflation.

The Wholesale Price Index-based inflation rate had surged to a record high of 15.1 per cent in April while Consumer Price Index-based retail inflation had also surged to an eight-year high of 7.79 per

cent in April.

In April, Prime Minister

urged "all states to work as

As fuel prices soared in November 2021, the Centre, for the first time in over three years, cut Central excise duties on petrol (by Rs 5 per litre) and diesel (by Rs 10 per litre).

Twenty-one states, including 17 ruled by the BJP, and some Union Territories then cut VAT in the range of Rs 1.80-10 per litre for petrol and Rs 2-7 per litre for diesel. The revenue loss to states due to this was estimated at 0.08% of GDP, as per the RBI's State Finances report for 2021-22.

The relief these moves had provided was outweighed by a series of 14 price hikes in 16 days, following the lifting of a 137-day freeze after state elections in March.

Experts said the excise

duty cut will help cool the inflation trajectory. "We project the May 2022 CPI inflation at between 6.5-7.0%. The fiscal cost, while material, can be absorbed by higher than budgeted revenues through other taxes," said ICRA Chief Economist Aditi Nayar.

"It will help reduce inflation by around 20 basis points - but in June. In May, its impact will be only for 10 days," said Devendra Kumar Pant, Chief Economist, and India Ratings said.

The Centre had hiked the excise duty on petrol

by Rs 13 per litre and on diesel and Rs 16 per litre through two rounds of hikes in March and May 2020 as the lockdown had severely reduced collections from other revenue sources.

It had then cut the excise duty on diesel by Rs 10 per litre and that on petrol by Rs 5 per litre in November. Rising international crude prices in the wake of the Russia-Ukraine conflict pushed the price of Brent crude by 44.7 per cent to \$112.55 per barrel from \$77.78 per barrel at the beginning of the year.

Customs duty on imported raw materials used by the steel industry including coking coal, coke, semi-coke and ferronickel has been reduced to zero in order to reduce the domestic cost of steel production. Also, to increase domestic availability, duty on exports of iron ore has been hiked to 50 per cent, for iron ore pellets to 45 per cent and for some steel intermediaries to 15 per cent. Import duty on naphtha, propylene oxide, and polymers of vinyl chloride has also been reduced.


Booker Prize To Hindi Novel For 1st Time: Geetanjali Shree's "Tomb Of Sand"

London, May 27: Author Geetanjali Shree's Hindi novel 'Tomb of Sand' has become the first book in any Indian language to win the prestigious International Booker Prize.

At a ceremony in London on Thursday, the New Delhibased writer said she was "completely overwhelmed" with the "bolt from the blue" as she accepted her prize, worth GBP 50.000 and shared with the book's English translator, Daisy Rockwell

'Tomb of Sand', originally 'Ret Samadhi', is set in northern India and follows an 80-yearold woman in a tale the Booker judges dubbed a "joyous cacophony" and an "irresistible novel".

"I never dreamt of the Booker, I never thought I could. What a huge recognition, I'm

book lies a rich and flourishing literary tradition in Hindi, and in other South Asian languages. World literature will be the richer for knowing some of the finest writers in these languages. The vocabulary of life will increase from such an interaction," she

Rockwell, a painter, writer and translator living in Vermont, US, joined her on stage to receive her award for translating the novel she described as a "love letter to the Hindi language".

"Ultimately, we were captivated by the power, the poignancy and the playfulness of 'Tomb of Sand', Geetanjali Shree's polyphonic novel of identity and belonging, in Daisy Rockwell's exuberant, coruscating translation," said Frank Wynne, chair of the judging panel.

"This is a luminous novel

of India and partition, but one whose spellbinding brio and fierce compassion weaves youth and age, male and female, family and nation into a kaleidoscopic whole," he said.

The book's 80-year-old protagonist, Ma, to her family's consternation, insists on travelling to Pakistan, simultaneously confronting the unresolved trauma of her teenage experiences of Partition, and reevaluating what it means to be a mother, a daughter, a woman, a

The Booker jury were impressed that rather than respond to tragedy with seriousness, Ms Shree's playful tone and exuberant wordplay results in a book that is "engaging, funny, and utterly original", at the same time as being an urgent and timely protest against the destructive impact of borders and boundaries, whether between religions, countries, or genders.

The author of three novels and several story collections, Mainpuri-born Ms Shree has translated her works into English, French, German, Serbian, and Korean. Originally published in Hindi in 2018,

'Tomb of Sand' is the first of her books to be published in the UK in English by Tilted Axis Press in August 2021.

Ms Shree's novel was chosen from a shortlist of six books, the others being: 'Cursed Bunny' by Bora Chung, translated by Anton Hur from Korean: 'A New Name: Septology VI-VII' by Jon Fosse, translated by Damion Searls from Norwegian; 'Heaven' by Mieko Kawakami, translated by Samuel Bett and David Boyd from Japanese; 'Elena Knows' by Claudia Piñeiro, translated by Frances Riddle from Spanish; and 'The Books of Jacob' by Olga Tokarczuk, translated by Jennifer Croft from Polish.

This year the judges considered 135 books and for the first time in 2022, all shortlisted authors and translators will each receive GBP 2,500, increased from GBP 1,000 in previous years bringing the total value of the prize to GBP 80,000.

Complementing the Booker Prize for Fiction, the international prize is awarded every year for a single book that is translated into English and published in the UK or Ireland.

Love, loss, life...




Over the Moon is directed by Glen Keane, who used to be with Disney before and has worked on such iconic films as The Little Mermaid, Aladdin and Beauty And The Beast. Hence, there's a distinct Disney influence in the film. It's reflected most in the handdrawn scenes when Fei Fei's mother acquaints her with the doomed love story of the moon Goddess. The castle in the sky, the cuddly moon residents who glow from the inside, the visual palette, all smack of Disney. The film's screenplay, which deals with the theme of loss and growth, too resembles Disney's entertainment with a moral formula. The script has been written by the late Audrey

Wells. The film is dedicated to the writer who sadly succumbed to cancer two years before its release. Given that context, the central theme of the film becomes even more poignant.

The film utilises the Chinese myth of the Moon Goddess to weave a tale about loss, grief, and the power of love. Animation has been a great tool for filmmakers to explore the theme of children coping with grief, especially when the loss of a parent is involved. Children internalise things differently and if certain wounds in their psyche aren't tended in time then they can fester for years. The Moon Goddess, despite being divine, is herself hasn't overcome her grief of losing her human lover and a chance meeting with the film's protagonist leads her towards resolution.

The film begins with Fei Fei (Cathy Ang) being told the legend of the Moon Goddess Chang'e (Phillipa Soo) by her mother (Ruthie Ann Miles). Chang'e has been exiled to the moon for allegedly stealing two immortality pills. She wanted to make her human lover Houyi immortal as well but didn't succeed. Fei Fei's father (John Cho) runs a cake shop and her mother's mooncakes are famous in their locality. During the annual Moon Festival, Fei Fei's mother falls ill of cancer and dies. Four years later, he's seen courting Mrs Zhong (Sandra Oh), a widow with a young son Chin (Robert G Chiu). While the rest of the family, who have gathered once more for the Moon Festival, have accepted

Mrs Zhong, Fei Fei has not. She's saddened by the fact that her father wants to move on. She sees it as a betrayal of her mother's love and wants to land on the moon, meet the Moon Goddess and bring proof of the 'eternal love' as told in fables. She invents her own moon rocket and with timely help from helpful lion dragons, does manage to land up on the moon. She finds that the Moon Goddess is more of a diva than a benevolent spirit, who's convinced that Fei Fei has brought her a gift which will provide her with a resurrection spell for her dead lover. She sets





off a Cannonball Run like competition, where all the cuddly denizens of the moon participate, looking for the lost gift. Chin has also towed himself along for the adventure. He always wanted a sister and thinks finding the gift would help win Fei Fei over. How Fei Fei's search leads both her and the Moon Goddess towards closure forms the crux of the story.

The film becomes a visual extravaganza once Fei Fei lands

on the lunar landscape. The world-building is truly amazing. And the Moon Goddess looks like a cross between Maleficent and Lady Gaga. Her various mood swings transform the landscape. Her tears are sentient beings and she's protected by an army of glowing mooncakes. There are biker chicks who actually are chickens riding some really awesome bikes, a jade rabbit who is a wizard and a wise creature named Gobi, who resembles an otter. One can see that again, poetic liberty has been taken and ideas from across different banners and films have been appropriated. Director Glen Keane's idea of China is that of an idyllic hamlet populated by kind souls who always help each other out. It's a place where spiritual harmony remains an ideal for everyone. Nothing wrong in imagining a utopia but we wonder whose agenda is being served by painting such a placid picture.

The film is part musical, part coming-of-age story and part pure fantasy. It falters in the execution of juggling all three parts. Disney, Pixar and Studio Ghibli have set high standards for others to follow. Over The Moon is a step in the right direction for its makers but they still have a lot of catching up to do...
